3. **Age Limit** 18 to 25 years for Gen Cat, 18 to 28 years for OBC and 18 to 30 years for SC/ST. SC/ST/OBC candidates applying against UNRESERVED posts are not entitled to any relaxation in age limit, experience etc.

4. Application in the format given below, duly completed alongwith the following should reach '**The Commandant, Pioneer Corps Training Centre, Post: Banaswadi, Bangalore-560033**' by '**ordinary post**' within **21 days from the date of publication of vacancies in Employment News.**

- (a) One self addressed registered envelope for issue of call letter.
- (b) Latest photograph pasted in the application should be self attested.
- (c) Xerox copy of education qualification, age, caste, work experience certificate etc. duly self attested.
- (d) Two copies of latest passport size photographs (one copy affixed on application form duly self attested)
- (e) Xerox copy of Aadhar Card.

5. Only one application should be submitted for the post. Candidate desirous of applying for separate posts should submit separate applications clearly indicating the post for which they have applied for.

6. Any one who has applied for these posts based on previous advertisement, if any, is ineligible and have to apply afresh on a new application form based on the present advertisement.

7. To reduce the number of candidates for the post for written examination, screening of application on the basis of 'Percentage of Marks' obtained in the examination for essential qualification may be carried out.

8. Incomplete, unsigned applications, received after **21 days from the date of first appearance of this advertisement and application not accompanied by attested copies of certificate/testimonials will be rejected and no correspondence in this regard will be entertained.**

9. Candidates living with more than one spouse or married to another spouse while the first spouse is alive, shall not be eligible to apply.

10. No TA/DA or travel expenses will be admissible for Written/Trade test. Applicants should attend the same at their own expenses.

11. Candidates after selection will be subject to Field Service Liability Rules.

12. The following applications will be summarily rejected :-

- (a) Application without signature of the candidate.
- (b) Application other than prescribed performa as published in advertisement.
- (c) Application received through FAX / AWAN.
- (d) Application received after due date, for any reason.
- (e) Incomplete / illegible application.
- (f) Latest photograph not pasted on application form and not attested by self and if no additional photogtaph is enclosed.
- (g) Mark sheet of essential qualifications not attested.
- (h) Only a single application will be entertained for one category / post. Candidates who forward more than one application form for the same category/post, their candidature will be rejected outright without any notice to such candidate.

13. Selection will be subject to Medical Fitness and verification of Character and Antecedents from Civil Authorities.

14. The candidates selected shall be governed by the provision of New Pension Scheme (NPS) - 2004.

15. Appointing authority has right to cancel/postpone / suspend / terminate /modify this notification of recruitment process without any prior notice/assigning any reasons at any stage and no enquiry or correspondence will be entertained for any information.

16. Appointing authority reserves the right to reject the candidature of a candidate for written / skill test. The candidates to be called for the written test and skill test shall be shortlisted by applying all or any of the slated norms.

17. Merely fulfilling the basic selection criterion does not automatically entitle a person to be called for written / trade test. The selection will be made strictly on merit basis.
