- 1. Reservations and relaxations for EWS / SC / ST / OBC (non-creamy layer) / XSM (Ex Servicemen) / PwBD (degree of disability 40% or above) candidates will be provided as per Government guidelines. Relaxation will be applicable to vacancies against posts identified SC/ST/OBC (non-creamy layer)/PwBD.
- 2. Category (EWS/SC/ST/OBC/PwBD) once filled in the online application form will not be changed and no benefit of other categories will be admissible later on.
