The Net Banking/Debit Card/Credit Card transaction charges will be extra as applicable. If the candidate applies for more than one post, he/she is required to deposit the fee separately for each post and apply separate application form.
- 2. The online application forms are available on the University website w.e.f. **19.12.2022** upto **10.01.2023**.
- 3. Last date for payment of fee through Net-Banking or Debit/Credit Card is 10.01.2023.
- 4. If the candidates claims marks for Socio-Economic criteria, self-declaration Undertaking (Annexure-I) will be uploaded along with other documents.
