The BMO shall not be eligible for any benefits as available to Part-Time Permanent/Full-Time Permanent employees of the Bank. • They will be eligible for 20 days Leave in a year. • Except the services of the compounder no other person will be allowed to be engaged by the Bank's Medical officer. • Bank's Medical Officer will have to make his/her arrangements for providing substitute during their absence, at their own cost. • The Bank reserves the right to review the rate of remuneration from time to time and alter the duty hours at its discretion in case it becomes expedient to suit administrative and operational requirements.
