

- **Mode of selection:** Through Walk-In-Interview.

- b) This is a "rolling advertisement" to fill the latest vacancy position declared above and will be opened for vacancies remaining unfilled/fresh vacancies and will be valid for a period of one (01) year or till all the vacancies are filled up, whichever is earlier.

The registration will be close at 11.00 AM. sharp and no candidates will be entertain after this time.
- e) Director (Medical Services) New Delhi Municipal Council (NDMC) reserves the right to vary these vacancies including increase or decrease or cancellation of filling up of any or all vacant posts without assigning any reasons.

**General terms and conditions:**

1. The Candidates are required to bring the duly-filled Application Form in CAPITAL LETTER provided at Annexure-A, and the original documents along with self-attested photocopies of the following documents i.e.,
  - a) Proof of date of birth : Birth certificate/Matriculation certificate
  - b) Degree of MBBS
  - c) Degree of MD/MS/DNB/DIPLOMA etc.
  - d) DMC Registration Certificate/Receipt of Application to DMC
  - e) Category certificate in respect of Claims i.e. SC/ST/OBC/PwD/EWS as per GOI rules.
2. **Eligibility for Senior Resident: -**
  - a) M.B.B.S. with Post Graduate Degree: MD/MS/DNB/Diploma in the relevant Speciality from a recognized University or equivalent Qualification recognized by Medical Council of India (MCI)/NMC. . In case such Candidates are not available,

- the Candidates with MBBS degree with 03 years' experience post MBBS in relevant field may be considered for the post.
- b) Those Candidates who have completed three (03) years Senior Residency in any Govt. Hospital/Institution inclusive Regular/Ad-hoc period need not apply.
- c) Delhi Medical Council (DMC) Registration is mandatory at the time of joining.
3. **Appointment & Tenure:** The tenure of appointment is purely temporary initially for a period of 01 year, extendable up to a maximum period of 03 years subject to the satisfactory performance as per rules and selected candidates will have no claim for regularization in NDMC whatsoever. The appointment is also subject to a Medical Certificate of Fitness to be obtained from the Medical Board at Charak Palika Hospital, Moti Bagh.
4. **Age Limit:** Not more than 45 years on date of interview
- a) The age is relaxable for SC/ST/OBC/PwD candidates as per the Govt. of India Rules and Candidates are required to produce a valid SC/ST/OBC/PwD certificate in prescribed Performa in regard to the Claim.
- b) OBC candidates are required to submit valid OBC Certificate vide. OM No.36036/2/2013-Estt. (Res.I) dated 31.02.2016 of DOPT, Ministry of Personal & Public Grievance & Pensions, New Delhi with Non Creamy Layer Certificate.
5. **Method of selection:** The selection is based purely on performance in the *Personal Interview* and the offer letters to selected Candidates will be communicated through the E-mail provided by the candidates or through mobile phone.
6. **TA/DA:** No T.A. / D.A. will be paid for appearing in the interview.
