**ANNEXURE**

**Amendment of the Rules and Regulations of the Kerala Kalamandalam**

**(Deemed to be University for Art and Culture)**

The Rules and Regulations of the Kerala Kalamandalam issued vide G.O. (MS)No.5/2022/CLAD dated 06.04.2022 is amended as follows:

(i) For clause 4.25.0 the following clause is substituted:

“Chancellor means the Chancellor appointed by the sponsoring body as per clause 29.1.0 of these Rules.”

(ii) For clause 11.1.0 and Note thereon the following clause is substituted.

“The Governance System & Management Structure of Kerala Kalamandalam (Deemed to be University for Art & Culture) shall be in accordance with the decision of the Government of Kerala. The Governance System and Management Structure of the deemed to be University are as per the provisions contained in these rules and orders issued and to be issued hereinafter by the Government of Kerala as and when occasion arises.”

(iii)(a) For clause 29.1.0 the following clause is substituted.

“The Chancellor shall be an eminent person in the field of Art and Culture appointed by the sponsoring body.”

(b) In clause 29.4.0 the 'Note' is omitted.

(c) After clause 29.4.0 the following clause is inserted.

“29.4.1. Tenure of the Chancellor.- The Chancellor shall hold office for a term of five years from the date of assuming office and shall be eligible for reappointment for one more term; provided no person shall be eligible to hold the office on attaining the age of 75 years.”

(iv) For clause 30.2.0, the following clause is substituted:

“In the absence of Chancellor or during his inability to act, the Pro-Chancellor shall exercise all the powers and perform all the functions of the Chancellor.”
