

Terms and Conditions

1. Payment Terms

1.1. **Payment Schedule:** Following is the Applicable Fee structure on the Select 200 companies:

- A non-refundable **Nomination Fee** of USD 250 (Plus applicable taxes) convertible into the local currency is payable on Nomination.
- A non-refundable **Select 200 Membership Fee (Including DGEMS & eXtrefy)** of USD 10,000 (Plus applicable taxes) convertible into the local currency is payable on Selection.

1.2. **Payment Methods:** Payments can be made via Accepted Payment Methods such as online payment, credit/debit card, bank transfer, or cheque.

The company shall bear all currency conversion charges and intermediary banking fees.

Any dispute arising out of or in connection with this Agreement shall be resolved in accordance with the provisions of the Arbitration and Conciliation Act, 1996 (as amended from time to time). The seat and venue of arbitration shall be New Delhi, India.

9.2. The arbitration proceedings may be conducted through video conferencing or any other electronic means, as may be mutually agreed by the Parties.

10. Brand Usage

The shortlisted Select 200 companies grants D Globalist a worldwide, royalty-free, irrevocable licence to use their company’s name, logo, trademarks, testimonials etc. for promotional, editorial, marketing, digital, and social media purposes. Further, the companies warrant that they own or have authority to grant such rights.
