**UPON hearing the counsel the Court made the following  
O R D E R**

**Heard learned counsel  
for the parties and perused the  
material placed on record.**

**Considering the facts  
and circumstances of the case,  
and in particular, the fact  
that the petitioner was  
granted bail earlier in the  
NDPS matter in the year 2022,  
against which the special leave**

petition filed by the State of Punjab was dismissed by this Court in 2025; further the petitioner has already remained in custody for the last seven months and the Police Report under Section 173(2) Cr.P.C. has already been filed and also taking into account that the present disproportionate assets case relates to the check period from 2007 to 2017 and the First Information Report has been lodged in the year 2025 under the Prevention of Corruption Act, 1988, we are inclined to grant bail to the petitioner.

Accordingly, we direct that the petitioner be released on bail, on such terms and conditions as may be imposed by the Trial Court, in connection with FIR No.22 of 2025 dated 25.06.2025, Police Station Vigilance Bureau, FS-1, SAS Nagar, Punjab.

However, it shall be open to the prosecution to impress upon the Trial Court to impose stringent conditions on the petitioner while releasing him on bail.

The petitioner shall continue to cooperate in the

trial, and in the event the Trial Court or the State finds that the petitioner is delaying the conclusion of trial, it shall be open for them to apprise this Court of the same for appropriate orders.

The Special Leave Petition and pending applications are disposed of accordingly.
