#### Nature of Duties

The consultant will look after the matters related to Establishment and Administration like Personnel management, welfare of the employees, promotion, pay fixation, MACP, Staff Management, RDA and Court Cases related to service matters etc

#### Terms and conditions towards engagement of retired CBI Officers as Consultants

- The said engagement as Consultant shall be for a period of 1 year from the date of joining or until further orders whichever is earlier. The person engaged shall have no right to claim regularisation/absorption in the organisation/Govt
- The engagement of Consultants shall be on full time basis and he/she will not be permitted to take any other assignment during the period of Consultancy with CBI
- The engagement of Consultants shall be of a temporary nature against the task assigned. The engagement may be terminated at any time by CBI without assigning any reason
- 4. The Consultant shall have to work as per the working hours of CBI
- He will be required to sign an agreement of confidentiality with the CBI to this effect which shall contain a clause of Ethics and Integrity
- He will be required to maintain discipline and absolute integrity in accordance with rules as contained under CCS(Conduct) Rules 1964
- He shall not take any commercial employment or assignment of work by any other name like project or such under any circumstances during the period of engagement in this Bureau.
- 8. He will be eligible @ 1.5 days leave for each completed month of service.
- He shall be required to perform duties in the Central Bureau of Investigation under the administrative control and supervision of the Joint Director, ACHQ-II Zone, CBI or any other officer authorized on his behalf.
- 10.A fixed monthly amount shall be admissible, arrived at by deducting the basic pension from the pay drawn at the time of retirement. The amount of remuneration so fixed shall remain unchanged for the term of the contract. There will be no increment/percentage increase during the contract period.
- 11. A fixed amount will be paid as Transport Allowance for the purpose of commuting between the residence and the place of work. However, he/she may be allowed TA/DA on official tour, if any as per his/her entitlement at the time of retirement.
- 12. The Income Tax or any other tax liable to be deducted, as per the prevailing rules will be deducted at source before effecting the payment for which the office will issue TDS certificate.
- 13.No increment and Dearness Allowance shall be allowed during the term of the contract.
- 14. No honorarium shall be allowed for any purpose.
- 15. No accommodation or HRA will be provided by CBI.
- 16. Other conditions of services will be governed by the relevant rules and orders in force.
