1. Minimum Essential Qualification(s) for the above posts shall be as indicated in Table-II below:

1	Full time Factory Medical Officer on temporary tenure basis	Minimum MBBS with completed internship and registration with Medical Council of India and must have Certificate of training in Industrial Health (CIH/AFIH/DIH) of minimum three months duration recognised by State Government.

- 1.1 Post qualification experience will be desirable.
- 1.2 Only full time Regular courses will be considered.

#### 2. <u>EMOLUMENTS AND OTHER BENEFITS</u>

2.1 Engagement is full time on temporary tenure basis and will have initial period of engagement for not more than one year. Based on the performance, period of engagement may be extended further on yearly basis. However, the maximum period of contractual engagement shall not



exceed beyond 30.06.2026. Increment will be given on extension of services after completion of one-year engagement.

- 2.2 Consolidated Monthly Fees of **Rs. 93,000/-** (Rupees Ninety-Three Thousand Only) will be paid per month.
- 2.3 Annual Increment of Rs. 2800/- will be given on extension of period (if any) after completion of one-year of engagement.
- 2.4 OPD expenses (as in-house medical facility is not available at GAIL, Gandhar) of Rs.1,000/- per month.
- 2.5 Family floater insurance cover of Rs.5 Lakhs for indoor treatment in respect of self, spouse and two immediate dependents i.e. children and/ or parents.
- 2.6 Personal Accident Insurance Policy for an amount of Rs.12 Lakhs to cover any eventuality including disability and medical treatment therefor.
- 2.7 Bachelor/ Family Accommodation shall be provided as per the entitlement for Sr. Officers/Eng. level in the Residential Colonies of GAIL subject to availability and License Fee Recovery (LFR) shall be made accordingly. Water, electricity charges and any other charges as applicable shall be recovered as per the rules.
- 2.8 TA/DA is also payable in case duty requires travelling or deputed for field duty to other locations as per rules, entitlement will be regulated similar to that for accommodation.
- 2.9 Factory Medical Officer will be entitled for 12 CL and 12 paid leave in a calendar year. For pro-rata calculation, 1 CL and 1 paid leave for a month may be taken. He will also be entitled to compensatory off for attending extra duty. Paid leave can be accumulated/ carried forward but not casual leave.
- 2.10 All the above benefits will be governed by the policy of the Company in force & amended from time to time.

- (ii) Self-attested recent passport size colour photograph (3.5 X 4.5 cm) of the candidate with white background (.JPEG/ .JPG/ .BMP format size upto 50 KB).
- (iii) MBBS degree certificate.
- (iv) MBBS internship completion certificate.
- (v) Registration with Medical Council of India or with State Medical Council.
- (vi) Degree certificate of Higher/ additional qualification(s) acquired (e.g., MD etc), if any.
- (vii)Complete and Proper Experience certificates/ Documents issued by the Employer in support of post qualification experience details mentioned by the candidate in the Application Form.
- (viii) NOC/ Forwarding Letter from the employer in case the candidate is employed in Central/ State Government Department, Central/ State PSUs or Semi Government organization.
- (ix) Valid Photo ID Proof: PAN Card/ Voter ID/ Aadhar Card/ Driving License etc.

6.1 Appointment to the above posts will be subject to the candidate being found medically fit.
