- ii) The provisional merit list shall be prepared on the basis of marks obtained by the candidate in written test (Computer Based Test) subject to the Scrutiny of eligibility documents at the time of Initial Medical Examination (IME).
- iii) Finally, selected candidates will have to undergo Initial Medical Examination (IME) by company's own doctors & the findings thereon will be final. Those who will be found unfit, will be disqualified for employment.

### 7. Application Fee of Rs. 1000/- (Non- Refundable):

- xiv) Shortlisted candidates, qualifying the CBT will be called for Initial/Pre-Employment Medical Examination through Email. The list of shortlisted candidates will be hoisted in the ECL's official website as well.
