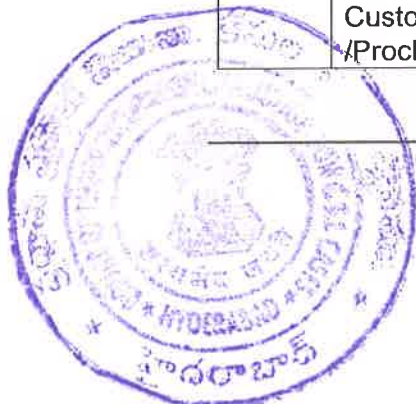

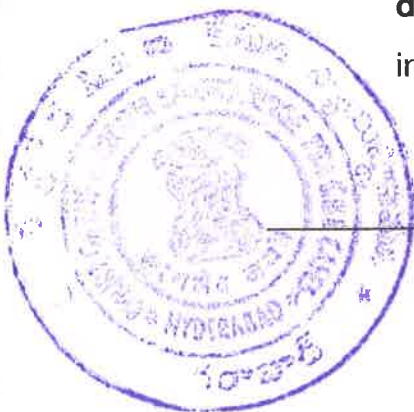
## 16. BRIEF FACTS OF THE CASE

16.1. That Central Bureau of Investigation (CBI) registered this case on 09.07.2020, U/s 302 IPC on the directions dated 11.03.2020 of Hon'ble High Court of Andhra Pradesh, whereby investigation of case originally registered vide FIR No. 84/2019 dated 15.03.2019 at Police Station - Pulivendula, District – Kadapa, Andhra Pradesh relating to murder of Shri Y.S. Vivekananda Reddy (**deceased**) was transferred to CBI.

16.2. That as per said FIR No. 84/2019, one M. V. Krishna Reddy (**Personal Assistant of Y. S. Vivekananda Reddy & complainant**) had filed a complaint in the morning of 15.03.2019 on the allegations that at about 05.30 AM, the complainant reached at the house of Y. S. Vivekananda Reddy, who by that time had not woken up. Thus, he read news-paper for half an hour and thereafter called Smt. Y. S. Sowbhagyamma, wife of YS Vivekananda Reddy and informed her that Y. S. Vivekananda Reddy has not yet woken up and

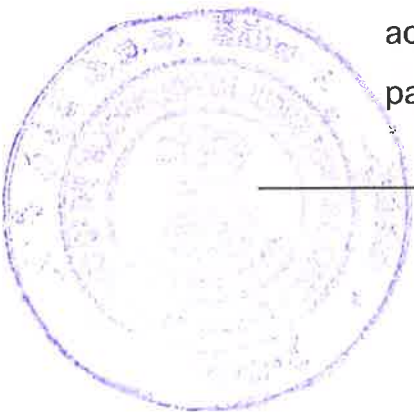


asked her permission to wake him up. On this, she informed him that Y.S. Vivekananda Reddy had gone to bed late in the night and thus told not to wake him up. Around half an hour after, cook Lakshmi and her son Prakash also reached at the house of Y. S. Vivekananda Reddy. Then, the complainant told her (**cook Ms. Lakshmi**) to wake up Y.S. Vivekananda Reddy, otherwise he (Y.S. Vivekananda Reddy) would shout on them. After sometime, Lakshmi informed the complainant that Vivekananda Reddy did not respond despite her repeated attempts of knocking the window pane. Thereafter, he (**the complainant**) also attempted to call Y.S. Vivekananda Reddy, but there was no response. Further, Ranganna (**Watchman of the house**) informed the complainant that the side door of the house was open. Then, Prakash (**son of cook Ms. Lakshmi**) and complainant both went inside and noticed that the door of the bed room was opened. They also noticed pool of blood about 2 liters splashed on the floor, but they didn't find Vivekananda Reddy inside the bed room and to their surprise, they found the body of Vivekananda Reddy lying in the bathroom floor in a pool of blood. Then, they checked pulse, which was not found functioning. They also noticed injuries on the forehead, back side of head and on the palm. He (**the complainant**) told Prakash that Y.S. Vivekananda Reddy is no more and then he (**the complainant**) came out of the house and telephoned to N. Raja Shekhar (**Son-in-law of deceased**) and Sowbhagyamma (**Wife of deceased**) and informed them about the matter.





- 16.3. That after initial investigation, CBI has filed a Charge-sheet u/s 173(2) Cr. PC in the Ld. Court of Judicial Magistrate – First Class, Pulivendula on 26.10.2021 against 04 accused persons namely Thumallapalli Gangi Reddy (A-1), Yadati Sunil Yadav (A-2), Gajjala Uma Shankar Reddy (A-3) and Shaik Dasthagiri (A-4) for commission of offences punishable U/s 302, 120-B IPC.
- 16.4. That out of the 04 accused charge sheeted, Shaik Dasthagiri (A-4) has been tendered pardon by the Ld. Chief Judicial Magistrate, Kadapa under section 306 Cr.P.C vide order dated 26.11.2021 for taking him as approver. The said order dated 26.11.2021 was challenged by the accused T. Gangi Reddy (A-1) and Gajjala Uma Shankar Reddy (A-3) before Hon'ble High Court of Andhra Pradesh. Hon'ble High Court dismissed their petitions vide a common order dated 16.02.2022 by upholding the order dated 26.11.2021 of Ld. CJM, Kadapa. Thereafter, the statement of Shaik Dasthagiri (A-4) was recorded by the Ld. Judicial Magistrate, First Class, Pulivendula u/s 306 (4) Cr. PC on 21.02.2022. Thus, he has been taken as approver in the case. Subsequently, Gajjala Uma Shankar Reddy (A-3) and D. Siva Shankar Reddy (A-5) filed appeal against the Hon'ble High Court order dated 16.02.2022 before the Hon'ble Supreme Court, however, their petitions were dismissed by the Hon'ble Supreme Court vide order dated 10.10.2022.
- 16.5. That during the course of further investigation role of another accused D. Siva Shankar Reddy (A-5) was found in the participation of conspiracy for murder of Y. S. Vivekananda

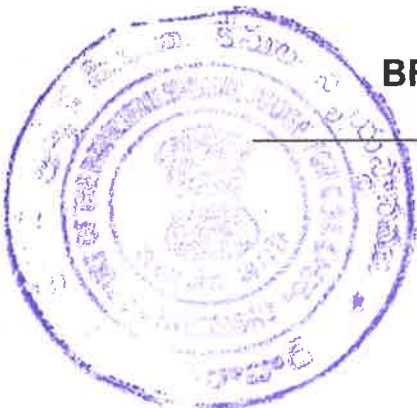


Reddy and also in the destruction of evidence at the Scene of Crime. Further, it was also found that accused T. Gangi Reddy **(A-1)** also had actively participated in the destruction of evidence at the Scene of Crime besides criminally intimidating to one of the eye-witnesses namely B. Ranganna **(Watchman of the house of deceased)** by threatening him. Therefore, a Supplementary Charge-sheet dated 31.01.2022 u/s 173 (8) Cr. PC was filed before Ld. Court of Judicial Magistrate – First Class, Pulivendula against accused D. Siva Shankar Reddy **(A-5)** u/s 201 & 120-B r/w 302 & 201 IPC. Further, accused T. Gangi Reddy **(A-1)** was also charge sheeted for the offences u/s 201, 506 & 120-B r/w 201 IPC in continuation to the first charge-sheet filed on 26.10.2021 by CBI.

**16.6.** That accused T. Gangi Reddy **(A-1)**, Yadati Sunil Yadav **(A-2)**, Gajjala Uma Shankar Reddy **(A-3)**, D. Siva Shankar Reddy **(A-5)**, Gajjala Uday Kumar Reddy **(A-6)** and Y.S. Bhaskar Reddy **(A-7)** are presently in Judicial Custody. Accused Y.S. Avinash Reddy **(A-8)** has been granted Anticipatory Bail u/s 438 Cr. PC by the Hon'ble High Court of Telangana on 31.05.2023. Thereafter, he has been arrested on 03.06.2023 and released on bail on the same day.

**16.7.** That after filing of Supplementary Charge-sheet u/s 173 (8) Cr. PC dated 31.01.2022, further investigation against other accused/suspect remained continued.

### **BRIEF PROFILE OF THE VICTIM (DECEASED)**



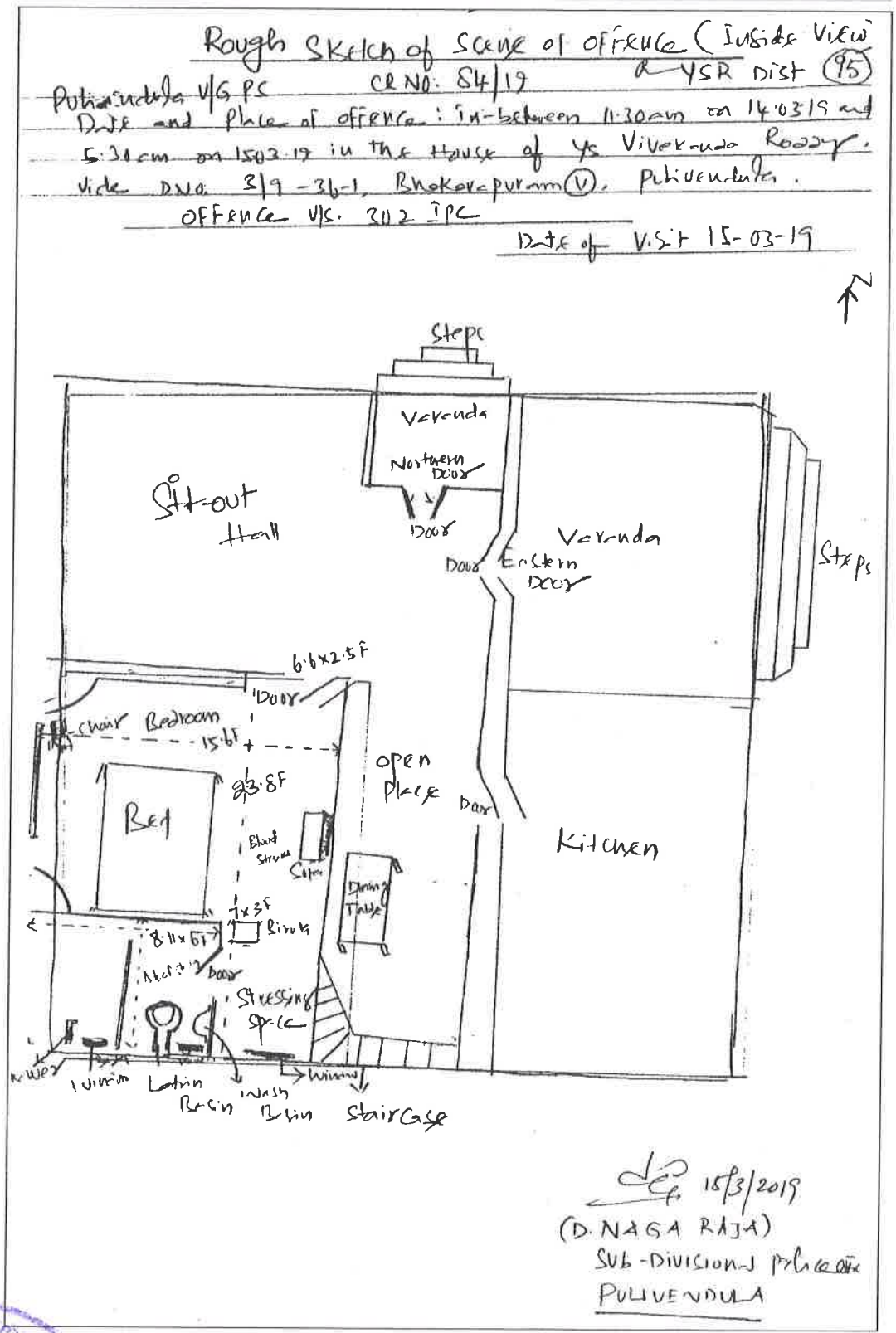
**16.8.** That Late Y.S. Vivekananda Reddy S/o Sh. Y. S. RajaSekhara Reddy, aged about 68 years, was pursuing an active political carrier. He had served two terms as Member of Legislative Assembly (MLA) of Pulivendula Constituency of the State of Andhra Pradesh from year 1989 – 1999. Thereafter, he had served for two terms as Member of Parliament - Lok Sabha (MP) from Kadapa, Lok Sabha Parliamentary constituency for the year from 1999 – 2009. He was also elected as Member of Andhra Pradesh Legislative Council (MLC) in the year 2009 and had also served as Minister for Agriculture in the State Government of Andhra Pradesh. Moreover, he was also appointed as the Member of the Parliamentary Committee on Science & Technology, Environment & Forests in the year 2005. He was brutally murdered in the intervening night of 14-15.03.2019 and his dead body was found lying in a pool of blood in the morning of 15.03.2019 by Sh. M. V. Krishna Reddy, P.A. of the deceased.

### **PLACE OF OCCURRENCE**

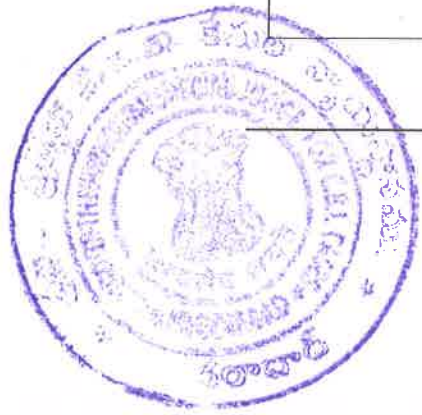
**16.9.** The place of occurrence i.e. house of Y.S. Vivekananda Reddy (D. N. 3-9-36-1, Bhakrapuram, Pulivendula) falls within the jurisdiction of Police Station - Pulivendula (U/G), in the District - Kadapa, Andhra Pradesh. The rough sketch prepared by Sh. D. Nagraja, then SDPO, Pulivendula, Investigating Officer of the case on 15.03.2019 in Crime No. 84/2019 is as such:

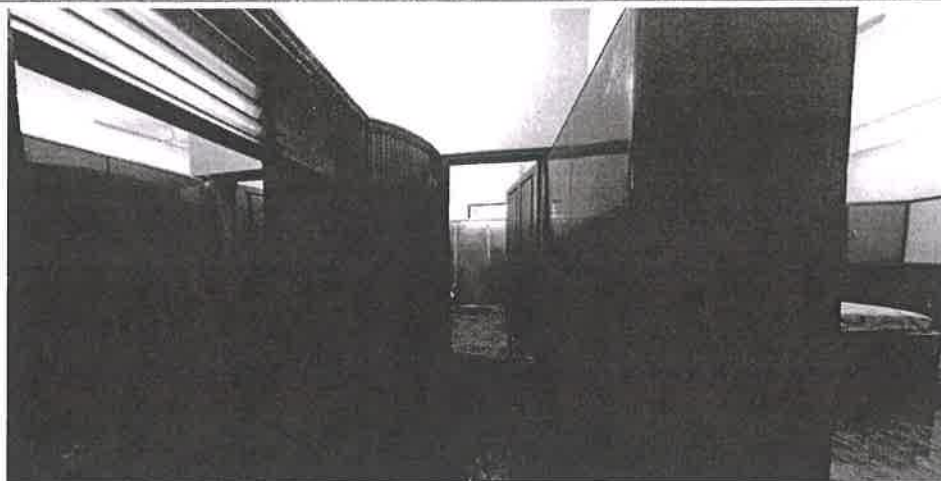


DRAWING ROOM/ HALL AREA

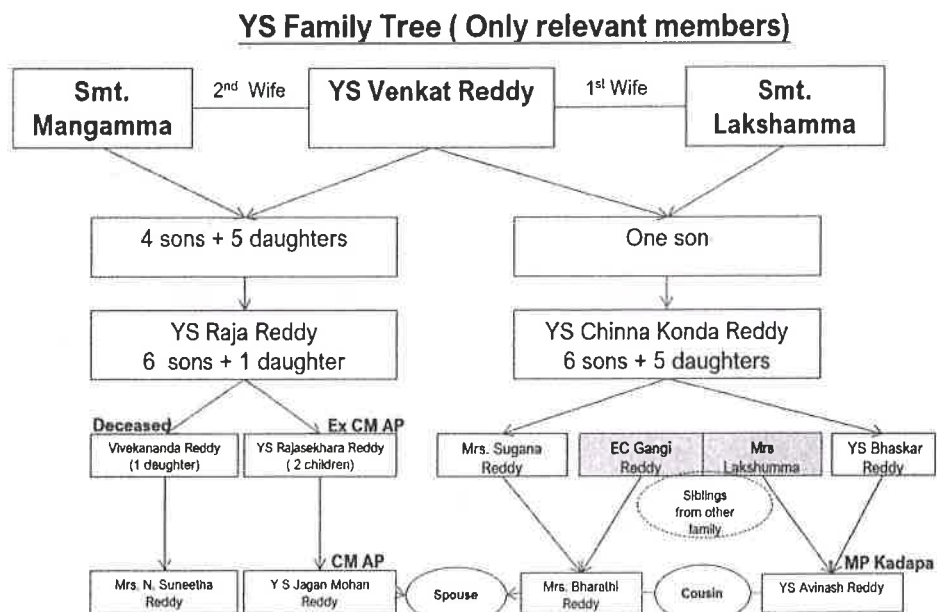

## MOTIVE BEHIND THE CONSPIRACY

**16.12.** Investigation revealed that YS (**Yeduguri Sandinti**) Family has enjoyed the reputation of being an influential and politically active in the State of Andhra Pradesh, particularly in the District Kadapa and other districts of Rayalaseema region. The family tree of the relevant members of YS family is depicted in a form of a chart as below:



**16.13.** It is revealed that Late Y. S. Raja Reddy (**father of deceased Y.S. Vivekananda Reddy**), who was engaged in mining business, got killed in an incident of bomb attack at Vemula, Kadapa during the year 1998. Thereafter, his legacy got shifted in the hands of his sons namely **(1) Y. S. Rajasekhara Reddy** and **(2) Y. S. Vivekananda Reddy**. Since, year 1998 to 2009, Shri Y. S. Rajasekhara Reddy, real brother of Sh. YS Vivekananda Reddy was having control over the entire YS family.





- 16.14.** It is revealed that Late Sh. Y. S. Raja Reddy had extended financial help to his cousin Late Sh. Y. S. Chinna Konda Reddy. However, Y. S. Chinna Konda Reddy could not return the money lent from Y. S. Raja Reddy. Later on, as per mutual understanding some of the assets of Y. S. Chinna Konda Reddy family were transferred in the name of Y. S. Raja Reddy's family as a settlement for the outstanding dues. However, with this settlement Shri Y. S. Bhaskar Reddy (A-7), son of Late Sh. Y. S. Chinna Konda Reddy and his brothers were not happy and showed their resentment, as their assets were transferred to the Y. S. Raja Reddy family. In the year 1996, late Shri Y. S. Rajasekhara Reddy got married his son Shri Y. S. Jagan Mohan Reddy to Ms. Bharathi, daughter of Shri E. C. Gangi Reddy and Dr. Sugana Reddy. Dr. Sugana Reddy is one of the sisters of Y. S. Bhaskar Reddy (A-7).
- 16.15.** It is revealed that Shri Y. S. Bhaskar Reddy (A-7) and his family had always been ambitious that their family should also be active in politics on account of the fact that though Shri Y. S. Rajasekhara Reddy had always kept them in confidence but never let them actively participate in politics. Due to such circumstances, Shri Y. S. Bhaskar Reddy (A-7) and his family members could not fulfil their ambition of becoming MLC, MLA or MP etc. Whereas, descendants of YS family, Shri Y. S. Rajasekhara Reddy and Y. S. Vivekananda Reddy were dominating in the politics. Further, Shri Y. S. Rajasekhara Reddy promoted his son Shri Y. S. Jagan Mohan Reddy, who became MP (Lok Sabha) in May, 2009 from Congress Party.



- 16.16. It is revealed that Y. S. Rajasekhara Reddy – Chief Minister of the State of Andhra Pradesh and a leader of Congress Party, died in an incident of helicopter crash in September 2009. After his demise, Shri K. Rossaiya became Chief Minister of Andhra Pradesh. Sh. YS Jagan Mohan Reddy, who was Lok Sabha MP at that time formed a new political party under the name and style of 'Yuvajana Shramika Rythu Congress Party' (YSRCP) without consulting his uncle Shri Y. S. Vivekananda Reddy, who was the only senior politician from YS family in Congress Party in the State of Andhra Pradesh, after the demise of Shri YS Rajshekhar Reddy.
- 16.17. It is revealed that after the formation of new party (YSRCP), there were bi-elections in the State of Andhra Pradesh during year 2011. The MLA seat from Pulivendula Constituency was held by Congress Party since 1978 to 2009, thus the party wanted to retain this seat. Therefore, Y. S. Vivekananda Reddy was made MLA candidate from Congress party from Pulivendula seat, whereas Smt. YS Vijayamma (**mother of YS Jagan Mohan Reddy**), was fielded as a candidate from YSRCP. Since, there were two candidates from same family on Pulivendula seat, therefore in order to resolve this issue, Shri Y. S. Jagan Mohan Reddy discussed the matter with Y. S. Vivekananda Reddy and requested him to contest for MP/MLA from YSRCP. However, Shri Y. S. Vivekananda Reddy did not agree with this proposal saying that he had already committed to the high command of Congress Party to support them and further told that after this election, he will not be a problem for

YSRCP as he will quit Congress Party and support Shri Y. S. Jagan Mohan Reddy in future. Since, Y. S. Bhaskar Reddy (A-7) was not in good terms with Y. S. Vivekananda Reddy, therefore he did not support him rather he strongly supported Smt. Y. S. Vijayamma, thus in the bi-election, Smt. Y. S. Vijayamma defeated Y. S. Vivekananda Reddy.

**16.18.** It is revealed that in spite of the defeat of Shri Y. S. Vivekananda Reddy in the bi-election, he always wanted that Shri Y. S. Jagan Mohan Reddy should carry on the legacy of their family in politics in the State of Andhra Pradesh, therefore, in a family gathering, Shri Y. S. Vivekananda Reddy announced to quit the Congress Party and decided to join YSRCP. Accordingly, in the month of May - 2012, Shri Y. S. Vivekananda Reddy quit Congress Party and subsequently joined YSRCP. Thereafter, he participated in a Bus Yatra held in Guntur District along with Shri Y. S. Jagan Mohan Reddy.

**16.19.** Investigation revealed that in view of increasing popularity of YSRCP, and also with the fact that Y. S. Bhaskar Reddy (A-7) had helped Smt. Y. S. Vijayamma to win Pulivendula bi-election, Shri Y. S. Jagan Mohan Reddy wanted to contest AP Assembly Election 2014 expecting win of his newly formed party YSRCP in the state elections with majority. Therefore, though Shri Y. S. Jagan Mohan Reddy had committed Shri Y. S. Vivekananda Reddy for entrusting some significant portfolio in lieu of his joining in YSRCP, but MP ticket for 2014 General Election from



Kadapa Lok Sabha constituency from YSRCP was given to Y. S. Avinash Reddy **(A-8)**, son of Y. S. Bhaskar Reddy **(A-7)**.

**16.20.** It is revealed that in 2014 general elections, since Shri Y. S. Vivekananda Reddy could not get either MLA or MP ticket from YSRCP, however as per commitment made by Shri Y. S. Jagan Mohan Reddy, he was given MLC ticket from Kadapa in 2017. By this time, Shri Y. S. Vivekananda Reddy had again become active in politics from YSRCP and if he would have won the MLC election, he would have been a strong contender for MP ticket from Kadapa Lok Sabha constituency.

**16.21.** It is revealed that Shri Y. S. Vivekananda Reddy could not win MLC election 2017, which was very shocking for him as he was very confident of his win. In the MLC election, the affairs at Pulivendula division were being looked after by YSRCP leader namely D. Siva Shankar Reddy **(A-5)**, who was very close to Y. S. Bhaskar Reddy **(A-7)** and Y. S. Avinash Reddy **(A-8)**. Further, D. Siva Shankar Reddy **(A-5)** himself wanted to contest MLC election. Y.S. Bhaskar Reddy **(A-7)** and Y. S. Avinash Reddy **(A-8)** also wanted that MLC ticket should be given to D. Siva Shankar Reddy **(A-5)**, instead of Y. S. Vivekananda Reddy, however, they could not succeed, as Shri Y. S. Jagan Mohan Reddy had given MLC ticket to Y.S. Vivekananda Reddy. Thus, D. Siva Shankar Reddy **(A-5)**, Y. S. Bhaskar Reddy **(A-7)** and Y.S Avinash Reddy **(A-8)** got annoyed and developed a grudge against Shri Y.S. Vivekananda Reddy. Therefore, Y. S. Bhaskar Reddy **(A-7)**, Y. S. Avinash Reddy **(A-8)** and D. Siva Shankar





Reddy **(A-5)** with the help of T. Gangi Reddy @ Y. Gangi Reddy **(A-1 and also a long-time associate of Shri Y.S. Vivekananda Reddy)** sabotaged the MLC election 2017 to ensure defeat of Shri Y. S. Vivekananda Reddy.

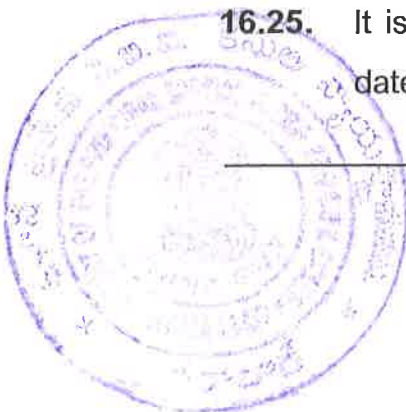
**16.22.** It is revealed that after defeat in MLC election, Shri Y.S. Vivekananda Reddy learnt that T. Gangi Reddy **(A-1)**, D. Siva Shankar Reddy **(A-5)**, Y. S. Bhaskar Reddy **(A-7)** and Y. S. Avinash Reddy **(A-8)** had sabotaged the MLC election and got defeated him deliberately in the MLC election. Thus, Shri Y.S. Vivekananda Reddy visited the house of Y. S. Bhaskar Reddy **(A-7)** / Y. S. Avinash Reddy **(A-8)** and there he scolded D. Siva Shankar Reddy **(A-5)**, Y. S. Bhaskar Reddy **(A-7)** Y. S. Avinash Reddy **(A-8)** for their involvement in sabotaging the MLC election. Moreover, Y. S. Vivekananda Reddy also scolded T. Gangi Reddy **(A-1)** as he had deceived him in the MLC election. Thereafter, Y. S. Vivekananda Reddy had started disbelieving on T. Gangi Reddy **(A-1)**, and had scolded him on several occasions. By this time, T. Gangi Reddy **(A-1)** had developed a good relation with D. Siva Shankar Reddy **(A-5)**, Y. S. Bhaskar Reddy **(A-7)** and Y. S. Avinash Reddy **(A-8)**.

**16.23.** It is revealed that despite defeat in the MLC election 2017, Y. S. Vivekananda Reddy was very active for the Lok Sabha Elections 2019, which were scheduled to be held in the month of April - 2019 and nominations for the candidature to be filed in the month of March 2019. Since, Y. S. Vivekananda Reddy had developed stalemate with D. Siva Shankar Reddy **(A-5)**, Y. S.

Bhaskar Reddy (**A-7**) and Y. S. Avinash Reddy (**A-8**) and therefore he wanted that MP ticket from Kadapa Lok Sabha constituency should either be given to himself or Smt. Y. S. Sharmila (**sister of Shri Y. S. Jagan Mohan Reddy**) or Smt. Y. S. Vijayamma (**mother of Shri Y. S. Jagan Mohan Reddy**) instead of Y. S. Avinash Reddy (**A-8**), incumbent Lok Sabha MP. Moreover, Y.S. Vivekananda Reddy believed that Y.S. Avinash Reddy (**A-8**) was a weak candidate for MP Kadapa and therefore he wanted that Y. S. Avinash Reddy (**A-8**) should be given MLA ticket from Jammalamadugu / Kamlapuram Assembly constituency instead of MP ticket from Kadapa Lok Sabha constituency. Accordingly, Shri Y. S. Vivekananda Reddy got convinced Smt. Y. S. Sharmila to contest from Kadapa Lok Sabha constituency.

**16.24.** Investigation revealed that the political move of Shri Y. S. Vivekananda Reddy was a hinderance in the coming elections for Y. S. Avinash Reddy (**A-8**) as he was being proposed to contest as MLA candidate instead of MP from Kadapa Lok Sabha constituency. Therefore, in order to thwart the plan of YS Vivekananda Reddy, a criminal conspiracy was hatched with the help of D. Siva Shankar Reddy (**A-5**) who was an associate of Y. S. Bhaskar Reddy (**A-7**) and Y. S. Avinash Reddy (**A-8**) besides having criminal antecedent, to get eliminated YS Vivekananda Reddy.

**16.25.** It is revealed that for General Elections - 2019 for Lok Sabha, dates were announced on 10.03.2019 followed by Notification



dated 18.03.2019 issued by the Election Commission of India. As per the Notification, in the State of Andhra Pradesh, Polling was scheduled in the first Phase on 11.04.2019. The last date for filing of nomination was till 25.03.2019. For Kadapa Lok Sabha Seat, YS Avinash Reddy **(A-8)** had filed his election nomination on 20.03.19. As per media reports, YSRCP had declared his name to contest from Kadapa Constituency on 17.03.19. However, in the meantime on the intervening night of 14 - 15.03.2019 Sh. YS Vivekananda Reddy was murdered.

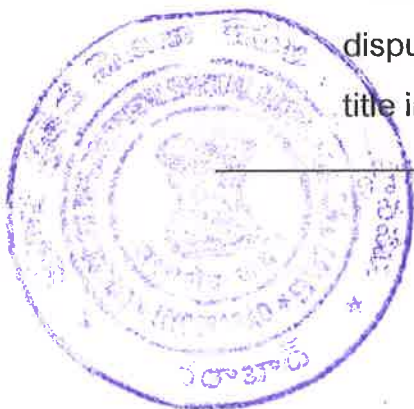
**16.26.** It is revealed that D. Siva Shankar Reddy **(A-5)**, in order to execute the plan of murder of Shri Y. S. Vivekananda Reddy, had roped in T. Gangi Reddy **(A-1 and also a long-time associate of Shri Y.S. Vivekananda Reddy)** who had developed grudge on various accounts against Shri Y. S. Vivekananda Reddy but still had association with the deceased.

**16.27.** It is revealed that T. Gangi Reddy **(A-1)** participated in pursuance of the criminal conspiracy to execute the plan of murder of Y.S. Vivekananda Reddy in view of his bitter experiences with Shri Y. S. Vivekananda Reddy. It is revealed that Shri Y. S. Vivekananda Reddy was pursuing a settlement for a disputed property measuring 08 acres 06 Gunthas located at No. 53 Old 24, Kogilu Village, Yelahanka Hobli, Bangalore North Taluk, Bangalore. The dispute was between 02 claimants of land namely **(1)** Shri Y. Radhakrishna Murthy and his sons (erstwhile r/o Kadapa) and **(2)** Shri H. M. Himachalpati (r/o Bangalore). This property had circle rate of approximately 35 crores and market



value of approx. 80 crores. In order to reach a settlement in this dispute, Y. Radhakrishna Murthy (expired on 10.12.2020) contacted Shri Y. S. Vivekananda Reddy through one Sh. Laxmika Lingam R/o Chitwel, District Kadapa for helping in the settlement. They had agreed to give 10-15% commission (Approx. 8 crores) to Shri Y. S. Vivekananda Reddy after settlement of said dispute.

- 16.28.** During investigation Shri Venkata Prasad S/o Shri Y. Radha Krishna Murthy revealed that initially the said disputed land was in possession of M/s IVY Traders, which had agreed to sell the land in favour of Sh. Y. Radha Krishna Murthy against the consideration amount of Rs. 10.50 lakhs on 05.06.1991. The owner of land had executed a General Power of Attorney as well as Agreement of Sale in favour of his Late father Sh. Y. Radha Krishna Murthy. Later, one Himachalpati R/o Bangalore took possession of the said land without the knowledge of Sh. Y. Radha Krishna Murthy and they could not take possession of the land despite their efforts. Thereafter, Shri Y. Radha Krishna Murthy approached Sh. Laxmika Lingam R/o Chitwel, District Kadapa through one Sh. J. D. Rajsekhar resident of Tirupati. In turn, Sh. Laxmika Lingam discussed the matter with Sh. YS Vivekananda Reddy who agreed to assist in this matter. Shri YS Vivekananda Reddy being a political figure approached senior police officers and politicians in Bangalore to intervene in the matter to facilitate Sh. Radha Krishna Murthy for possession of disputed land. However, the matter could not be resolved as the title in the name of Y. Radha Krishna Murthy was not clear.





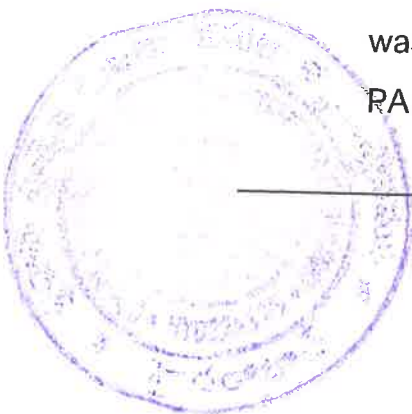
- 16.29.** It is revealed that Y. S. Vivekananda Reddy along with said Sh. Laxmikaar, T. Gangi Reddy **(A-1)** and one Malli Venkat Ramanna, a financier met a Police officer namely Rajesh Jaisimha, Dy. SP at Bangalore who further took them to one Mr. Peter Caddy, a Bangalore based real estate dealer. Further, Sh. Y. Radha Krishna Murthy, owner of the property also authorized Sh. Y. S. Vivekananda Reddy to deal with this matter on his behalf. During investigation one agreement on a stamp paper of year 1992 has been found to have been executed in favour of Y. S. Vivekananda Reddy by Y. Radha Krishna Murthy. Sh. Radha Krishna Murthy, YS Vivekananda Reddy are signatories on this document, whereas Kota Venkata Prasad, T. Gangi Reddy **(A-1)** are witnesses of this document.
- 16.30.** Investigation revealed that in order to meet various expenses to dispose of the property financier Shri Malli Venkat Ramanna had paid Rs. 24 lakhs to Peter Caddy. However, since the settlement could not materialise, Peter Caddy returned Rs. 24 lakhs to Shri Malli Venkat Ramanna through DD during the months of Feb – March, 2019. During investigation, no evidence has come on record to establish that Shri Y. S. Vivekananda Reddy had received any amount from pursuing settlement of this dispute.
- 16.31.** Investigation on the said aspect further revealed that while pursuing the said settlement, T. Gangi Reddy **(A-1)** had also visited Bangalore on several occasions along with Shri Y. S. Vivekananda Reddy and was in the knowledge of ongoing

settlement and likely receipt of huge amount as a commission. Further, on some occasions, Yadati Sunil Yadav (A-2) also accompanied by with them. Whereas, Shaik Dasthagiri (A-4 turned approver) was also having knowledge of the aforesaid settlement being Driver of Shri Y. S. Vivekananda Reddy and accompanying with him while visiting Bangalore.

16.32. Investigation further revealed that in one of such visits, Shri Y. S. Vivekananda Reddy accompanied by T. Gangi Reddy (A-1) and Shaik Dasthagiri (A-4 turned approver) visited Bangalore and stayed at a Guest house at Yelahanka, Bangalore. In the guest house, Shri Y. S. Vivekananda Reddy and T. Gangi Reddy (A-1) had consumed liquor and entered in a verbal fight on the demand of T. Gangi Reddy (A-1) asking 50% share in money to be received out of the said settlement. On this, Y.S. Vivekananda Reddy expressed his anger and did not agree to satisfy the demand of T. Gangi Reddy (A-1). Further, Shri Y. S. Vivekananda Reddy scolded T. Gangi Reddy (A-1) by saying that "**have you become so big, that you are going to ask me your share**". Thereafter, Shri Y. S. Vivekananda Reddy left the guest house along with Shaik Dasthagiri (A-4 turned approver), Driver for Pulivendula, leaving T. Gangi Reddy (A-1) at the guest house. The heated arguments between both were also seen by the caretaker of the guest house namely Ram Bahadur Sunal. It is revealed that after this incident, there was no communication between both for some time.



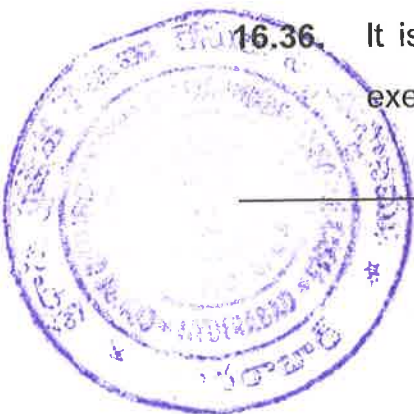
- 16.33. Investigation revealed that despite failure of settlement in the said dispute, T. Gangi Reddy **(A-1)** was able to falsely convince Shri Y. S. Vivekananda Reddy that they are likely to receive huge amount out of the said settlement very soon. Further, T. Gangi Reddy **(A-1)**, convinced other co-accused persons in executing the plan of murder citing that Y. S. Vivekananda Reddy has developed greed and had not given him money in Bangalore land settlement case.
- 16.34. It is further revealed that in order to execute the plan of murder, T. Gangi Reddy **(A-1)** further involved three known persons namely Yadati Sunil Yadav **(A-2)**, Gajjala Uma Shankar Reddy **(A-3)** and Shaik Dasthagiri **(A-4 turned approver)**, who also had developed grudge on different accounts with Shri Y. S. Vivekananda Reddy. As revealed by Shaik Dasthagiri **(A-4 turned Approver)** in lieu of murder of Shri Y. S. Vivekananda Reddy, a promise of payment of Rs 40 crores was also made by T. Gangi Reddy **(A-1)** at the behest of D. Siva Shankar Reddy **(A-5)**, Y. S. Bhaskar Reddy **(A-7)**, and Y. S. Avinash Reddy **(A-8)**.
- 16.35. Investigation revealed that in furtherance of criminal conspiracy for committing the murder T. Gangi Reddy **(A-1)** got convinced Yadati Sunil Yadav **(A-2)** to participate in their plan. Yadati Sunil Yadav **(A-2)** was associated with Y. S. Vivekananda Reddy for nearly 1.5 years before the incident. Yadati Sunil Yadav **(A-2)** was an ambitious person and used to introduce himself as the RA of Shri Y. S. Vivekananda Reddy. Further, Yadati Sunil



Yadav **(A-2)** had obtained money from several persons using name of Shri Y. S. Vivekananda Reddy. Even, Yadati Sunil Yadav **(A-2)** had also tried to cheat Shri Y. S. Vivekananda Reddy by floating a fake story of sale of some diamonds/precious stones, claiming to be in his possession. Initially, though Shri Y. S. Vivekananda Reddy had come under the influence of Yadati Sunil Yadav **(A-2)** and started facilitating his movements by letting him use his personal vehicle besides extending other facilities. However, when Sh. N. Raja Shekhar Reddy **(son-in-law of the deceased)** got to know the activities of Yadati Sunil Yadav **(A-2)** about the fake story relating to possession of diamond and its sell to Y S Vivekananda Reddy, N. Raja Sekhar Reddy scolded him and warned him to stay away from Y. S. Vivekananda Reddy. During investigation the story relating to possession of precious stone /diamond floated by Yadati Sunil Yadav **(A-2)** has been found to be false. Moreover, Yadati Sunil Yadav **(A-2)** was also annoyed with Y. S. Vivekananda Reddy, on being scolded by his mother Mrs. Savithri, who was suspecting that Y. S. Vivekananda Reddy had a bad eye on her. After these episodes, Yadati Sunil Yadav **(A-2)** was unhappy with Y. S. Vivekananda Reddy, hence on being contacted by T. Gangi Reddy **(A-1)** with a share in the promised amount of Rs. 40 crores, he also participated in the plan of execution of murder of Shri Y. S. Vivekananda Reddy.

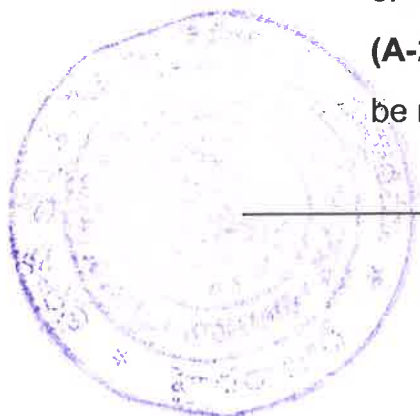
16.36.

It is revealed that in furtherance of the criminal conspiracy to execute the plan of murder, T. Gangi Reddy **(A-1)** involved





associate namely Gajjala Uma Shankar Reddy (**A-3**) who was brother of Shri Gajjala Jagdeeshwar Reddy – a close associate of Shri Y. S. Vivekananda Reddy. It is revealed that Shri Gajjala Jagdeeshwar Reddy was maintaining the party funds of Shri Y. S. Vivekananda Reddy for various expenses and had also campaigned for him during MLC election 2017. During investigation, it was found that Shri Y. S. Vivekananda Reddy was also holding one benami property of about 16 acres of agricultural land in name of Gajjala Jagdeeshwar Reddy. Due to such association of Gajjala Jagdeeshwar Reddy with Shri Y. S. Vivekananda Reddy, his brother Gajjala Uma Shankar Reddy (**A-3**) and his family members were expecting some political favour in the village sarpanch election, but Shri Y. S. Vivekananda Reddy never favoured them as they were not having adequate support in the village. In the meantime, Gajjala Uma Shankar Reddy (**A-3**) was got convinced by Yadati Sunil Yadav (**A-2**) with the allurements of huge amount of money to be received from selling of diamonds lying in his possession, for which they were looking for any gullible buyer to cheat. Further, Gajjala Uma Shankar Reddy (**A-3**) through his elder brother Gajjala Jagdeeshwar Reddy got introduced Yadati Sunil Yadav (**A-2**) with YS Vivekananda Reddy for discussion regarding transaction of precious stone/ diamonds. In this connection, on certain occasions YS Vivekananda Reddy had visited the house of Gajjala Uma Shankar Reddy (**A-3**) and Yadati Sunil Yadav (**A-2**) to pursue the progress of transaction and likely amount to be received from the sale of precious stone/ diamonds. Since, in



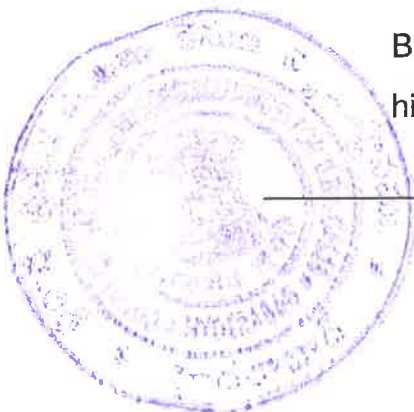
the meantime, Gajjala Uma Shankar Reddy (A-3) was not taking care of his milk dairy business therefore he started suffering loss. This resulted in strained relationships with his brother Gajjala Jagdeeshwar Reddy. Further, Gajjala Jagdeeshwar Reddy on realizing the plan of Yadati Sunil Yadav (A-2) and Gajjala Uma Shankar Reddy (A-3) for selling of diamond to be a hoax, he scolded his brother to not to involve a good person like YS Vivekananda Reddy. Gajjala Jagdeeshwar Reddy further revealed that due to closeness between Yadati Sunil Yadav (A-2) and Gajjala Uma Shankar Reddy (A-3), Yadati Sunil Yadav (A-2) had also started troubling minor daughter of Gajjala Uma Shankar Reddy (A-3). After knowing such activities of Yadati Sunil Yadav (A-2), the matter was taken up in a Panchayat wherein YS Vivekananda Reddy scolded Yadati Sunil Yadav (A-2) and warned him. However, despite these incidents Gajjala Uma Shankar Reddy (A-3) continued his friendship with Yadati Sunil Yadav (A-2). Therefore, Gajjala Uma Shankar Reddy (A-3) also joined the conspiracy along with other co-accused persons.

- 16.37. It is further revealed that in furtherance of criminal conspiracy to execute the plan of murder, T. Gangi Reddy (A-1) involved another person namely Shaik Dasthagiri (A-4 turned approver), Ex-driver of Y.S. Vivekananda Reddy. Shaik Dasthagiri (A-4 turned approver) was removed from his service by Smt. Sowbhagyamma and N. Raja Sekhar Reddy on account of his unsatisfactory service leading to accident of vehicle and also knowing the fact that Shaik Dasthagiri (A-4

**turned approver**) used to take Y. S. Vivekananda Reddy to the house of Ms. Shaik Shameem (**second wife the deceased**). Further, Shaik Dasthagiri (**A-4**) also used to bring unwanted issues relating to matrimonial disputes for settlement before Y. S. Vivekananda Reddy. These issues were bringing disrepute to the name of Y. S. Vivekananda Reddy therefore, family members of Y. S. Vivekananda Reddy were not happy with Shaik Dasthagiri and removed him from service. It is revealed that on being contacted by T. Gangi Reddy @ Y Gangi Reddy (**A-1**), initially Shaik Dasthagiri (**A-4 turned approver**) was hesitant to join the conspiracy, however on being induced by T. Gangi Reddy (**A-1**) with Rs 5 crore as part of share in promised amount of Rs. 40 Crores, he agreed to join the conspiracy for execution of murder Y. S. Vivekananda Reddy.

### PREPERATION FOR EXECUTION OF MURDER

- 16.38.** It is revealed that in furtherance of criminal conspiracy to commit the murder of Sh. Y. S. Vivekananda Reddy, T. Gangi Reddy (**A-1**) met with other 03 co-accused persons namely Yadati Sunil Yadav (**A-2**), Gajjala Uma Shankar Reddy (**A-3**) and Shaik Dasthagiri (**A-4, turned approver**) at his residence sometimes around 08 -10.02.2019. In respect of this meeting, Shaik Dasthagiri (**A-4, turned approver**) has disclosed that T. Gangi Reddy (**A-1**) told them that Shri Y. S. Vivekananda Reddy had not given him share out of the money received from Bangalore land settlement and requested them to do a job for him. Shaik Dasthagiri (**A-4, turned approver**) enquired as to



what the job was? On this, T. Gangi Reddy (A-1) told Shaik Dasthagiri to murder Shri Y. S. Vivekananda Reddy. In response, Shaik Dasthagiri (A-4, turned approver) told him that he will not kill someone whom he worked for. On this, T. Gangi Reddy (A-1) further told Shaik Dasthagiri (A-4, turned approver) that **"You are not alone; we are also with you and we have support of very powerful persons"**. Dasthagiri further enquired as to **"Who are these powerful persons?"** On this, T. Gangi Reddy (A-1) told them that **"YS Avinash Reddy, YS Bhaskar Reddy, YS Manohar Reddy & D. Siva Shankar Reddy are also involved in this plan of murder and D. Shiv Shankar Reddy would give them Rs. 40 crores"**. He also told Dasthagiri that his share would be Rs. 5 crores, out of Rs. 40 crores. T. Gangi Reddy (A-1) further told Dasthagiri that, **"you have worked as a driver for so long, what have you earned. Do this one job and your life will be settled."** Thereafter, Shaik Dasthagiri (A-4, turned approver) agreed to participate in the plan. In this meeting, it was also decided that Yadati Sunil Yadav (A-2) and Gajjala Uma Shankar Reddy (A-3) will kill the dog who used to live at the house of Shri Y. S. Vivekananda Reddy as it could cause a hindrance in execution of their plan. Further, they also decided that T. Gangi Reddy (A-1) will make sure that P. Rajshekhar (house help of YS Vivekananda Reddy) should also not be at the house of Shri Y. S. Vivekananda Reddy, when they execute the murder. However, when Shaik Dasthagiri (A-4 turned approver) came out of the house of T. Gangi Reddy (A-1), he (Shaik Dasthagiri)





told Yadati Sunil Yadav (A- 2) that he is afraid of doing this work. On which, Yadati Sunil Yadav (A- 2) assured Shaik Dasthagiri (A-4 turned approver), by saying that “**why do you fear Dasthagiri, they have big people behind them.**”, and “**if big people are not afraid, then why should they fear**”.

- 16.39. Investigation revealed that 02-03 days after the said meeting to execute the plan of murder, T. Gangi Reddy (A-1) paid an advance amount to other three co-accused persons. Shaik Dasthagiri (A-4, turned approver), received a sum of Rs. 01 Crore in cash from Yadati Sunil Yadav (A-2) as an advance for executing the murder of Sh. Y. S. Vivekananda Reddy. However, out of Rs. 01 crore, Yadati Sunil Yadav (A-2) kept Rs. 25 lacs for himself with the promise to give the same to Sh. Shaik Dasthagiri (A-4, turned approver) after sometime. On this aspect, Shaik Dasthagiri (A-4, turned approver) further revealed that after taking money from Yadati Sunil Yadav (A-2) he asked from Yadati Sunil Yadav (A-2) “**who gave him so much money?**” Then, Yadati Sunil Yadav (A-2) told him that D. Siva Shankar Reddy (A-5) had given the money to T. Gangi Reddy (A-1), who in turn had given this money to him (Yadati Sunil Yadav). Thereafter, in order to confirm Shaik Dasthagiri (A-4, turned approver) asked Yadati Sunil Yadav (A-2), “**Are they telling truth or are they lying**”. On this, Yadati Sunil Yadav (A-2) took Shaik Dasthagiri (A-4, turned approver) to the house of T. Gangi Reddy (A-1), where T. Gangi Reddy (A-1), made a call to D. Siva Shankar Reddy (A-5) and D. Siva Shankar Reddy (A-5) spoke to Shaik Dasthagiri (A-4, turned approver)

on phone and told him that **"Do whatever Gangi Reddy says"**. Further, D. Siva Shankar Reddy (A-5) made confirmation to Shaik Dasthagiri (A-4, turned approver) by saying that **"We told you that we are there, then why do you doubt now"**. The CDR of mobile phone (9440281444) of T. Gangi Reddy (A-1) corroborates that a call on 18.02.2019 at 08:44:19 AM (406 sec) has been made at Mobile Phone (9440203852) belonging to D. Siva Shankar Reddy (A-5).

**16.40.** On the aspect of possession of advance amount of Rs. 75 lakhs, Shaik Dasthagiri (A-4, turned approver) in his disclosure statement dated 10.08.2021 revealed that after receipt of said cash amount, he had planned to buy a 'Villa' at Vijaya Homes in Pulivendula. However, after murder of Y. S. Vivekananda Reddy he had dropped this plan. He further revealed that he had kept the cash amount secretly with his friend namely Sh. Syed Munna for the purpose of safe custody, on assurance that in lieu he will provide 6-7 lakhs rupees to him.

**16.41.** Investigation as regards purchase of 'Villa' by Shaik Dasthagiri (A-4, turned approver), it is revealed that he had contacted with the Manager of 'Vijaya Homes' and had agreed to pay the entire amount of Rs. 75 lakhs in cash. Shri Reddy Chandra Mouli, Manager, 'Vijaya Homes' has confirmed about the verbal agreement in respect of purchase of 'Villa' in 'Vijaya Homes' against a consideration amount of Rs. 75 lakhs in cash by one person namely 'Basha' claiming to be PA of Shri Y.S. Vivekananda Reddy. Shri Chandra Mouli stated that he was

told Yadati Sunil Yadav (A- 2) that he is afraid of doing this work. On which, Yadati Sunil Yadav (A- 2) assured Shaik Dasthagiri (A-4 turned approver), by saying that “**why do you fear Dasthagiri, they have big people behind them.**”, and “**if big people are not afraid, then why should they fear**”.

- 16.39. Investigation revealed that 02-03 days after the said meeting to execute the plan of murder, T. Gangi Reddy (A-1) paid an advance amount to other three co-accused persons. Shaik Dasthagiri (A-4, turned approver), received a sum of Rs. 01 Crore in cash from Yadati Sunil Yadav (A-2) as an advance for executing the murder of Sh. Y. S. Vivekananda Reddy. However, out of Rs. 01 crore, Yadati Sunil Yadav (A-2) kept Rs. 25 lacs for himself with the promise to give the same to Sh. Shaik Dasthagiri (A-4, turned approver) after sometime. On this aspect, Shaik Dasthagiri (A-4, turned approver) further revealed that after taking money from Yadati Sunil Yadav (A-2) he asked from Yadati Sunil Yadav (A-2) “**who gave him so much money?**” Then, Yadati Sunil Yadav (A-2) told him that D. Siva Shankar Reddy (A-5) had given the money to T. Gangi Reddy (A-1), who in turn had given this money to him (Yadati Sunil Yadav). Thereafter, in order to confirm Shaik Dasthagiri (A-4, turned approver) asked Yadati Sunil Yadav (A-2), “**Are they telling truth or are they lying**”. On this, Yadati Sunil Yadav (A-2) took Shaik Dasthagiri (A-4, turned approver) to the house of T. Gangi Reddy (A-1), where T. Gangi Reddy (A-1), made a call to D. Siva Shankar Reddy (A-5) and D. Siva Shankar Reddy (A-5) spoke to Shaik Dasthagiri (A-4, turned approver)

on phone and told him that **"Do whatever Gangi Reddy says"**. Further, D. Siva Shankar Reddy (A-5) made confirmation to Shaik Dasthagiri (A-4, turned approver) by saying that **"We told you that we are there, then why do you doubt now"**. The CDR of mobile phone (9440281444) of T. Gangi Reddy (A-1) corroborates that a call on 18.02.2019 at 08:44:19 AM (406 sec) has been made at Mobile Phone (9440203852) belonging to D. Siva Shankar Reddy (A-5).

**16.40.** On the aspect of possession of advance amount of Rs. 75 lakhs, Shaik Dasthagiri (A-4, turned approver) in his disclosure statement dated 10.08.2021 revealed that after receipt of said cash amount, he had planned to buy a 'Villa' at Vijaya Homes in Pulivendula. However, after murder of Y. S. Vivekananda Reddy he had dropped this plan. He further revealed that he had kept the cash amount secretly with his friend namely Sh. Syed Munna for the purpose of safe custody, on assurance that in lieu he will provide 6-7 lakhs rupees to him.

**16.41.** Investigation as regards purchase of 'Villa' by Shaik Dasthagiri (A-4, turned approver), it is revealed that he had contacted with the Manager of 'Vijaya Homes' and had agreed to pay the entire amount of Rs. 75 lakhs in cash. Shri Reddy Chandra Mouli, Manager, 'Vijaya Homes' has confirmed about the verbal agreement in respect of purchase of 'Villa' in 'Vijaya Homes' against a consideration amount of Rs. 75 lakhs in cash by one person namely 'Basha' claiming to be PA of Shri Y.S. Vivekananda Reddy. Shri Chandra Mouli stated that he was



surprised as before booking the Villa for Rs. 75 lakhs, the person did not even negotiate, and agreed to make payment of Rs. 40-50 lakhs in cash within a week and remaining amount after one month. After the said deal, there were 3-4 telephonic exchange between both. Thereafter, on 13.03.2019 Shri Reddy Chandra Mouli sent a message to said 'Basha' mentioning as **"Sir, if u r please interested to taken Villa or not.....? management asked to them answering to me."** During investigation, it was found that Shri Chandra Mouli had saved name of Shaik Dasthagiri as '**Basha@150**' along with his profile picture in his mobile phone. Further, the message exchanged has been recovered from the mobile phone of Shaik Dasthagiri, which reveals that said Manager of 'Vijaya Homes' had sent the said message from his Mobile phone (+919441156310) at 05:47:46 AM UTC + 0 (11:17:46 AM) to Shaik Dasthagiri (+919515078820) on 03/13/2019. However, the said deal could not materialise after the murder of Shri Y. S. Vivekananda Reddy. It is revealed that in the CDR of Shaik Dasthagiri following calls. SMS have been made/ exchanged between them:

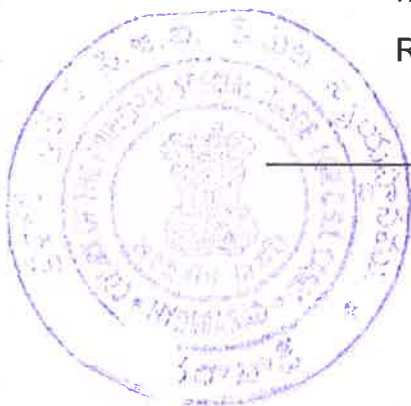

16.42. Investigation in regard to possession of cash amount of Rs. 75 Lakhs by Sh. Syed Munna, it is revealed during investigation that Y. S. Vivekananda Reddy had mediated in marital disputes between Syed Munna and his two wives namely (1) Mrs. B. Raziya and (2) Mrs. Prabhavati @ Ayesha. These persons were brought by Shaik Dasthagiri (**A-4, turned approver**), driver of Y. S. Vivekananda Reddy before him for the purpose of mediation as Syed Munna was a close friend of him. Accordingly, Mrs. B. Raziya and Mrs. Prabhavati were examined on 20&21.09.2020. Thereafter, Syed Munna was also examined on 22.09.2020. However, during examination regarding wherewithal to meet the expenses, Syed Munna was found evasive and denied having any bank account or locker, despite maintaining bank account as well as locker. Therefore, locker of Syed Munna was operated on 23.09.2020 in presence of Bank officials wherein unaccounted cash amount of Rs. 46,70,000/- along with large quantity of new/old jewellery was recovered from the joint locker of the Sh. Syed Munna and his mother. The possession of such a huge amount in locker could not be satisfactorily explained by Sh. Syed Munna and it was suspected to be linked with the commission of murder of Sh. Y.S. Vivekananda Reddy. Accordingly, same was seized u/s 102 Cr. P.C. The details collected from banks relating to locker operation reveals that the locker of Shri Syed Munna was operated on 18.03.2019. Further, between the dates 18.03.2019 to 22.09.2020, the locker had been operated on 25 times. On 05.11.2019, the locker was operated and on the same day, a



cash deposit of Rs. 11 lakh was made in his Saving Account for the purpose of creating a fixed deposit. However, after 03 months, this fixed deposit got realised and amount was withdrawn in cash. After recovery of such huge amount in the locker, Syed Munna attempted to justify the possession by claiming it to be income through chits (Committee) and sale of chappals by procuring false purchase bills. On verification, such claims of Syed Munna found to be false, it is revealed that Syed Munna was running a small footwear shop under the name of "Paragon Footwear" at Pulivendula with the earning of Rs. 200-300 daily. The GST details collected from Tax Authorities reveal that he had filed GST returns only for the period 03.11.2017 to 31.03.2018 for a total turnover of Rs. 4,48,400/- with tax liability of Rs. 4484. Further, the facts relating to income through chits have also not been substantiated, as the entire cash amount recovered from the locker was having same kind of cash slips of Kotak Mahindra Bank indicating single source of entire cash amount.

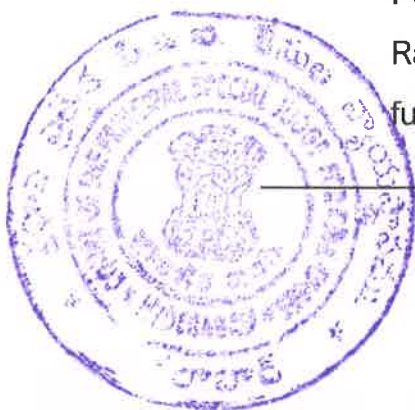
- 16.43.** Investigation further revealed that in furtherance of criminal conspiracy to execute the murder, Yadati Sunil Yadav (**A-2**) and Gajjala Uma Shankar Reddy (**A-3**), killed the dog 'Jimmy' living at the house of Shri Y. S. Vivekananda Reddy by running over it by the Honda Amaze Car No. AP04BF8982 used by Gajjala Uma Shankar Reddy (**A-3**), as the dog could have caused hindrance at the time of execution of murder. In this regard, B. Rangana, Watchman, Ragiri Lakshmi Devi (House help), P.



Rajshekhar (Caretaker) and C. K. Srinivasulu, Municipality worker have confirmed the disposal of the dead body of the said dog in the end of February, 2019 i.e., around 15 days before the incident of murder of Shri Y.S. Vivekananda Reddy.

**16.44.** It is further revealed that after killing the dog, accused persons got an opportunity to execute their plan in the second week of March, 2019 when Smt. Y. S. Sowbhagamma (**wife of the deceased**) had proceeded for Hyderabad on 12.03.2019 to attend a family function organised on the occasion of first birthday celebration of granddaughter of Shri N. Siva Prakash Reddy (**brother of Smt. Y. S. Sowbhagamma**) at Hyderabad on 15.03.2019. In this function, all the family members including Shri Y. S. Vivekananda Reddy, his wife Smt. Y. S. Sowbhagamma and close friends were also invited. Though, initially Shri Y. S. Vivekananda Reddy had also intended to join the said function, however he dropped the plan on being insisted by accused T. Gangi Reddy (**A-1**) and Gajjala Uma Shankar Reddy (**A-3**) who convinced him by assuring that they were likely to receive huge amount very soon. Therefore, Shri Y. S. Vivekananda Reddy stayed back at his residence at Pulivendula.

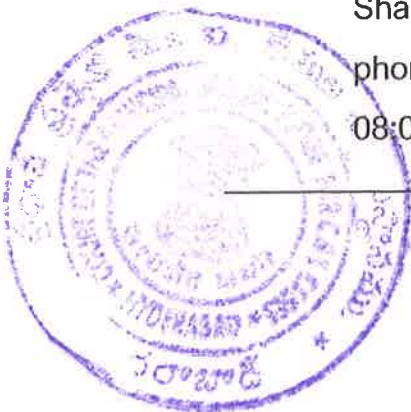
**16.45.** Investigation on the said aspect further revealed that in the said family function, Shri N. Siva Prakash Reddy apart from his family members, had also invited two of his close friends from Pulivendula namely **(1)** Shri Raja Reddy @ Moramreddy Rajareddy and **(2)** T. Gangi Reddy (**A-1**). However, the said function was attended only by Raja Reddy, whereas, T. Gangi





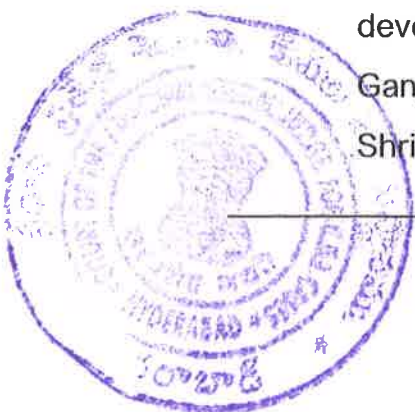
Reddy (A-1) informed Shri Raja Reddy that due to some important work he was not able to join the function at Hyderabad. On this aspect, Shri N. Siva Prakash Reddy stated that though T. Gangi Reddy (A-1) had agreed to join the function on 12.03.2019, however he did not inform his non-attendance in the function on 15.03.2019. He was surprised as to why T. Gangi Reddy (A-1) did not join the function without informing him, which he regularly used to attend on earlier occasions. Shri Moramreddy Rajareddy confirmed the said facts and also stated about the change in the behavior of Y. Gangi Reddy (A-1), suspected involvement in the offence and his close relationship with D. Siva Shankar Reddy (A-5) and Y.S. Avinash Reddy (A-8) after the incident of murder of Y.S. Vivekananda Reddy.

- 16.46.** It is further revealed that before executing the plan to commit murder of Y.S. Vivekananda Reddy, as disclosed by Shaik Dasthagiri (A-4 turned approver) the accused persons had conducted recce to enter in the house of Y.S. Vivekananda Reddy. As per the forensic expert opinion on Google Takeout recovered from the email id ([sunilyadavyadati@gmail.com](mailto:sunilyadavyadati@gmail.com)) of Yadati Sunil Yadav (A-2), it is revealed that location of his mobile phone was just outside the house of Y.S. Bhaskar Reddy (A-7) and Y.S. Avinash Reddy (A-8) at 00:08 hrs in the intervening night of 13/14.03.2019. Further, as per Google Takeout of email id ([d.shankarreddy1967@gmail.com](mailto:d.shankarreddy1967@gmail.com)) belonging to D. Siva Shankar Reddy (A-5), it is revealed that location of his mobile phone was inside house premises of Y.S. Vivekananda Reddy at 08:08 AM on 13.03.2019. It is revealed that during the aforesaid



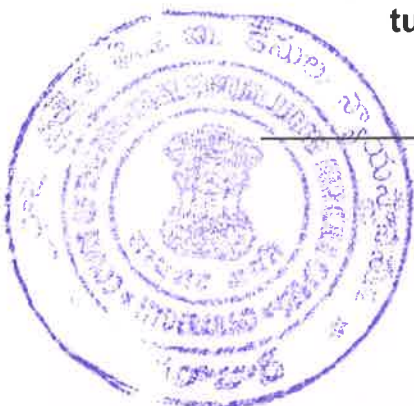
time, Y.S. Vivekananda Reddy was not available at his house in Pulivendula. As per the CDR of mobile phone (9440282789) of Y.S. Vivekananda Reddy, he was at Kadapa approximately 75 Kms away from Pulivendula and he reached Pulivendula at around 10:00 AM on 13.03.2019 from Hyderabad. It is also revealed that Y.S. Vivekananda Reddy was not in good terms with D. Siva Sankar Reddy (**A-5**) due to the criminal antecedent of D. Siva Sankar Reddy (**A-5**). The CDR analysis of Y. S. Vivekananda Reddy reveals that there was no telephonic exchange between Y.S. Vivekananda Reddy (9440282789) and D. Siva Shankar Reddy (**A-5**) on his both mobile phone numbers 9440203852 and 8008349666 from the period 01.05.2018 to 14.03.2019.

- 16.47.** It is further revealed that when Smt. Y. S. Sowbhagyamma (**wife of Y. S. Vivekananda Reddy**) proceeded for Hyderabad on 12.03.2019, she also permitted her house help namely Shri Pendanti Rajshekhar to avail leave to visit Kanipakam temple as per his request. She also gave Rs 5000 to him through Shri M. V. Krishna Reddy (**PA of the deceased**). Pendanti Rajashekhar was working with Sh. YS Vivekananda since year 2014 and he use to look after the agriculture as well as routine work of YS Vivekananda Reddy and used to stay at the house of Y.S. Vivekananda Reddy. He left for Kanipakam in the morning of 13.03.2019. Since, T. Gangi Reddy (**A-1**) was aware of these developments, therefore in furtherance of the conspiracy T. Gangi Reddy (**A-1**) enquired to confirm the non-availability of Shri P. Rajshekhar on 14/15.03.2019 from B. Ranganna (**house**



**watchman).** However, B. Ranganna since was not aware of the date of return of P. Rajshekhar, therefore, he could not confirm. Therefore, T. Gangi Reddy (**A-1**) in order to ascertain the non-availability of P. Rajshekhar on 14/15.03.2019, called P. Rajshekhar at 12.46 PM on 14.03.2019 through the mobile phone (7997456298) of B. Ranganna keeping the phone on speaker mode and telling B. Ranganna to enquire from P. Rajshekhar regarding the date on which P. Rajshekhar will be coming back to work. During conversation, P. Rajshekhar informed that he would return in the morning of 15.03.2019. Sh. P. Rajshekhar further revealed that M. V. Krishna Reddy had also called him on 14.03.2019 in the evening and enquired about his plan of return. The CDR of mobile phone (9573508123) of M.V. Krishna Reddy reveals that he had called P. Rajshekhar (8897351429) at 17:13:57 (45 seconds) on 14.03.2019. Thus, the accused persons found it convenient to execute their plan to commit murder of Y.S. Vivekananda Reddy in the intervening night of 14 -15.03.2019.

- 16.48.** It is further revealed that in furtherance of conspiracy for execution of murder, Yadati Sunil Yadav (**A-2**) asked Shaik Dasthagiri (**A-4 turned approver**) to arrange an axe (**Goddali**). Accordingly, Shaik Dasthagiri (**A-4 turned approver**) purchased an axe from Kadiri, a town located around 35 kms away from Pulivendula as nobody could have noticed the purchase of axe. While going to Kadiri, Shaik Dasthagiri (**A-4 turned approver**) was accompanied by one of his relatives



namely Sh. Sayyed Hafizullah and visited a Hardware shop owned by one Sh. Karmala Krishnama Chari and purchased an axe in Rs. 450 in the evening of 14.03.2019. However, while Shaik Dasthagiri (**A-4 turned approver**) visited the shop, Shri Sayyed Hafizullah had gone to attend prayer at a nearby Mosque. Thereafter, both returned to Pulivendula. It is revealed that though Shri Sayyed Hafizullah had accompanied Shaik Dasthagiri (**A-4 turned approver**) for Kadiri, however he was not aware about the purchase of axe, instead Shaik Dasthagiri (**A-4 turned approver**) told him that he had visited the Hardware shop to purchase horse/ox shoe nails. During investigation the shop owner, Sh. Karmala Krishnama Chari in his 164 Cr. PC statement has confirmed the purchase of axe by Shaik Dasthagiri (**A-4 turned approver**). Further, Shri Sayyed Hafizullah has also confirmed accompanying Shaik Dasthagiri (**A-4 turned approver**) on 14.03.2019 while visiting Kadiri.

- 16.49.** Investigation revealed that on 14.03.2019 afternoon onwards, T. Gangi Reddy @ Y Gangi Reddy (**A-1**) was with Shri Y. S. Vivekananda Reddy, who had gone for campaigning at Mydukur Assembly constituency. Therefrom, T. Gangi Reddy @ Y Gangi Reddy (**A-1**) made two calls from his phone (9440281444) to Yadati Sunil Yadav (**A-2**) (9182183922) at 18.22.14 hrs and 18.22.58 hrs. As per forensic analysis of the Google take out of Yadati Sunil Yadav (**A-2**), extracted from his Google account linked with his email i.d. sunilyadavyadati@gmail.com, at this time (between 18.14 hrs to 18.33 hrs on 14.03.2019) Yadati Sunil Yadav was present inside the house of Y.S. Bhaskar





Reddy (A-7) / Y.S. Avinash Reddy (A-8) and was waiting for the arrival of Shaik Dasthagiri (A-4 turned approver), who had gone to Kadiri for purchase of axe (weapon of offence). In between, Yadati Sunil Yadav (A-2) enquired from Shaik Dasthagiri (A-4 turned approver), as to what time he will be reaching at Pulivendula. The messages exchanged between both reveals that at 07.10.01 PM, when Shaik Dasthagiri started from Kadiri, he sent a message to Yadati Sunil Yadav (9182183922). On this, Yadati Sunil Yadav (A-2) replied to Shaik Dasthagiri (A-4 turned approver), that he is waiting for him. It is further revealed that in the meantime, Gajjala Uday Kumar Reddy (A-6), had also visited the house of Y. S. Bhaskar Reddy (A-7) / Y.S. Avinash Reddy (A-8) at 18.53 hrs and remained present till 20.07 hrs on 14.03.2019. As per CDR analysis, Y. S. Avinash Reddy (A-8) after carrying out campaigning at Jammalamadugu, reached Pulivendula at around 18:45 hrs and D. Siva Shankar Reddy (A-5) had also reached at Pulivendula at 07:15 PM. It is further revealed that D. Siva Shankar Reddy (A-5) (9440203852) after reaching at Pulivendula made a call to T. Gangi Reddy (A-1) at 19:58:29 pm (153 seconds) who by that time had not reached Pulivendula and was with Shri Y. S. Vivekananda Reddy. Thereafter, most of the time, both (Y. S. Avinash Reddy and D Siva Shankar Reddy) were remained connected with same tower ID located in Pulivendula before, during and after the murder of Shri Y. S. Vivekananda Reddy and also during the destruction of evidence at the Scene of Crime in the morning of 15.03.2019.

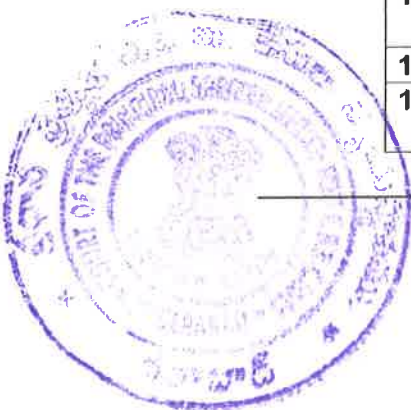


**16.50.** It is further revealed that Shaik Dasthagiri (**A-4 turned approver**), reached Pulivendula at around 20.30 hrs. from Kadiri and met Yadati Sunil Yadav (**A-2**), who was waiting for him. In the meantime, Y. S. Bhaskar Reddy (**A-7**) made himself incommunicado on his both mobile phone numbers 9440203750 (prominently used number) and 9502771232. The last call on SIM number 9440203750 was made at 20:21:47 hrs. on 14.03.2019, and thereafter next call was made at 09:40:24 on 16.03.2019, whereas on SIM number 9502771232, last call was made at 20:13:02 PM on 14.03.2019 and next call was made at 07:35:31 AM on 15.03.2019 (During this period no call or SMS has been received on both mobile phone numbers, which indicate that the phones were switched off). In between, Yadati Sunil Yadav (**A-2**) had visited the place of residence of Y. S. Bhaskar Reddy (**A-7**) / Y.S. Avinash Reddy (**A-8**) besides visiting other places of relevance in the commission of offence. As per Forensic Expert Opinion of CFSL, New Delhi dated 22.11.2022 based on the data extracted from the Google Take Out of Yadati Sunil Yadav (**A-2**) the locations of mobile phone of Yadati Sunil Yadav (**A-2**) in the intervening night of 14-15.03.2019 were as such:

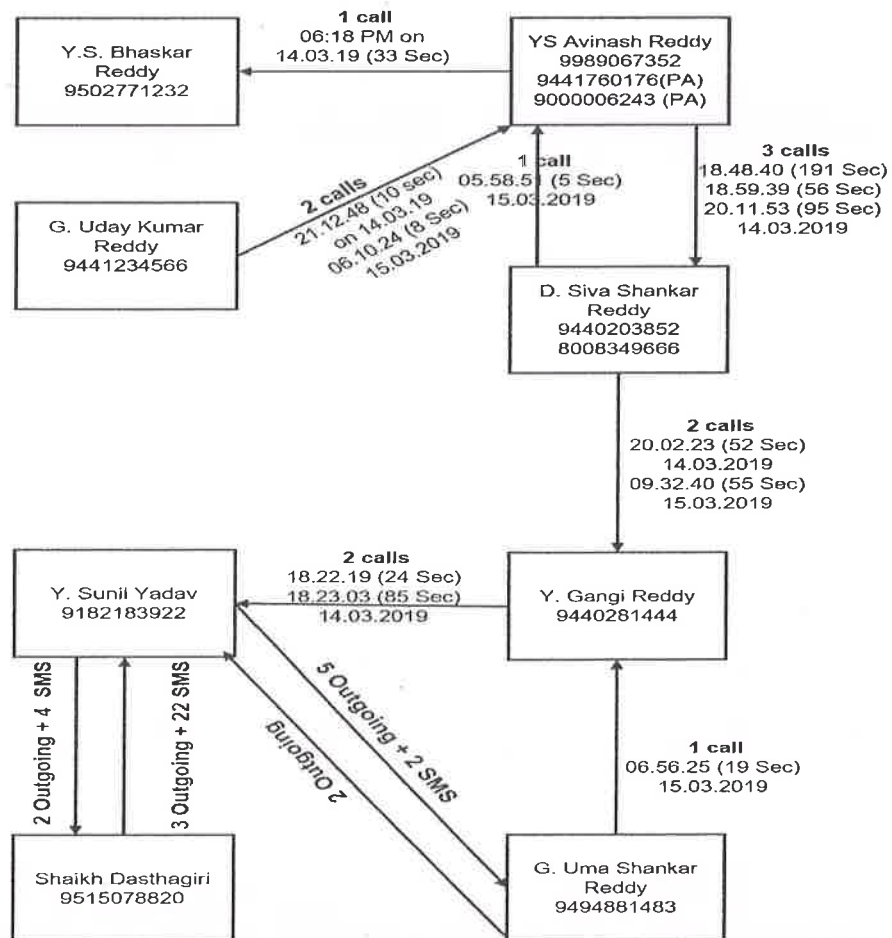

16.51. It is further revealed that accused Yadati Sunil Yadav (A-2) was also in frequent contact with T. Gangi Reddy (A-1), Gajjala Uma Shankar Reddy (A-3) and Shaik Dasthagiri (A-4 turned approver) over mobile phone and exchanged several messages with them. Further, T. Gangi Reddy (A-1) and Gajjala Uday Kumar Reddy were found in contact of accused D. Siva Shankar Reddy (A-5). D. Siva Shankar Reddy (A-5) was also found in frequent contact with accused Y. S. Avinash Reddy (A-8) and Y. S. Bhaskar Reddy (A-7). The telephonic exchange among the accused persons between the period 06:00 PM on 14.03.2019 to 08.00 AM on 15.03.2019 has been depicted in the following chart.



## EXECUTION OF MURDER

**16.52.** It is revealed that on 14.03.2019, Shri Y. S. Vivekananda Reddy had left his house at Pulivendula in the afternoon for political campaigning at Mydukur Assembly Constituency for Raghu Rami Reddy, MLA. While going to Mydukur, T. Gangi Reddy (A-1) also accompanied him, further T. Gangi Reddy (A-1) had also called another person namely Sh. B. Ravindra Reddy @ Ravi Kumar Reddy, at around 14:45 hrs and asked him to meet near Mallela Bus Stand to accompany them. Accordingly, they picked up Sh. B. Ravindra Reddy @ Ravi Kumar Reddy from Mallela Bus stand and reached Mydukur at around 04:45 PM, where MLA Mydukur Sh. Raghu Rami Reddy along with his followers also joined in door-to-door campaigning for him. After campaigning for 1-1:30 hours, they left Mydukur and went Chinnavardayapalli and campaign for around 30 minutes. Thereafter, they visited the office of Ms. Alle Prabhavati, an independent MLA candidate and asked her to support YSRCP in the upcoming elections. After campaigning, while returning to Pulivendula, they dropped Sh. B. Ravindra Reddy @ Ravi Kumar Reddy at Mallela Bus Stand at around 10:00-10:30 PM on 14.03.2019. Whereas, T. Gangi Reddy (A-1) get off from the vehicle of Y. S. Vivekananda Reddy near his house at Pulivendula. Y. S. Vivekananda Reddy reached at his home along with his driver namely Sh. Neeruguttu Prasad at around 23:25 hrs. on 14.03.2019. As per the video footage of CCTV camera installed at Bridgestone Shop, the vehicle of Shri Y. S. Vivekananda Reddy is seen at 23:24:42 PM on 14.03.2019



which is approximately 200 meters away from the residence of YS Vivekananda Reddy. Therefrom after about 10 minutes, Driver Prasad left for his home after informing Shri B. Rangana, watchman of the house.

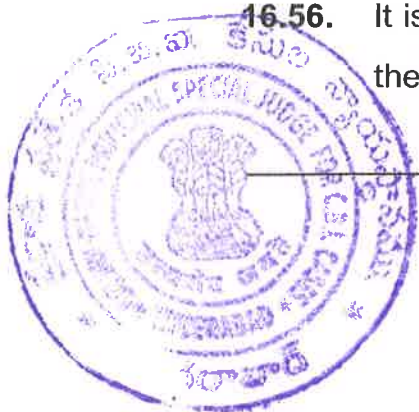
**16.53.** It is further revealed that in furtherance of conspiracy, in the evening of 14.03.2019, accused Yadati Sunil Yadav **(A-2)** and Shaik Dasthagiri **(A-4 turned approver)** stayed at a place near the house of Shri Y. S. Vivekananda Reddy and were waiting for his arrival. As disclosed by Shaik Dasthagiri **(A-4 turned approver)**, while they were waiting at the said place, Yadati Sunil Yadav **(A-2)** had brought liquor from one Gorla Bharat Yadav which they consumed during the period in between around 09 PM on 14.03.2019 to 01.30 AM on 15.03.2019. In the meantime, Gajjala Uma Shankar Reddy **(A-3)** also joined them at around 11.50 PM. As per forensic expert opinion of CFSL, New Delhi the location of mobile phone of Yadati Sunil Yadav **(A-2)** has been found available at the place of drinking alcohol between 08.04 pm to 11.06 pm on 14.03.2019. It is revealed that Yadati Sunil Yadav **(A-2)** had sent an SMS to Gajjala Uma Shankar Reddy **(A-3)** at 11:06:03 PM on 14.03.2019. Further the Google Takeout of Yadati Sunil Yadav **(A-2)** reveals that in between he had also visited the house of Y. S. Avinash Reddy **(A-8)** / Y. S. Bhaskar Reddy **(A-7)** at 09.39 pm to 09.58 pm on 14.03.2019.

**16.54.** It is further revealed that the arrival of vehicle of Shri Y. S. Vivekananda Reddy at the main gate of the house at around

23.30 hrs, was noticed by Yadati Sunil Yadav **(A-2)** and Shaik Dasthagiri **(A-4 turned approver)** who were keeping a watch on his arrival while taking liquor. Thereafter as per plan, T. Gangi Reddy **(A-1)** accompanied by Gajjala Uma Shankar Reddy **(A-3)** on his bike, reached at the house of Sh. Y. S. Vivekananda Reddy and went inside the house through the main gate at around 23.45 PM. His friendly entry was seen by Shri B. Ranganna **(Watchman of the house)**. Whereas, Gajjala Uma Shankar Reddy **(A-3)** after dropping T. Gangi Reddy **(A-1)** at the main gate of the house of Y.S. Vivekananda Reddy, joined other 02 accused and remained with them.

**16.55.** It is further revealed that after entering in the house, T. Gangi Reddy **(A-1)** engaged Shri Y. S. Vivekananda Reddy in conversation. While T. Gangi Reddy **(A-1)** was inside the house, at around 12.30 AM on 15.03.2019, Shri Y. S. Vivekananda Reddy came out in the Verandah area to smoke a cigarette, where watchman B. Ranganna was sitting. On seeing B. Ranganna awake, Shri Y. S. Vivekananda Reddy asked him as to why he did not sleep, on this B. Ranganna replied that he will lock the main gate after leaving of T. Gangi Reddy @ Y Gangi Reddy **(A-1)**. However, Shri Y. S. Vivekananda Reddy told him that T. Gangi Reddy **(A-1)** will be staying in the house during night, therefore, he need not to wait and go for sleep. Accordingly, B. Ranganna slept in the Verandah of the house.

**16.56.** It is further revealed that while T. Gangi Reddy **(A-1)** was inside the house of Y.S. Vivekananda Reddy, other three accused

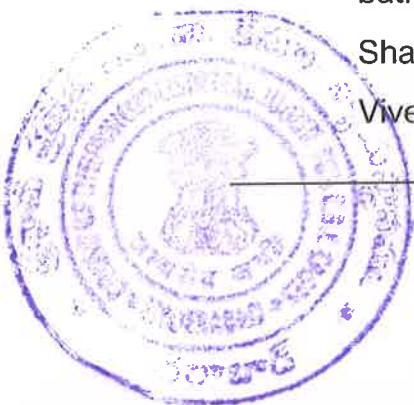


persons namely Yadati Sunil Yadav (A-2), Gajjala Uma Shankar Reddy (A-3) and Shaik Dasthagiri (A-4, **turned approver**) reached rear side road of the house of Sh. Y. S. Vivekananda Reddy on the bike of Gajjala Uma Shankar Reddy (A-3) at around 01.30 AM on 15.03.2019. Therefrom, all 03 entered in the compound of the house of Sh. Y. S. Vivekananda Reddy after scaling the boundary wall, where Shaik Dasthagiri (A-4, **turned approver**) noticed presence of B. Ranganna, who was sleeping in the Verandah near the main gate of the house. Therefore, they knocked the side door of the house, on which T. Gangi Reddy (A-1) opened the side door and facilitated the entry of other three accused Yadati Sunil Yadav (A-2), Gajjala Uma Shankar Reddy (A-3) and Shaik Dasthagiri (A-4, **turned approver**), inside the house.

- 16.57. It is revealed that as per statement of Shaik Dasthagiri (A-4, **turned approver**), on seeing the entry of aforesaid three accused persons inside his drawing room, Sh. Y.S. Vivekananda Reddy asked them **"what are they doing here at this hour"**, on which T. Gangi Reddy (A-1) replied that **"Sir they have come to discuss regarding the money settlement"**. On this, YS Vivekananda Reddy told them that **"I have been telling you (Gangi Reddy) several times, in spite of that you are asking the settlement money, if I want then I would have given you. MP elections are also coming up, if we invest and win then we will get more. Then he said that if you want, I will give you."** On this Gangi Reddy said that **"I want now."** Further Uma Shankar said that **"You have never helped us then why**

should we leave our money.” Immediately thereafter, taking pretext of a heated verbal exchange, Yadati Sunil Yadav (A-2) abused and kicked Shri Y. S. Vivekananda Reddy due to which he fell down. After this, Gajjala Uma Shankar Reddy (A-3) asked Shaik Dasthagiri (A-4, turned approver) to bring the axe which Shaik Dasthagiri (A-4, turned approver) had purchased and was carrying with him as per plan. Thus, Shaik Dasthagiri (A-4, approver) handed over the axe to Uma Shankar Reddy (A-3) who hit on the forehead of Shri Y. S. Vivekananda Reddy by the axe. Simultaneously, co-assailant Yadati Sunil Yadav (A-2) hit 7-8 times on the chest of Shri Y. S. Vivekananda Reddy after abusing him. Thereafter, all 04 accused tortured Shri Y. S. Vivekananda Reddy and forced him to write a false note mentioning that his driver Prasad had beaten him badly and he should not be spared. During investigation the experts have opined that the said letter was written in the handwriting of Sh. Y.S. Vivekananda Reddy. Further, after examination of the said letter, CFSL, New Delhi vide report dated 10.01.2022 has opined that the said letter was written by YS Vivekananda Reddy under mental condition of extreme duress.

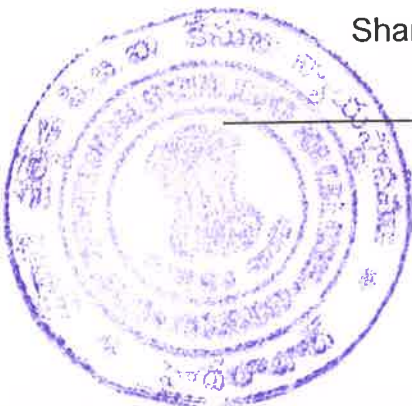
16.58. On the said aspect, Shaik Dasthagiri (A-4, turned approver) further revealed that after forcing Shri Y.S. Vivekananda Reddy to write the said letter to falsely implicate Driver Prasad, all the accused lifted Shri Y. S. Vivekananda Reddy and took him in the bathroom in order to kill him, where accused Gajjala Uma Shankar Reddy (A-3) again hit on the head of Shri Y.S. Vivekananda Reddy with axe 7-8 times in order to ensure his



death. During investigation the forensic medicine experts have confirmed that injuries inflicted on the body Shri Y.S. Vivekananda Reddy were possible to be caused by a weapon like 'Axe'. Further, Post-mortem examination has confirmed that death of Shri Y. S. Vivekananda Reddy was caused by the haemorrhage shock and injury to the vital organ i. e. brain.

**16.59.** Shaik Dasthagiri (**A-4, turned approver**) further revealed that after committing murder of YS Vivekananda Reddy, T. Gangi Reddy (**A-1**), Yadati Sunil Yadav (**A-2**) and Gajjala Uma Shankar Reddy also searched some documents and they also tried to break open the almirah. However, they could only break the handle of almirah and left it because of causing it a loud sound. Thereafter, T. Gangi Reddy (**A-1**) collected some documents, while leaving the house of Y. S. Vivekananda Reddy. As per the disclosure statement dated 07.08.2021 of Yadati Sunil Yadav the documents collected by T. Gangi Reddy (**A-1**) appeared to be related to some land agreements. Accordingly, in order to trace out the documents, a search was conducted at the house of T. Gangi Reddy (**A-1**) on 11.08.2021 in which several original as well as photocopied property related documents bearing round seals have been recovered but none of these documents recovered were found to be related to YS Vivekananda Reddy.

**16.60.** Shaik Dasthagiri (**A-4, turned approver**) further revealed that after committing murder of Shri Y.S. Vivekananda Reddy, 03 accused persons namely Yadati Sunil Yadav (**A-2**), Gajjala Uma Shankar Reddy (**A-3**) and he himself came out of the house and





escaped by scaling the backside compound wall. As per 164 Cr. PC statement of Shaik Dasthagiri **(A-4, turned approver)** after scaling the boundary wall, he had handed over the "Axe" to Yadati Sunil Yadav **(A-2)**. Thereafter, all three parted in different directions for their respective places. As per disclosure statement dated 07.08.2021 of Yadati Sunil Yadav **(A-2)** he had thrown the weapon of offence i.e. "axe" in a Nala **(drainage)** near Vasvi Kalyan Mandapam, Pulivendula. During investigation efforts were made to trace the weapon of offence from the said Nala, however same could not be recovered. In this regard a detailed memorandum of proceedings was prepared in the presence of CFSL team as well as independent witnesses on 09.08.2021.

- 16.61.** It is further revealed that after a little while, 03 assailants escaped from the house, T. Gangi Reddy **(A-1)** came out from the main gate of the house, which was seen by Shri B. Rangana, watchman of the house. Shri B. Ranganna, in his 164 Cr. PC statement has revealed that while the accused persons were inside the house of Shri Y. S. Vivekananda Reddy, he got woke up from sleep due to noises coming from inside the house. Thus, he peeked through the side window of the drawing room where he saw 04 persons inside the house and they were walking from hall to the bedroom of Shri Y. S. Vivekananda Reddy as if they had lost something. He could identify three persons namely T. Gangi Reddy **(A-1)**, Yadati Sunil Yadav **(A-2)** and Shaik Dasthagiri **(A-4 turned approver)** and about 04<sup>th</sup> person he described was a tall and thin person. However, after seeing their



activity, he got scared and hid himself in the hedge near the window area of the lawn, wherefrom he saw three persons escaping from the house by scaling the compound wall. Immediately thereafter, when T. Gangi Reddy (A-1), came out of the house, he approached him to enquire as to what had happened inside and why other three persons ran away from the house. On this, T. Gangi Reddy (A-1), assaulted Shri B. Rangana, and criminally intimidated him by threatening that **“your story will end soon. He said that he will kill me. He said that he would definitely kill me and left.”** After threatening Shri B. Rangana, to not to tell anybody about the occurrence, T. Gangi Reddy (A-1), left the house of Shri Y. S. Vivekananda Reddy from main gate. Thereafter, Shri B. Rangana went inside the house and saw that Shri Y. S. Vivekananda Reddy was murdered and his dead body was lying in the pool of blood in the bathroom. Thus, he got extremely scared and did not tell anybody due to fear of T. Gangi Reddy (A-1). Shri B. Rangana further revealed that earlier he did not reveal the identity of accused persons due to fear from T. Gangi Reddy (A-1). Shri B. Rangana further revealed that T. Gangi Reddy (A-1) further threatened him in the morning at around 06:30-7:00 on 15.03.2019 to not to reveal the incident occurred in the night to anybody, otherwise he will be killed. During Test Identification Parade, B. Rangana identified Gajjala Uma Shankar Reddy (A-3) as the fourth accused person being present inside the house of Shri Y. S. Vivekananda Reddy while commission of murder in the intervening night of 14-15.03.2019.



**16.62.** During investigation from the examination of the video footage of the CCTV cameras installed at a shop namely Bridgestone **(located on Kadapa-Pulivendula main road at around 100 meters from the house of the deceased)** it is revealed that after the incident, Gajjala Uma Shankar Reddy **(A-3)** was seen running on the road at 03:15 AM on 15.03.2019. Identity of Gajjala Uma Shankar Reddy **(A-3)** in the CCTV footage has also been confirmed by the experts of Film Factory Bangalore and Directorate of Forensic Science, Gandhinagar on the basis of analysis of the "gait pattern" of Gajjala Uma Shankar Reddy **(A-3)**; besides, he has also been identified by some of the witnesses acquainted with the physical features of Gajjala Uma Shankar Reddy **(A-3)** after seeing the said CCTV footages.

**16.63.** During investigation the Google takeout of email ID ([sunilyadavyadati@gmail.com](mailto:sunilyadavyadati@gmail.com)) belonging to Yadati Sunil Yadav **(A-2)** was obtained vide memorandum dated 28/29.04.2021 and got analyzed by the Investigating Officer with the technical assistance of a Computer Programmer, wherein large number of locational data (latitude and longitude) was found available showing location of mobile phone of accused Yadati Sunil Yadav **(A-2)**. Accordingly, some of the relevant location co-ordinates of Yadati Sunil Yadav **(A-2)** relating to the house of YS Vivekananda Reddy were analyzed and it was concluded that Yadati Sunil Yadav **(A-2)** was present inside the house of YS Vivekananda Reddy at 02:42:04 Hrs., and was available near the house of deceased at 02:35:44 hrs. and 02:34:01 hrs. in the intervening night of 14/15.03.2019. However, during further



investigation, the Google takeout got forensically examined by CFSL, New Delhi wherein it was found that the said timings mentioned in the initial Chargesheet were as per the UTC timing, which is 05:30 hrs. behind the Indian Standard Time (IST). Therefore, an addition of 05:30 hrs. is required to be made to arrive at the Indian Standard Time (IST). Accordingly, the fact relating to presence of Yadati Sunil Yadav **(A-2)** inside the house of YS Vivekananda Reddy mentioned at Para No. 16.24 of the initial Charge sheet dated 26.10.2021 stands rectified and should be read as 08:12:04 hrs (IST) instead of 02:42:04 Hrs. on 15.03.2019.

- 16.64.** The forensic analysis carried out by CFSL, New Delhi dated 22.11.2022 of the Google Take Out of Yadati Sunil Yadav **(A-2)**, further reveals that the location of his mobile phone was inside the house of Y. S. Bhaskar Reddy **(A-7)** / Y. S. Avinash Reddy **(A-8)** at 01:58:36 AM on 15.03.2019. The findings of Forensic Analysis Report regarding the presence of Yadati Sunil Yadav **(A-2)** inside the house of Y.S. Bhaskar Reddy **(A-7)** / Y.S. Avinash Reddy **(A-8)** at 01:58:36 AM on 15.03.2019 substantiates the statement of Shaik Dasthagiri **(A-4, turned approver)**, that larger conspiracy for commission of murder of Shri Y. S. Vivekananda Reddy was hatched at the behest of D. Siva Shankar Reddy **(A-5)**, Y. S. Bhaskar Reddy **(A-7)** and Y. S. Avinash Reddy **(A-8)**. The extract from the Forensic Examination Report vide CASE NUMBER CFSL-2022/G-0896 is such:





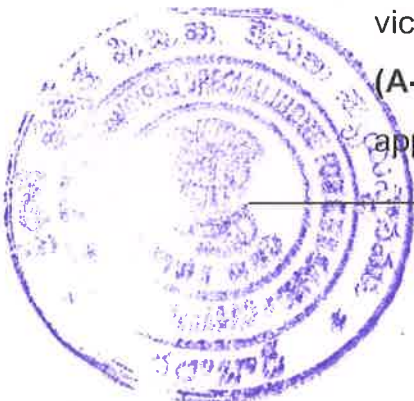

**16.65.** During investigation, available IPDRs of suspects / accused / victim got analysed wherein it was found that T. Gangi Reddy (A-1) and Y. S. Avinash Reddy (A-8) had accessed WhatsApp application in the intervening night of 14/15.03.2019. The





analysis of IPDR reveals certain similar timestamps on the WhatsApp Activity of Y. S. Avinash Reddy (A-8) on his mobile phone No. 9989067352 and Y. Gangi Reddy (A-1) on his mobile phone No. 9440281444 during the relevant period, which is as under:

**16.66.** During investigation, in order to find out the aforesaid WhatsApp activity, efforts were made to find out the same in the data extracted from the mobile phone (IMEI No. 352511084714476) used by T. Gangi Reddy (**A-1**) during the relevant period. It is revealed that local police during its investigation collected the said mobile phone of T. Gangi Reddy (**A-1**) on 15/16.03.2019 (last SMS received on 16.03.2019) and had got the data extracted from the said mobile phone vide Extraction Report dated 25.03.2019 (*extracted on 23.03.2019 by a Cyber Security expert namely Shri Syed Muzaffar Hussain*). However, after extraction, same was handed over to T. Gangi Reddy on 29/30.08.2019. During the period in between T. Gangi Reddy (**A-1**) was arrested by the local police on 28.03.2019 and he was released on default bail on 27.06.2019. The CDR of mobile number (9440281444) of Y. Gangi Reddy (**A-1**) reveals that before arrest he had received last call on 15.03.2019 at 21.28.32 hrs and on 16.03.2019 some incoming service messages were

received till 17:30:16 hrs. Thereafter, no activity is found in his CDR till 29.08.2019 except receipt of a service message on 05.08.2019.

**16.67.** During investigation the said extraction report dated 25.03.2019 of the mobile phone of T. Gangi Reddy (**A-1**) was scrutinized, wherein only logical files were found available. The WhatsApp Chat / Voice Call data and deleted data are not available in the extraction report.

**16.68.** During investigation the said mobile phone bearing IMEI No. 352511084714476 was seized by CBI from the possession of T. Gangi Reddy (**A-1**) on 06.08.2021 and its data got forensically extracted again on 06.08.2021. The scrutiny of extraction report revealed that entire data of the relevant period was wiped out by T. Gangi Reddy (**A-1**). Further, in order to recover the deleted data, the said mobile phone was also sent to C-DAC (Center for Development of Advanced Computing) Thiruvananthapuram on 03.05.2023. However, in the forensic extraction report dated 04.05.2023 provided by C-DAC, deleted WhatsApp data could not be recovered.

**16.69.** On the said aspect, the google takeout of email Id of T. Gangi Reddy (**A-1**) i.e. [gangireddy5403@gmail.com](mailto:gangireddy5403@gmail.com) , (My Activity Folder) extracted by CBI reveals that T. Gangi Reddy (**A-1**) had already installed WhatsApp Application on the said mobile phone on 19.11.2018. However, immediately after taking over possession of the mobile phone, he uninstalled the WhatsApp

Application on 30.08.2019 at 19.23.13 IST and re-installed the same on 30.08.2019 at 19.25.08 IST. Thereby wiping out the entire data. It shows that T. Gangi Reddy (**A-1**) had intentionally deleted the WhatsApp Application data of the relevant period from his mobile phone. Thus, the WhatsApp activity of his mobile phone carried out during the intervening night of 14/15.03.2019 could not be found out. Further, in order to find out the mobile phone used by Y.S. Avinash Reddy (**A-8**) during the relevant period, notice u/s 91 Cr. PC was given to him. However, he informed that he is not in possession of the two mobile devices and was not able to produce them. The IPDR analysis of other suspects / accused could not reveal any information relevant in the case.

- 16.70.** During investigation, it is revealed that Gajjala Uday Kumar Reddy (**A-6**) is a close associate of co-accused Y.S. Avinash Reddy (**A-8**), Y. S. Bhaskar Reddy (**A-7**) and D. Siva Shankar Reddy (**A-5**) and was also found involved in the conspiracy of the murder and destruction of evidence at scene of crime. As per forensic expert opinion of CFSL New Delhi dated 08.09.2022 Gajjala Uday Kumar Reddy (**A-6**) was found active in the intervening night of 14/15.03.2019, which is evident from his movement as depicted in the following chart.

**16.71.** As evident from the above chart, Gajjala Uday Kumar Reddy (A-6) was active during the entire intervening night of 14/15.03.2019 and had visited the house of Y. S. Bhaskar Reddy (A-7) / Y. S. Avinash Reddy (A-8) at 18.53 to 20.07 PM on 14.03.2019 and other relevant places. Further, between 20.09 to 21.10 PM on 14.03.2019, his location was found near the houses of other accused persons namely D. Siva Shankar Reddy (A-5) and Gajjala Uma Shankar Reddy (A-3). Further, he

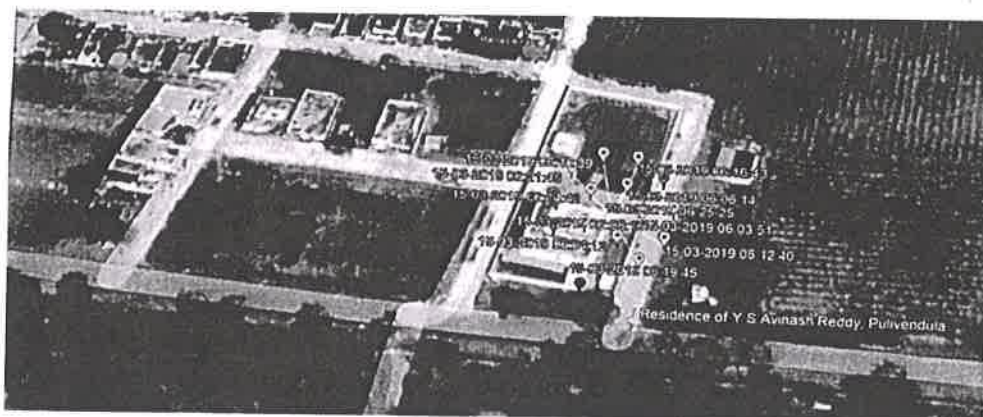




left his house in the early morning at about 03.35 am on 15.03.2019. Further, his location between 05.41 AM to 05.52 AM on 15.03.2019 has been found near the house of accused D. Siva Shankar Reddy (A-5). Thereafter, he remained inside the house of Y.S. Bhaskar Reddy (A-7) / Y.S. Avinash Reddy (A-8) between 06.03 AM to 06.25 AM on 15.03.2019.

**16.72.** Investigation on the aforesaid aspect revealed that Gajjala Uday Kumar Reddy (A-6) had left his house early in the morning after informing his mother namely Smt. Shakuntala that Shri Y. S. Vivekananda Reddy had died. In this regard, one Smt.

Prabhavati Devi (**Mother of T. Raghu Natha Reddy**) stated that her neighbour Smt. Shakuntala (**Mother of Gajjala Uday Kumar Reddy**) had told her that her son Gajjala Uday Kumar Reddy knew about the death of Y.S. Vivekananda Reddy in the morning at about 04:00 AM and he left the house early in the morning. Shri T. Raghu Natha Reddy has also corroborated the version of his mother regarding conversation between Smt. Shakuntala and Smt. Prabhavati Devi. Moreover, Smt. Prabhavati Devi had also disclosed this fact to one Shri Guduru Sivarama Krishna Reddy and his wife Smt. Uma Devi, who during investigation have also corroborated this fact. From the movement chart of Gajjala Uday Kumar Reddy, it is evident that he had left the house at around at 3.35 AM on 15.03.2019 and kept roaming in Pulivendula time till 04.01 AM on 15.03.2019, by this time no person other than the accused involved in the conspiracy (Except, Sh. B. Ranganna who did not call to any outside person or came out of the house of Sh. Y. S. Vivekananda Reddy) was aware of the death of Shri Y. S. Vivekananda Reddy. Further, his role also gets strengthened due to his involvement in the conspiracy for destruction of evidence at the Scene of Crime, as he was present at the house of Shri Y. S. Vivekananda Reddy and had facilitated in the destruction of Scene of Crime. During investigation, it was found that he had prior knowledge of the conspiracy and in order to facilitate the coordinate amongst the co-accused persons he had taken leave for 15.03.2019, the leave application was submitted on 14.03.2019 in his office.



- 16.73. During investigation, it is revealed that apart from Gajjala Uday Kumar Reddy (A-6), some other persons were also informed about the death of Sh. YS Vivekanand Reddy in the early morning of 15-03-2019 much before the information of the death of Sh. YS Vivekanand Reddy was broken out by M.V. Krishna Reddy at around 06:15 A.M to the family members and public.

### DESTRUCTION OF THE SCENE OF CRIME

- 16.74. During investigation on the aspect of destruction of scene of crime, Shaik Dasthagiri (**A-4 turned approver**) revealed that after committing murder of Shri Y. S. Vivekananda Reddy in the intervening night of 14-15.03.2019, T. Gangi Reddy (**A-1**), had called Shaik Dasthagiri (**A-4 turned approver**) and other two assailants Yadati Sunil Yadav (**A-2**) and Gajjala Uma Shankar Reddy (**A-3**) at his residence on 15.03.2019 at around 05.20 AM, where T. Gangi Reddy (**A-1**) assured them by saying that **"No need to be in tension, I have talked to Y.S. Avinash Reddy, D. Shiva Shankar Reddy. They told they will take care all. I am also going there now. I will manage. Your balance amount today evening or by tomorrow morning. I will settle"**. The CDR of Yadati Sunil Yadav (**A-2**) (9182183922) confirms that he had made a call to Shaik Dasthagiri (9515078820) at 05:05:08 AM on 15.03.2019. In this regard, one Shri Nagappa, a neighbour of T. Gangi Reddy (**A-1**) stated that he had seen T. Gangi Reddy (**A-1**) at around 05 am outside his house waiting for someone.



- 16.75. On this aspect, Shaik Dasthagiri (**A-4 turned approver**) further revealed that all 04 accused persons namely (1) T. Gangi Reddy , (2) Yadati Sunil Yadav, (3) Gajjala Uma Shankar Reddy and (4) Shaik Dasthagiri were questioned by the local police during investigation, where Shaik Dasthagiri was about to reveal the truth, however on the assurance he didn't reveal the actual facts as T. Gangi Reddy (**A-1**) had assured him stating that **"No Dasthagiri, don't tell the truth, we cleaned the murder place, no evidences. If you want, I will give you more money when we go out. I will settle your life"**. It shows that all the accused persons had deliberately conspired to destroy the evidence at the Scene of Crime after commission of murder of Shri Y.S. Vivekananda Reddy.
- 16.76. Investigation further revealed that in the early morning of 15.03.2019, accused D. Siva Shankar Reddy (**A-5**), Gajjala Uday Kumar Reddy (**A-6**) and others were already present at the house of Y. S. Bhaskar Reddy (**A-7**) / Y.S. Avinash Reddy (**A-8**) and prepared to reach at the house of Y.S. Vivekananda Reddy immediately, as soon as any formal information is received from any third person, as accused T. Gangi Reddy (**A-1**) had already spoken to them.
- 16.77. It is revealed that after the incident of murder, Sh. M. V. Krishna Reddy (**PA of the deceased Sh. Y. S. Vivekananda Reddy**) reached at the house of Shri Y. S. Vivekananda Reddy at about 05:30 AM on 15.03.2019, where he found that Shri B. Ranganna, watchman was sleeping in the Verandah of the





house. The lights of the house were still off and the doors were closed. Thereafter, Sh. M.V. Krishna Reddy started reading newspaper. After waiting for some time, Sh. M.V. Krishna Reddy made a call from his Mobile phone no. 9573508123 to Mrs. Sowbhagyamma, **(wife of Sh. YS Vivekananda Reddy)** on her mobile phone number 9703821122 at 05:58:11 hrs (53 sec.) and intimated her that Shri Y. S. Vivekananda Reddy has not woken up. On this, Mrs. Sowbhagyamma told Sh. M. V. Krishna Reddy to let him sleep as he had reached home late in the night due to election campaign. In the meantime, Smt. Yedula Laxmiamma (cook) and her son Sh. Yedula Prakash also reached at the house of Shri Y. S. Vivekananda Reddy. It was discussed between Shri M.V. Krishna Reddy and Smt. Laxmiamma that Sh. Y. S. Vivekananda Reddy may get annoyed if they did not wake up him early. Thereafter, Smt. Laxmiamma knocked at the window shade and window door of the room located in the gully side in order to wake up Shri Y. S. Vivekananda Reddy but there was no response. In the meanwhile, watchman Shri B. Ranganna also got up, and Shri M. V. Krishna Reddy told him to go inside and check whether Shri Y. S. Vivekananda Reddy had woken up. Accordingly, Shri B. Ranganna went inside and came out quickly shouting that Shri Y. S. Vivekananda Reddy is no more. Thereafter, Shri M. V. Krishna Reddy and Shri Yedula Prakash entered in the bedroom of the house where they found the dead body of Shri Y. S. Vivekananda Reddy lying in the bathroom in a pool of blood.





- 16.78.** It is revealed that after seeing the suspicious death of Sh. Y. S. Vivekananda Reddy, Sh. M.V. Krishna Reddy made a call from his mobile phone number 9573508123 to Sh. N. Raj Shekhar Reddy (**Son-in-law of the Sh. Y. S. Vivekananda Reddy**) at his mobile phone number 9966022224 at 06.15.32 AM (47 Sec.). Further, he also informed Sh. N. Siva Prakash Reddy (**Brother-in-law of the Sh. Y. S. Vivekananda Reddy**) at 06.18.26 (78 Sec.) at 9441932231 (in the name of Ms. Aruna w/o Sh. N. Siva Prakash Reddy) and at mobile number 9989092555 at 06.21.58 AM (90 sec) who were at Hyderabad that Shri Y. S. Vivekananda Reddy had died being fallen in the bathroom and blood is lying there. Further, Shri M.V. Krishna Reddy also informed to other persons namely Smt. Sowbhagyamma W/o Shri Y. S. Vivekananda Reddy, P. Raja Shekhar (**Care Taker**), Sheikh Inayatullah, Smt. Sarveshwari sister of Smt. Sowbhagyamma, Macchi Reddy Rama Subba Reddy, Babu @ Siva Ramakrishna, Narreddy Jagdeeshwar Reddy etc.
- 16.79.** Investigation further revealed that after receiving information, Sh. N. Siva Prakash Reddy made a call from his mobile phone number 9989092555 to Y. S. Avinash Reddy (**A-8**) at his mobile phone number 9989067352 at 06:26:15 AM (24 Sec.) and informed him about the death of Sh. Y. S. Vivekananda Reddy. Further, Sh. N. Siva Prakash Reddy also called Sh. Shaikh Inayatullah (**Steno of the deceased**) at mobile number 7013021452 at 06.21.30 am (16 Sec.) and instructed him to



reach at the house of Shri Y. S. Vivekananda Reddy, immediately.

**16.80.** Investigation further revealed that after receiving information, Sh. N. Raj Shekhar Reddy (9966022224) made a call to P. Rajasekhar (8897351429) at 06.19 AM. However, since Rajasekhar Reddy was not aware of the fact that P. Rajasekhar was out of the town, therefore, he did not inform P. Rajasekhar about the death of Shri Y. S. Vivekananda Reddy. Thereafter, Sh. N. Raj Shekhar Reddy made a call to driver Prasad at his mobile phone number 6300843934 at 06.21 AM who was sleeping at that time. On enquiry, driver Prasad informed Sh. N. Raj Shekhar Reddy that he had dropped Shri Y. S. Vivekananda Reddy at the house at around 11.30 PM in the night. Sh. N. Rajasekhar Reddy further called Shaikh Inayatullah (**Steno of the deceased**) at mobile number 9441502302 at 06.27.22 AM (16 Sec.) and instructed him to reach at the house of Shri Y. S. Vivekananda Reddy, immediately and report about the happening.

**16.81.** Investigation further revealed that Sh. M. V. Krishna Reddy at again made a call to Sh. N. Raj Shekhar Reddy at 06.29.04 AM (346 Seconds) informing him that he had found one letter mentioning the name of driver Prasad and he read out the contents of the letter to Shri N. Raj Shekhar Reddy. On this, Sh. N. Raj Shekhar Reddy suspected that there was some foul play and it was not a case of natural death, therefore, in order to prevent mishandling of the letter and to save driver Prasad from



public outrage, he told Shri M. V. Krishna Reddy to keep the letter in safe custody till his arrival. Thereafter, entire family including Smt. N. Suneetha Reddy (**daughter of YS Vivekananda Reddy**) and Shri Y. S. Sowbhagyamma (**wife of YS Vivekananda Reddy**) immediately left for Pulivendula by road.

- 16.82.** Investigation further revealed that while M. V. Krishna Reddy was informing the near relatives regarding death of Y.S. Vivekananda Reddy, Shri B. Rangana, cook Mrs. Yedula Laxmi Devi and her son Shri Yedula Prakash were also present at the house. In the meantime, one Smt. K. Sasikala, Ex. Counsellor and a local leader of YSRCP along with her 04 associates namely **(1)** Shri Tippiripati Sudhakar **(2)** Dr. Panuganti Chinnanna @ P Chinnanna, **(3)** Shri Guntha Chinnappa and **(4)** Shri P. Jangam Chinna Nagaeshwaraiah also visited the house of Shri Y. S. Vivekananda Reddy for a casual meeting and getting photographs clicked with him. It is further revealed that Smt. K. Sasikala and persons accompanied with her before visiting the house of Shri Y. S. Vivekananda Reddy, had also visited the house of Y. S. Avinash Reddy **(A-8)**, MP, Kadapa at around 06:00 AM and saw 20-25 persons already gathered there. Therefrom, she proceeded for the house of Shri Y. S. Vivekananda Reddy. As per her statement, when she entered inside the compound, she did not see any other person except watchman B. Ranganna, who was present in the lawn area and there was pin-drop silence. There, she knocked the main door of the house and waited for few minutes, thereafter Shri M. V.



Krishna Reddy, PA came out from the main door and enquired the purpose of their visit. On this, she expressed her intention to meet Shri Y. S. Vivekananda Reddy for taking photograph. However, Shri M.V. Krishna Reddy told her that Shri Y. S. Vivekananda Reddy had gone to Tirupati and is not available, therefore insisted them to leave the house. But seeing the slippers and vehicle of Shri Y. S. Vivekananda Reddy, she inferred that Shri M. V. Krishna Reddy was not interested in letting them to meet with Shri Y. S. Vivekananda Reddy. Immediately thereafter, she saw Shaikh Inayatullah entering in the premises and going inside the house. While they were preparing to leave the house, she saw Y. S. Avinash Reddy (A-8) along with his convoy of 3-4 vehicles reached and entered in the house of Shri Y. S. Vivekananda Reddy. With the arrival of Y.S. Avinash Reddy (A-8) and others, she hoped that Shri Y. S. Vivekananda Reddy was available inside the house and she may get a chance to meet with him. Accordingly, they waited for sometimes and thereafter she saw Y. S. Avinash Reddy (A-8) coming out of the drawing room after 3-4 minutes and he started talking on his mobile phone in the adjacent lawn of the house. After sometime, she came to know about the death of Shri Y. S. Vivekananda Reddy, therefore she also went inside the house to see Shri Y. S. Vivekananda Reddy, where she noticed presence of blood on the bed and corners of the room. Further, she saw the dead body lying in the bathroom and appeared that it was a case of murder. On this aspect, Shri Tippiripati Sudhakar, in addition has stated that after arrival, Y.

S. Avinash Reddy (A-8) and 5-6 other persons straightway entered in the house of Shri Y. S. Vivekananda Reddy and after sometime when Sasikala enquired from them, someone from inside told her that Shri Y. S. Vivekananda Reddy died due to heart attack. From the statement of Shri Tippiripati Sudhakar, it is clear that the fake story of heart attack was floated by Y. S. Avinash Reddy (A-8) and persons accompanied with him, as soon as they arrived at the house of Shri Y. S. Vivekananda Reddy and after seeing the dead body in pool of blood with grievous injuries.

- 16.83. Investigation further revealed that Shri Shaikh Inayatullah (Steno), after receiving the information from Shri N. Siva Prakash Reddy and Shri N. Raj Shekhar Reddy, immediately reached at the house of Shri Y. S. Vivekananda Reddy. While entering in the house, he saw Smt. K. Sasikala, YSRCP worker along with 3-4 other persons sitting outside the main door of the house which was closed. Thereafter, he entered in the house through side door of the house and saw Y. Prakash, Lakshmi Amma Cook, M. V. Krishna Reddy and B. Ranganna, watchman in the drawing room. He further noticed that Smt. Lakshmi Amma cook standing near the Kitchen was weeping. She informed that Shri Y. S. Vivekananda Reddy is no more. When he entered in the bedroom of Shri Y. S. Vivekananda Reddy, he saw blood on the floor and bed. He further saw the dead body of Shri Y. S. Vivekananda Reddy lying in pool of blood in the bathroom. He noticed 02 deep cut-injuries on the forehead and thus suspected it is not a case of blood vomiting rather some

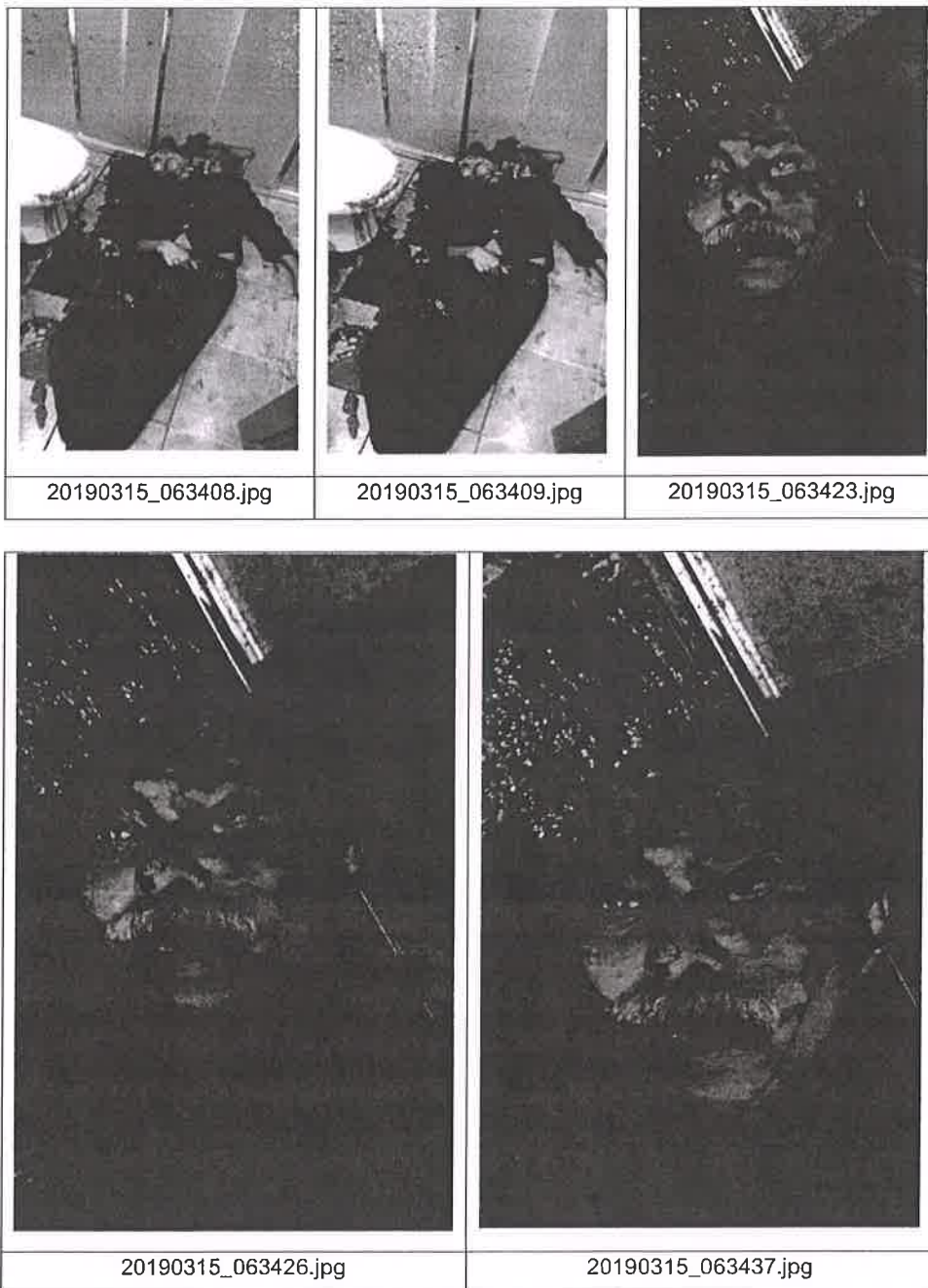


untoward incident has occurred with Shri Y. S. Vivekananda Reddy. While, he was inside the house, he saw Y. S. Avinash Reddy (A-8) MP Kadapa along with D. Siva Shankar Reddy (A-5), E.C. Surendra Reddy, Uday UCIL (Gajjala Uday Kumar Reddy (A-6), Raghava Reddy, etc. entering in the house. Thereafter, Y. S. Avinash Reddy (A-8) and D. Siva Shankar Reddy (A-5) went inside the bedroom and bathroom to see the dead body. Subsequently, other persons accompanied with Y. S. Avinash Reddy (A-8) also went inside the bedroom and bathroom to see the dead body. Thereafter, all of them went out of the bedroom and Y. S. Avinash Reddy (A-8) started discussing with D. Siva Shankar Reddy (A-5) in the lawn area.

- 16.84.** Investigation revealed that since Shaikh Inayatullah had suspected occurrence of some untoward incident with Shri Y. S. Vivekananda Reddy, he took some photographs and one small video clip covering the bedroom and bathroom where dead body of Shri Y. S. Vivekananda Reddy was lying in the pool of blood from his mobile phone. Thereafter, he sent photographs to Sh. N. Raj Shekhar Reddy and Sh. N. Siva Prakash Reddy. During investigation, mobile phone of Shaikh Inayatullah was seized by the local police. The forensic extraction report of mobile phone of Shaikh Inayatullah reveals that he had sent 05 photographs through WhatsApp to Sh. N. Raj Shekhar Reddy on **(+13133336660: Raja sir)** at 06:35:49 (UTC +5:30) and also to N. Siva Prakash Reddy on **(9989092555: NSPR 1)** at 06:37:09 (UTC+5:30), read at 07:00:24 (UTC+5:30). The Photographs sent are as such: -



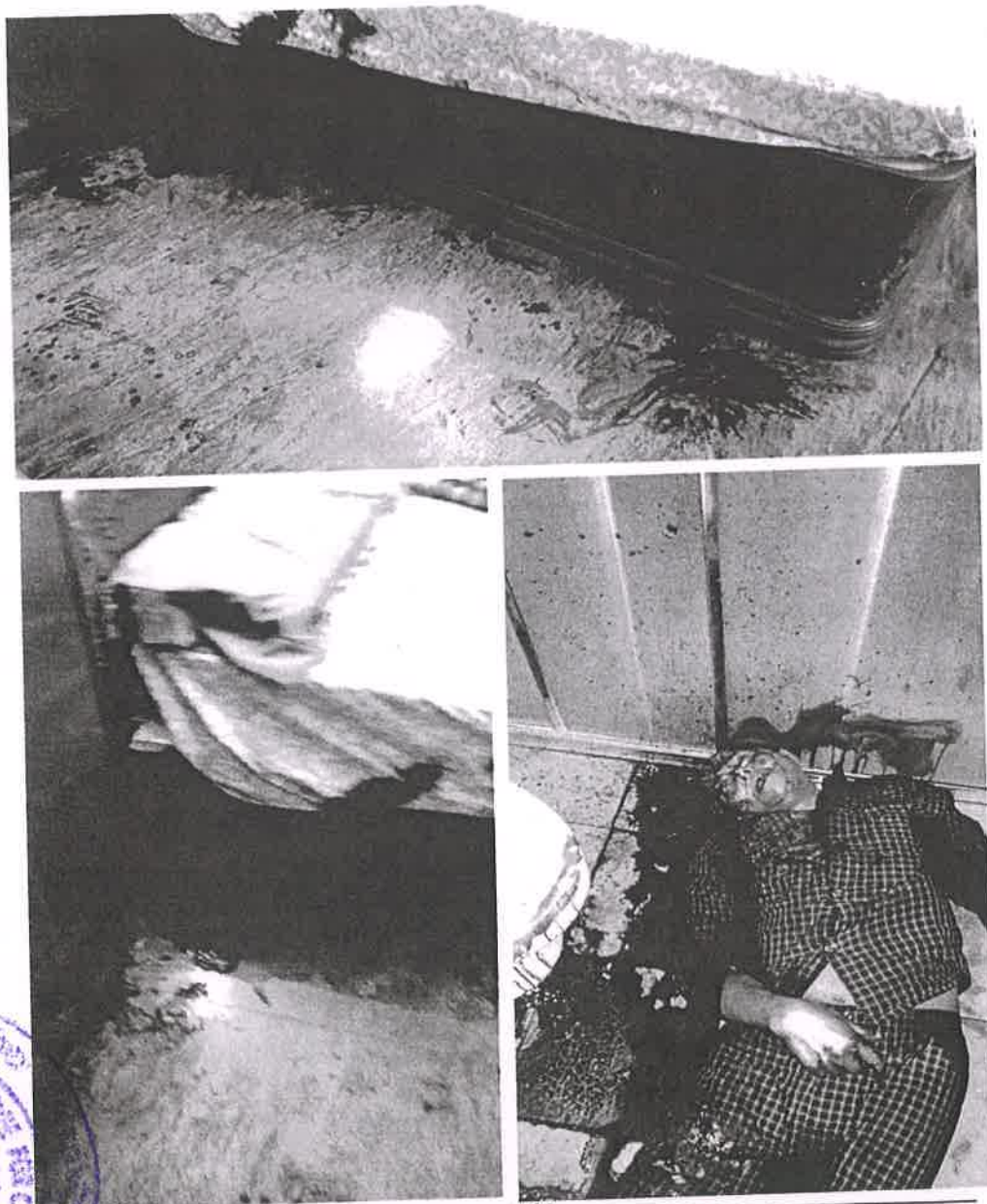

16.85. The forensic extraction report of mobile phone of Shaikh Inayatullah also reveals that Shaikh Inayatullah had also taken some other photographs and one small video clip of the SoC, which were not sent to N. Raja Sekhar Reddy or N. Siva

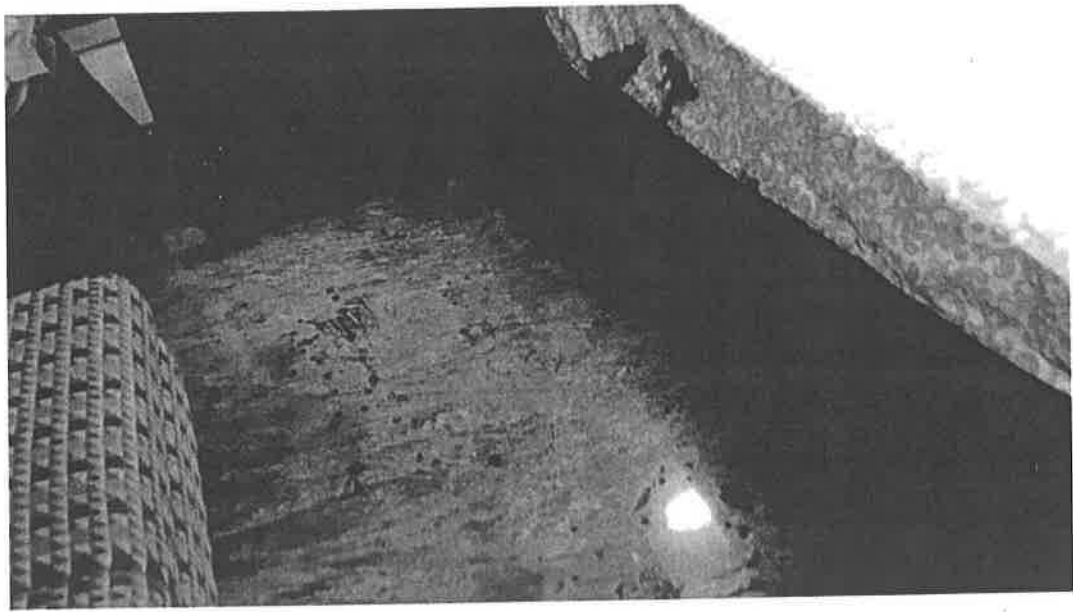


Prakash Reddy. These photographs and video clip taken by Shaikh Inayatullah before destruction of Scene of crime and recovered from his phone by the local police. In these photographs and videoclip, grievous injuries inflicted on the dead body are clearly visible and a person of ordinary prudence can easily make out that it was a case of murder as observed by different witnesses and not an incident of heart attack.

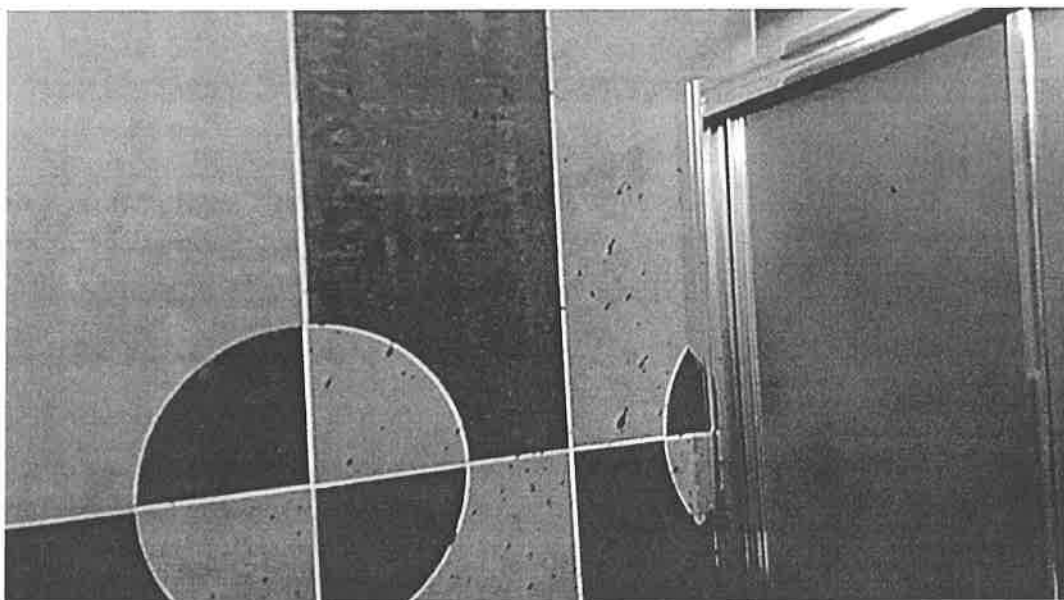

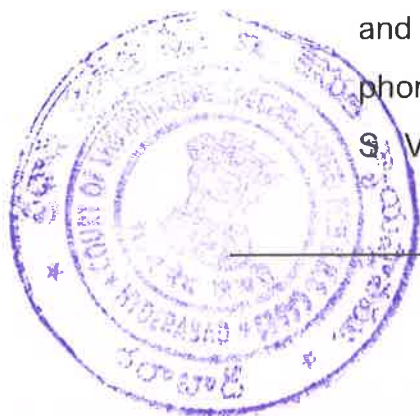

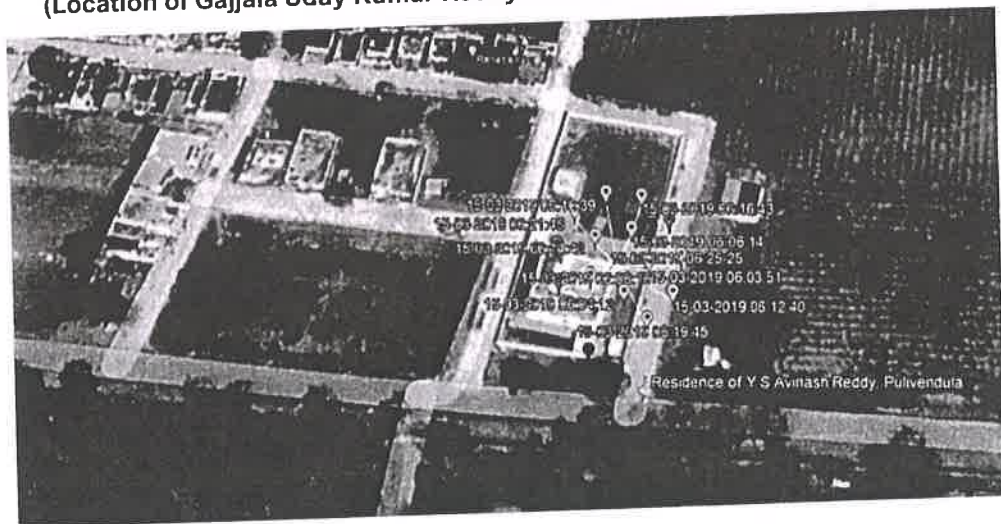
- 16.87.** Investigation revealed that as soon as Shri N. Siva Prakash Reddy called Y. S. Avinash Reddy **(A-8)** at his mobile phone number 9989067352 at 06:26:15 AM, (24 Sec.) Y. S. Avinash Reddy **(A-8)** along with D. Siva Shankar Reddy **(A-5)** Gajjala Uday Kumar Reddy **(A-6)**, E. C. Surendra Reddy, Prashanth Reddy, Chella Mali, Bandi Keshava, Raghava Reddy and Ramana Reddy **(both PAs of Y.S. Avinash Reddy)** immediately reached in 03-04 vehicles at the house of Shri Y. S. Vivekananda Reddy. The forensic analysis of Google takeout of Gajjala Uday Kumar Reddy **(A-6)** carried out by CFSL, New Delhi reveals that Gajjala Uday Kumar Reddy **(A-6)** was present at the house of Shri Y. S. Avinash Reddy **(A-8)** at 06.25.25 AM and just two minutes after at 06.27.28 AM, location of his mobile phone was found outside the main gate of the house of Shri Y. S. Vivekananda Reddy and thereafter, he was found present



inside the house of Shri Y.S. Vivekananda Reddy at 6:29 to 6:31 AM.

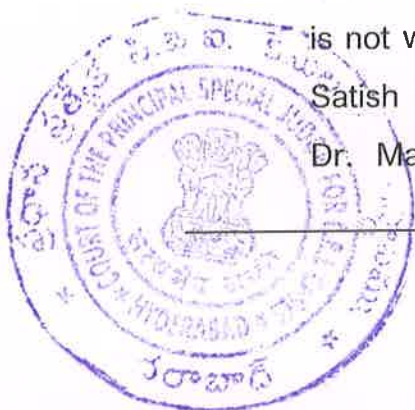

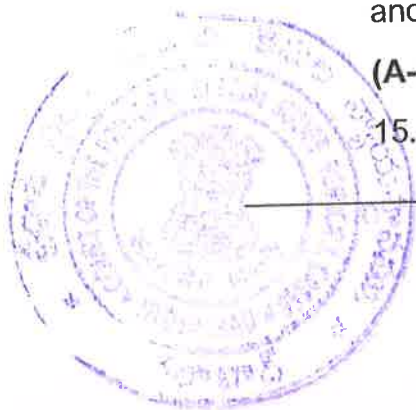
- 16.88.** Investigation on the said aspect further revealed that Gajjala Uday Kumar Reddy (A-6) immediately after reaching at the house of Shri Y. S. Vivekananda Reddy, made two calls at 06.30.13 AM (35 seconds) and 06.33.41 AM (15 seconds) from his mobile phone number 9441234566 to one Dr. Satish Reddy (9966666923) informing him that Shri Y. S. Vivekananda Reddy is not well, therefore he should reach immediately. On this, Dr. Satish Reddy informed him that he was out of town, therefore Dr. Madhu should be contacted. Further, Dr. Satish after





contacting Dr. Madhu called back to Gajjala Uday Kumar Reddy (A-6) at 6:35:55 AM (69 seconds) that Dr. Madhu was available at Dinesh Medical Centre and a vehicle should be sent for him to pick him up. Thereafter, Gajjala Uday Kumar Reddy (A-6) taking the vehicle of Prashanth Reddy, himself went at Dinesh Medical Centre and picked up Dr. Madhu along with one Casualty Nursing Staff, however immediately after reaching at the house of the deceased, they were sent back. As per forensic analysis, location of mobile phone of Gajjala Uday Kumar Reddy (A-6) at 6:35 AM was inside the EC Gangi Reddy Hospital (Dinesh Medical Centre), wherefrom he came back to the house of Shri Y. S. Vivekananda Reddy and his location at 6:39 to 6:47 was again inside the house of Shri Y. S. Vivekananda Reddy.

- 16.89.** Investigation as regards further role of Gajjala Uday Kumar Reddy (A-6), it is revealed that he along with E. C. Surendra Reddy had reached at the house of Y. S. Bhaskar Reddy (A-7) / Y.S. Avinash Reddy (A-8). The CDRs reveal that E. C. Surendra Reddy (7013568053) had called Gajjala Uday Kumar Reddy (A-6) at 05.31 AM on 15.03.2019 on his mobile number 9441234566. Thereafter, Gajjala Uday Kumar Reddy had contacted one Prashanth Reddy at his mobile number 9000055545 at 05.57 AM. As per statement of Prashanth Reddy, he accompanied by 02 other persons namely Chela Mali and Bandi Keshava reached at the house of Y.S. Bhaskar Reddy (A-7) / Y. S. Avinash Reddy (A-8) in the early morning of 15.03.2019 at around 5.45 – 6.00 AM. Whereas, E. C. Surendra



Reddy and Gajjala Uday Kumar Reddy (A-6) had also reached at the house of Y. S. Bhaskar Reddy (A-7) / Y.S. Avinash Reddy (A-8) on the motorcycle of Gajjala Uday Kumar Reddy (A-6) at around 05.45 AM. As per forensic analysis of Google takeout of Gajjala Uday Kumar Reddy (A-6) by CFSL, New Delhi, it is revealed that he was present at the residence of Y.S. Bhaskar Reddy (A-7) / Y. S. Avinash Reddy (A-8) at 06.03 to 06:25:25 am on 15.03.2019. As per the statements of EC Surendra Nath Reddy, Prashant Reddy, Bandi Keshva and Chela Mali they had reached early morning at the house of Y.S. Bhaskar Reddy (A-7) / Y. S. Avinash Reddy (A-8) for attending the political programme organised at Jammalamadugu and while they were on way to Jammalamadugu, Y.S. Avinash Reddy (A-8) received a call from Shri N. Siva Prakash Reddy after 5-7 minutes. As per statements of both PAs of Y.S. Avinash Reddy (A-8), they took U-turn near new Shri Krishna Temple on ring road and reached directly at the house Shri Y. S. Vivekananda Reddy. While going to Jammalamadugu, Y.S. Avinash Reddy (A-8), D. Shankar Reddy (A-5) and EC Surendra Reddy were in one vehicle whereas Prashant Reddy, Gajjala Uday Kumar Reddy (A-6) and 02 PAs were following them in another vehicle. However, during investigation, their version has been found false and misleading, as during investigation it was found that there was no political programme of Y.S. Avinash Reddy (A-8) at Jammalamadugu on 15.03.2019. As per forensic analysis of Google Take Out of Gajjala Uday Kumar Reddy, who had accompanied Y. S. Avinash Reddy (A-8), location of his mobile phone was found at





6.25.25 AM inside the house Y. S. Bhaskar Reddy (A-7) / Y.S. Avinash Reddy (A-8), wherefrom, he reached near the gate of the house of Y. S. Vivekananda Reddy at 6.27.28 AM and entered inside the house at 06.29.30 AM. It is further revealed that Gajjala Uday Kumar Reddy (A-6), made first call after reaching the house of Shri Y.S. Vivekananda Reddy at 06.30.13 AM to Dr. Satish Reddy. Moreover, Shri Ram Chandra Reddy, a political functionary who was supposed to join YSRCP on 15.03.2019 has stated that on 15.03.2019 a programme of YSRCP was scheduled at 1000 Hrs. at Kadiri in which Shri YS Vivekananda Reddy, YS Bhaskar Reddy (A-7), YS Avinash Reddy (A-8) and YS Konda Reddy were invited to be present among the main leaders at Kadiri and food for around 4000 persons had been cooked in the night of 14.03.2019. As per his statement, Jammalamadugu is located at about 100 kms away from Kadiri in opposite direction from Pulivendula.

- 16.90.** Investigation further revealed that Y. S. Avinash Reddy (A-8) along with persons accompanied (D. Siva Shankar Reddy (A-5), Gajjala Uday Kumar Reddy (A-6), Ramana Reddy PA, Raghava Reddy PA, E. C. Surendra Reddy etc.) after entering in the house of Shri Y. S. Vivekananda Reddy had seen the blood present in the bedroom and dead body lying in pool of blood in the bathroom with visible gruesome injuries on the head as seen in the photographs affixed above. Thereafter, he made a call from his mobile no. 9989067352 to one mobile phone number 9000266234 at 06.32.05 AM (351 seconds), further made another 02 calls at the said mobile phone at 06:40:33 &

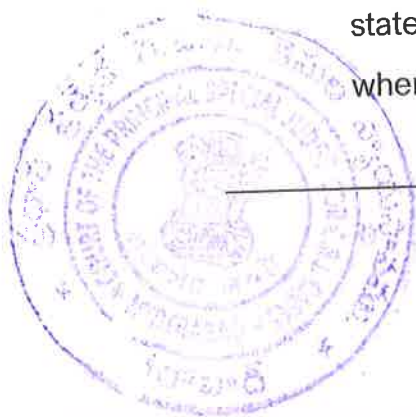


06:41:41 AM. Thereafter, Y. S. Avinash Reddy **(A-8)** using mobile phone number (9000006243) of his PA Raghava Reddy, made a call to Shri J. Shankaraiah, (9121100544) then Circle Inspector, Pulivendula at 06:44:16 AM (159 Sec.) and informed him that Shri Y. S. Vivekananda Reddy had died due to heart attack and heavy blood vomiting, which is present at bedroom and bathroom. He further told Shri J. Shankaraiah to send 3-4 constables for Bandobast. It is evident that Y.S. Avinash Reddy **(A-8)** had called Police after seeing the dead body of Shri Y. S. Vivekananda Reddy and discussing the matter with D. Siva Shankar Reddy. It shows that the fake story of heart attack and blood vomiting was floated in a pre-meditated manner to give it a colour of natural death as a part of conspiracy. During investigation it was found that Sh. Rahul Dev Sharma, then SP, Kadapa was also informed by J. Shankaraiah wherein Sh. Shankaraiah had informed SP that he had got information from Y. S. Avinash Reddy **(A-8)** regarding death of Y. S. Vivekananda Reddy due to heart attack. Subsequently, during a press briefing Sh. Rahul Dev Sharma, SP narrated the said fact CI had informed him that Y. S. Vivekananda Reddy died due to heart attack as per information received from Y.S. Avinash Reddy **(A-8)** through the mobile phone of his PA.

- 16.91. It is further revealed that in pursuance of conspiracy, accused D. Siva Shankar Reddy **(A-5)** had also reached at the house of Y.S. Avinash Reddy in the early morning and accompanied by them to the house of Y.S. Vivekananda Reddy. The analysis of google takeout of email id of D. Siva Shankar Reddy **(A-5)** i.e.



d.shankarreddy1967@gmail.com reveals that at 6:28 AM on 15.03.2019 his location was inside the house of Y.S. Vivekananda Reddy. D. Siva Shankar Reddy (A-5) (9440203852) had called Sh. Mopuri Bala Krishana Reddy, a Reporter of Sakshi TV informing him that Sh. Y. S. Vivekananda Reddy had died due to heart attack. Consequently, Sakshi TV ran a breaking news regarding death of Sh. Y. S. Vivekananda Reddy due to heart attack at 7.14 AM. During investigation the news clippings from 06.00 AM to 07.30 AM have been collected from Sakshi T.V. In this regard, Shri Mopuri Bala Krishana Reddy has stated that at 06.24.14 AM, he was contacted by D. Siva Shankar Reddy (A-5) in-order to arrange a TV reporter to cover the political program of Y.S. Avinash Reddy at Jammalamadugu and at 6.46 AM D. Siva Shankar Reddy (A-5) had informed him that Shri Y.S. Vivekananda Reddy died due to heart attack. In this regard, Shri Mopuri Bala Krishana Reddy was further asked to clarify as to whom he had contacted to cover the said political programme for which he had received call from D. Siva Shankar Reddy (A-5) at 6.24.14 AM. On this, Shri Mopuri Bala Krishana Reddy stated that he had conveyed the said message to a trainee reporter namely Sh. Nelaturi Sivanandareddy to cover the program. However, Sh. Nelaturi Sivanandareddy in his statement has denied receiving any instruction from Shri Mopuri Bala Krishana Reddy regarding coverage of political program of Y.S. Avinash Reddy (A-8). He stated that he had received a call at around 07.00 - 07.15 AM wherein Shri Mopuri Bala Krishana Reddy asked him to cover



the story regarding death of Y.S. Vivekananda Reddy. As per CDR of Shri Mopuri Bala Krishana Reddy (9912199605) and Sh. Nelaturi Sivanandareddy (9502222209) during this period only one call has been made by Shri Mopuri Bala Krishana Reddy to Sh. Nelaturi Sivanandareddy at 06:26:08 AM. Therefore, it shows that the call at 6:24:14 AM made by D Siva Shankar Reddy (A-5) to Shri Mopuri Bala Krishana Reddy was only with the purpose to cover the story regarding death of Y.S. Vivekananda Reddy. Further, as per statements of local reporters of Sakshi TV covering Jammalamadugu and adjacent areas namely Nelaturi Sivanandareddy, N. Abdul Basheer, Vallupu Srinivasulu and others, they had no information about the political programme of Y. S. Avinash Reddy (A-8) at Jammalamadugu on 15.03.2019. As per their statements, they used to get information for covering the political events one day in advance. Therefore, the spread of fake story relating to death of Y. S. Vivekananda Reddy due to heart attack was part of a criminal conspiracy hatched at the behest of the accused persons.

- 16.92.** It is further revealed that D. Siva Shankar Reddy (A-5) (9440203852) had also made a call to J. Shankaraiah, then Circle Inspector (CI) of Pulivendula (9121100544) at 07:12:08 to send the police force immediately to control the situation and reach immediately. Shortly after, Shri J. Shankaraiah accompanied by 03 constables reached at the house of Shri Y. S. Vivekananda Reddy at around 7.15 AM. On this aspect, investigation revealed that Shri J. Shankaraiah after receipt of





information from Y. S. Avinash Reddy (**A-8**) at 06.44 AM regarding death of Shri Y. S. Vivekananda Reddy due to heart attack and the request of sending 3-4 Constables, had brought the information in the knowledge of his Supervisory Officer Shri D. Nagraja, SDPO Pulivendula, on which Shri D. Nagraja instructed him to visit the house of Shri Y. S. Vivekananda Reddy. Further, at 7.10 AM, Shri J. Shankaraiah had also received a call from Shri Rahul Dev Sharma, then SP Kadapa, enquiring about the incident, on which Shri J. Shankaraiah informed him about the death of Shri Y.S. Vivekananda Reddy due to heart attack and blood vomiting as informed to him by Y.S Avinash Reddy (**A-8**). Shri J. Shankaraiah informed SP that since Shri Y.S. Vivekananda Reddy had died naturally therefore there was no apprehension of Law & Order problem and thus there was no need of sending the force.

- 16.93.** Investigation further revealed that T. Gangi Reddy (**A-1**) after having a meeting with 03 co-accused at his residence in the early morning of 15.03.2019 received a call from Gajjala Uma Shankar Reddy (**A-3**) at 6.56.25 AM (19 seconds) and simultaneously he also received call from Shri N. Siva Prakash Reddy at 6.56.30 AM (36 seconds). Thereafter, T. Gangi Reddy (**A-1**) called Shri Nagappa, his neighbour at 6.59.12 AM and requested him to drop at the residence of Shri Y. S. Vivekananda Reddy and he immediately reached at the house of T. Gangi Reddy (**A-1**), wherefrom both proceeded to the house of Shri Y.S. Vivekananda Reddy on the Motorcycle of Shri Nagappa and reached within a few minutes. Shri Nagappa





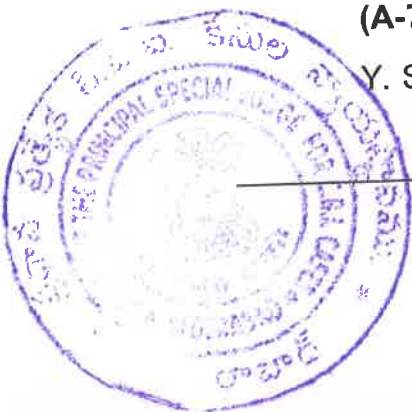
during investigation has stated that T. Gangi Reddy **(A-1)** while seated on the motorcycle did not talk to him and even did not disclose about the death of Shri Y.S. Vivekananda Reddy and he was looking nervous. As soon, he dropped T. Gangi Reddy **(A-1)** at the house of Vivekananda Reddy, T. Gangi Reddy **(A-1)** directly went inside the house without talking to anybody where public had already gathered. On reaching Shri Nagappa heard that Shri Y.S. Vivekananda Reddy had died due to heart attack. Shri Nagappa also tried to go inside the house but he was not allowed to see the dead body and someone pushed him outside. He noticed that only main persons were being allowed to go inside to see the dead body and others were standing in the compound area. Thereafter, he came back to his home.

**16.94.** Investigation as regards arrival of Y. S. Bhaskar Reddy **(A-7)** at the Scene of Crime revealed that as per part of conspiracy, Y. S. Avinash Reddy **(A-8)** after reaching at the house of Shri Y.S. Vivekananda Reddy, called his father. Thereafter, Bhaskar Reddy **(A-7)** also reached at the house of Y.S. Vivekananda Reddy and joined other accused persons as a part of conspiracy.

**16.95.** Investigation revealed that all accused persons namely Y. S. Bhaskar Reddy **(A-7)**, Y.S. Avinash Reddy **(A-8)**, D. Siva Shankar Reddy **(A-5)** and T. Gangi Reddy **(A-1)**, while standing inside the drawing room of Y.S. Vivekananda Reddy, were discussing among themselves that Y.S. Vivekananda Reddy had died due to heart attack and cotton bandages should be

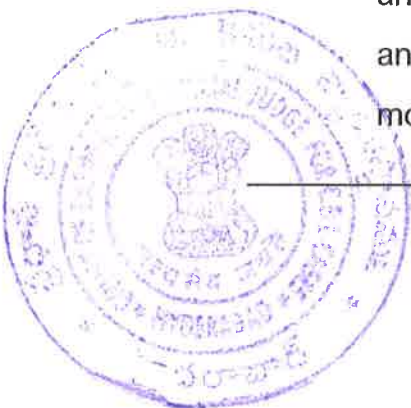


arranged besides cleaning the bedroom, bathroom and dead body. Their conversations were heard by Ragiri Lakshmi Devi, Sheikh Inayatullah and Y. Prakash, who were present at that time inside the drawing room. Further, as a part of conspiracy Gajjala Uday Kumar Reddy (A-6) called his father namely Shri Gajjala Jai Parkash Reddy, a compounder working at EC Gangi Reddy Hospital to immediately reach at the house of Shri Y. S. Vivekananda Reddy along with Cotton & Bandage. As per CDR of Gajjala Uday Kumar Reddy (A-6), he had made a call to his father at 06.35.06 AM from his mobile phone 9441234566 to the Mobile phone 9705796073 of his father. Accordingly, Shri Gajjala Jai Parkash Reddy who was attending a patient at the house of his landlord namely Sh. Guduru Sivarama Krishna Reddy @ Babu lecturer, visited the house of Shri Y. S. Vivekananda Reddy. During investigation, Shri Gajjala Jai Parkash Reddy stated that he worked as a Compounder at Dinesh Medical Centre since last 30 years and on being called by his son, he reached at the house of YS. Vivekananda Reddy, where he saw a huge crowd at the main door of the house. After sometimes, he entered inside the house on being called by Y. S. Bhaskar Reddy (A-7), where he saw Y. S. Bhaskar Reddy (A-7), Y. S. Manohar Reddy, T. Gangi Reddy (A-1), CI Shankaraiah with one Home Guard, Sh. Vara Prasad, Sh. Y. S. Pratap Reddy, Sh. M.V. Krishna Reddy, PA of Late Shri YS Vivekananda Reddy. On entering inside the bedroom, Y. S. Bhaskar Reddy (A-7) directed him to dress the wounds in the forehead of Shri Y. S. Vivekananda Reddy. However, bandage was not available



with him. In the meantime, Sh. Vusireddy Sreenivas Reddy, who worked as compounder in YS Raja Reddy Hospital, Pulivendula reached at Scene of Crime along with cotton and bandages. Thereafter, on the instructions of Y. S. Bhaskar Reddy (A-7), he (Gajjala Jai Parkash Reddy) started padding the wounds on the forehead. While dressing the wounds, he noticed that there were large wounds on the backside of the head also. Sh. Vusireddy Sreenivas Reddy had also helped him in bandaging the wounds on the directions of Y. S. Bhaskar Reddy (A-7).

- 16.96.** Investigation revealed that Sh. Vusireddy Sreenivas Reddy, was working as a pharmacist at YSR Raja Reddy Hospital. He reached at the Scene of crime at around 06.50 AM on being called by Sh. Yeddula Chandra Shekhar Reddy, Manager of Y. S. Raja Reddy Hospital. Thereafter, he contacted Driver Prasad, who informed that Shri Y. S. Vivekananda Reddy had died. Accordingly, he rushed to the house of Shri Y.S. Vivekananda Reddy on his motorcycle. On entering in the drawing room and hall area of the house, he noticed that the bedroom was closed and D Siva Shankar Reddy (A-5) and Y. S. Bhaskar Reddy (A-7) came out of the bedroom. Both of them saw him in the hall area and both directed him to bring cotton and bandages, immediately. Thereafter, he rushed to the YS Raja Reddy Hospital and brought the same and handed over to Shri Gajjala Jai Parkash Reddy, compounder. However, on seeing the cotton and bandages in small quantity, D. Siva Shankar Reddy (A-5) and Y. S. Bhaskar Reddy (A-7) scolded him and directed to get more cotton and bandages from EC Gangi Reddy Hospital.



Thereafter, he went to EC Gangi Reddy Hospital on his motorcycle and collected cotton and bandages which was already kept ready by that time. As soon, he returned to the house of Shri Y.S. Vivekananda Reddy, while entering in the house he noticed Y. S. Avinash Reddy (A-8), and 3-4 other persons were present in the hall area. However, the bedroom door was closed, thus he knocked the door. Thereafter, the door was opened and he handed over cotton and bandages to Shri Gajjala Jai Parkash Reddy in the bedroom. When he entered inside the bedroom, he noticed that D. Siva Shankar Reddy (A-5), Y. S. Bhaskar Reddy (A-7), Y. Gangi Reddy (A-1), M. V. Krishna Reddy, Dr. Venkatesh Naik, Jaya Prakash Reddy, Compounder, Inayatullah, P. Rajasekhar, CI Shankaraiah, Nagabhushan Reddy, Home guard were present inside in the bedroom. Further, he saw the dead body of Shri Y.S. Vivekananda Reddy was kept in the bed room. Moreover, he also heard discussion of D. Siva Shankar Reddy (A-5) and Y. S. Bhaskar Reddy (A-7) with Dr. Naik that the blood has been cleaned and bed sheet has also been changed as it was a case of heart attack. On this, Dr. Naik stated that the injuries were grievous in nature and it was not a case of heart attack. He further noticed that Y. Gangi Reddy (A-1) was preparing to change the blood-soaked clothes of Shri Y. S. Vivekananda Reddy. The bandages were being applied by Shri Gajjala Jai Parkash Reddy, Compounder and he handed over the cotton bandages to him. On seeing the grievous injuries, at that time he had thought that it is not a heart attack but it was a murder





but he could not express his views. He further noticed that the bedroom was got cleaned. After handing over the cotton and bandages, he left the room.

- 16.97.** Investigation as regards application of cotton and bandages it is revealed that, same were applied by Shri Gajjala Jai Parkash Reddy on the instructions of Y. S. Bhaskar Reddy (A-7), D. Siva Shankar Reddy (A-5) and T. Gangi Reddy (A-1). However, two Doctors namely Dr. B Venkatesh Naik and Dr. Y.S. Abhishek Reddy had also visited the Scene of Crime and noticed the grievous injuries present on the dead body of Shri Y. S. Vivekananda Reddy and the dead body being lying in the pool of blood at the time of application cotton and bandages.
- 16.98.** On this aspect, Dr. B Venkatesh Naik, a physician at Srinivasa Hospital, Pulivendula stated that on 15.03.2019, after hearing the news of death of Shri Y.S. Vivekananda Reddy due to heart attack, he reached at the house of Shri Y. S. Vivekananda Reddy at around 0715 Hours, where a huge crowd had already gathered. On entering the bedroom of Shri Y. S. Vivekananda Reddy, he saw M.V. Krishna Reddy, Inayatullah, Y. S. Bhaskar Reddy (A-7), Shri Y. S. Pratap Reddy, Y. S. Manohar Reddy, Shri Vara Prasad, CI Shankaraiah with one home guard, Vempulla Ramu and Shri Gajjala Jai Parkash Reddy, compounder were present inside the bedroom. Whereas, Y. S. Avinash Reddy (A-8) was present in the hall area of the house. He saw the dead body of Y. S. Vivekananda Reddy laid down on the floor beside the bed. There was no blood in the room where



the dead body was kept. On seeing the dead body of Shri Y.S. Vivekananda Reddy, he was shocked because the news was that Shri Y.S. Vivekananda Reddy had died due to heart attack, however he could see that the reason for his death was not due to heart attack. Further, he saw that Shri Gajjala Jai Parkash Reddy was applying cotton pads on the injuries. Therefore, he asked from Shri Gajjala Jai Parkash Reddy that if there were injuries on the backside of head. On this Shri Gajjala Jai Parkash Reddy responded positively. Thereafter, he stayed in the bedroom for around 10 minutes. At that time, some other persons were also discussing that it is not a heart attack. As a doctor many people asked him about his opinion on the death, on which he responded that it was not a case of heart attack because suspicious injuries were there.

- 16.99.** On this aspect, Dr. Y. S. Abhishek Reddy, a consultant Orthopaedician at Dinesh Medical Centre Pulivendula, stated that on 15.03.2019 at about 06:35am, D. Siva Shankar Reddy (A-5) called him and asked him to come to the residence of Shri Y. S. Vivekananda Reddy but he did not tell him anything else. He reached at the house of Shri Y.S. Vivekananda Reddy at around 06:50 AM. When he entered in the house, he saw that D. Siva Shankar Reddy (A-5) was standing in the porch area near the main door. As soon as he entered the bedroom, he saw blood around the bed. The blood marks were there till the bathroom. Then, he went towards the bathroom and saw that the dead body of Shri Y. S. Vivekananda Reddy was lying there in night dress. He also saw blood in the bathroom and noticed



injuries on his forehead. Immediately, he thought that it is an assault. When he came outside, he saw Y. S. Avinash Reddy (A-8) was in veranda on phone call. At that time, Sh. Raghava Reddy, Y. S. Manohar Reddy were also present in Veranda. After some time, he saw that D. Siva Shankar Reddy (A-5), M.V. Krishana Reddy, Y. S. Manohar Reddy, T. Gangi Reddy (A-1) were discussing that Shri Y. S. Vivekananda Reddy came home late last night drunk and probably that it might be the reason for death due to vomiting blood. On hearing their discussion, he wondered and thought that Police should be called and Scene of Crime should be preserved. Thereafter, at around 07:30 AM, he left the house of Shri Y. S. Vivekananda Reddy and did not return thereafter.

- 16.100.** Investigation revealed that blood from bedroom and bathroom was cleaned by Smt. Ragiri Lakshmi, Tanker Basha, Shaikh Inayatullah and P. Rajashekhar on being forcefully directed by Y.S. Bhaskar Reddy (A-7), D. Siva Shankar Reddy (A-5) and T. Gangi Reddy (A-1) in order to destroy the evidence at the Scene of Crime. They were present inside the bedroom, whereas Y. S. Avinash Reddy (A-8) was present in the hall area of the house. In this regard, Smt. Ragiri Lakshmi stated that she used to work as house maid in the house of Shri Y.S. Vivekananda Reddy. On 15.03.2019, as usual she had gone to the house of Shri Y.S. Vivekananda Reddy, where she found that Shri Y.S. Vivekananda Reddy had died and there was a crowd in the house. Shaikh Inayatullah was already present at

the house. He called her inside the bed room of Vivekananda Reddy along with bucket and cleaning cloth. Accordingly, she went to bed room where T. Gangi Reddy (A-1) was present and he instructed her to clean the blood from floor. While she started wiping the blood from floor she couldn't wipe and started nauseating thus she left the bucket and the cloth there, and went into the kitchen where driver Prasad and cook Lakshmmumma were present. While, she was cleaning the floor she saw D. Siva Shankar Reddy (A-5), T. Gangi Reddy (A-1), Inayatullah, P. Rajasekhar, Y.S. Manohar Reddy, M.V. Krishna Reddy, Y.S. Bhaskar Reddy (A-7) were present inside the bedroom. She further noticed that Y.S Avinash Reddy talking over phone also entered in to the bed room of Shri Y.S. Vivekananda Reddy along with a Police Inspector. Thereafter, T. Gangi Reddy (A-1) again insisted Inayatullah to get the room cleaned. After that, Inayatullah asked her that they are insisting to clean the blood on the floor of the bedroom and bathroom and convinced her to clean the same.

16.101. Investigation revealed that Smt. Ragiri Lakshmi Devi, had cleaned the blood from the bedroom and bathroom on being instructed by Shaikh Inayatullah who in turn was instructed by T. Gangi Reddy (A-1). On this aspect, Sheikh Inayatullah stated that at around 07.00 AM, T. Gangi Reddy (A-1) entered into the bedroom, and after sometime, CI J. Shankaraiah also reached in the house. He explained the blood present all over the bedroom and further informed about the broken handle of Amirah in the bedroom. However, on search he could not find the broken

piece of handle. In between, T. Gangi Reddy (A-1) told him to clean the blood and bring the dead body out of the bathroom. At that time, D. Siva Shankar Reddy (A-5), Y.S. Manohar Reddy and others were also present. He observed that T. Gangi Reddy (A-1) was in hurry and thus instructed him 2-3 times to arrange someone to clean the blood but he did not pay heed on the instructions of T. Gangi Reddy (A-1). Then, T. Gangi Reddy (A-1) shouted on him and told to get Smt. Lakshmmamma (Ragiri Lakshmi Devi) to clean the blood. Accordingly, he asked Smt. Lakshmmamma to come along with bucket and cloth for cleaning the blood. While Smt. Lakshmmamma was cleaning the blood she started weeping and left the bedroom without finishing the cleaning work. Thereafter, T. Gangi Reddy (A-1) himself scratched the dried blood. Further, Tanker Basha and P. Rajasekar Reddy were also called to clean the blood with the towel. Moreover, T. Gangi Reddy (A-1) removed the blood-soaked bedsheet. After cleaning bedroom T. Gangi Reddy (A-1) asked CI J. Shankaraiah that room was cleaned, thus they can bring the dead body out of bathroom. Thereafter, P. Rajasekhar, Gouse Peer @ Tanker Basha and T. Gangi Reddy (A-1) brought the dead body from bathroom and laid on the floor of bedroom. After applying the cotton and bandages, the dead body was put on a stretcher and taken to hospital in an Ambulance. He accompanied by one Chand Basha, P. Rajasekhar and Vasu carried the dead body in an Ambulance to Government Hospital, Pulivendula where the dead body was kept in the mortuary.





**16.102.** Investigation revealed that while the destruction of the Scene of Crime was going on one Vara Prasad, a civil contractor and Ex-councilor of Pulivendula was also present. In this regard, he stated that on 15.03.2019 at around 06:40 AM, he heard the news regarding the death of Shri Y.S. Vivekananda Reddy due to heart attack from one Sh. Krishnamurthy (9866852691) a party worker. Further, he got confirmed the same from Y.S. Manohar Reddy (9701111179) at 06:55AM. At 07:15AM, he received a call from Y.S. Manohar Reddy for arranging one body freezer box. However, later Y.S. Manohar Reddy informed that the body freezer box had been arranged from CSI Church. He reached at the house of Shri Y.S. Vivekananda Reddy at around 07:45 AM. On entering in the house and seeing the dead body, he found that it was a confirmed murder. There was huge blood in the bedroom as well as in the bathroom. The body was kept in the bedroom. One lady was cleaning the blood on the floor of the bedroom. At that time, Y.S. Bhaskar Reddy (A-7), Y.S. Avinash Reddy (A-8), D Siva Shankar Reddy (A-5), Dr. Venkatesh Naik, Y.S. Manohar Reddy, Jagdeeshwar Reddy, CI J. Shankaraiah and T. Gangi Reddy (A-1) were present in the bedroom. At that time, Dr. Venkatesh Naik was telling that it was not a case of heart attack. However, the process of bandaging was also going on. Thereafter, he talked to PA M.V. Krishna Reddy and discussed that it appears to be a clear-cut murder and tried to know from him whether he received/ found any evidence at the spot. He told him that he did not find anything suspicious. He being outsider did not raise any further question



about the murder because all the respectable family members were already available there.

**16.103.** Investigation revealed that while the destruction of the Scene of Crime was going on Y.S. Pratap Reddy (**elder brother of Y. S. Bhaskar Reddy**) had also visited the Scene of Crime at around 07:20AM. When he entered in the house, he saw Y.S. Manohar Reddy sitting in hall area and also noticed that Y.S. Avinash Reddy (**A-8**), was in the garden area talking over phone. When he entered the bedroom M.V. Krishana Reddy, D. Siva Shankar Reddy (**A-5**), T. Gangi Reddy (**A-1**), Inayatullah and Y.S. Bhaskar Reddy (**A-7**), were present in the bedroom. There was blood on the floor near the bed, some blood on the pillow and bed sheet was also seen. He saw that the dead body lying in a pool of blood at bathroom. Further, he also noticed the grievous injuries on the forehead. After seeing the grievous injuries on the forehead and heavy bleeding in bedroom and bathroom, he realized that it was not a case of heart attack, rather something untoward had happened. However, he did not express his views in front of other persons because Y.S. Avinash Reddy (**A-8**), Y.S. Bhaskar Reddy (**A-8**), and D. Siva Shankar Reddy (**A-5**) had already reached at the spot and the message of heart attack was floated by them to different individuals. He also noticed that one maid was cleaning the bedroom and D. Siva Shankar Reddy (**A-5**) and T. Gangi Reddy (**A-1**) were forcing her to clean up the blood immediately. On seeing this he was surprised as to why they were in such a hurry to get the bedroom cleaned. At that time CI J.

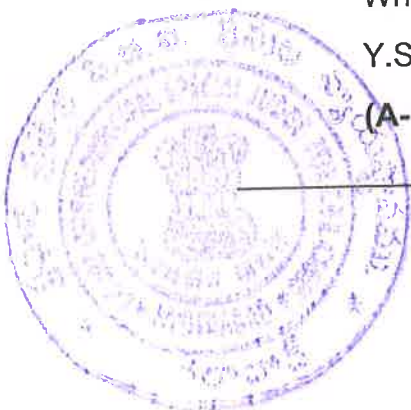


Shankaraiah also reached in the bedroom and on seeing the scene of crime he specifically told him **"Sir why D. Shankar Reddy and Yerra Gangi Reddy getting the scene of crime clean as it will get complicated as they are destroying the evidences"**. He further saw that T. Gangi Reddy (A-1) removed the blood-stained bed sheet and threw it in a corner. Y.S. Bhaskar Reddy (A-7) and Y.S. Manohar Reddy were walking in and out of the bedroom while D. Siva Shankar Reddy (A-5) and T. Gangi Reddy (A-1) were destroying the evidence at the Scene of Crime. On seeing these activities, he could not control his emotions and left to his house. He did not visit the house of Shri Y.S. Vivekananda Reddy again as it was a case of clear-cut murder, which was being manipulated as heart attack.

- 16.104.** Investigation revealed that while the destruction of the Scene of Crime was going on Narreddy Jagdeeshwara Reddy also visited the Scene of Crime. When he entered the hall area Y.S. Bhaskar Reddy (A-7) was present there along with other persons. The bedroom was bolted from inside, Y. S. Bhaskar Reddy (A-7) took him inside the bedroom to show the dead body. Where he saw maid Lakshmumma cleaning the blood on the floor. Y.S. Prakash Reddy, Y.S. Pratap Reddy, Y.S. Manohar Reddy, Ramakrishna Reddy, HC, T. Gangi Reddy (A-1), M.V. Krishana Reddy, Inayatullah, P. Rajashekhar and Varaprasad were present in the bedroom. After sometime, CI J. Shankaraiah also entered in the bedroom. Then, he went towards the bathroom where he saw the dead body lying in pool of blood. At that time Y.S. Manohar Reddy, Y.S. Bhaskar Reddy

(A-7), D. Siva Shankar Reddy (A-5) and CI J. Shankaraiah were present they were telling that it is blood vomiting, however he did not believe their version. Thereafter, the dead body was shifted to the bedroom where he noticed a cut injury in the right-hand palm. Moreover, the bandages were applied by Vusireddy Sreenivas Reddy, Compounder of Y.S. Raja Reddy Hospital and Gajjala Jai Prakash Reddy, Compounder of E.C Gangi Reddy Hospital. Further, he saw that D Siva Shankar Reddy (A-5) was scolding Vusireddy Sreenivas Reddy as to why he did not bring more cotton. Home guard Nagabhushan was capturing photographs on his phone and he was also scolded by D. Siva Shankar Reddy (A-5) for doing so and warned him not to share the pictures to anybody or on social media.

- 16.105. Investigation revealed that while the destruction of the Scene of Crime was going on, Sh. Karna Nagabhushan Reddy, a Home Guard also visited the Scene of Crime. He was on night duty from 9 PM to 5 AM in the intervening night of 14/15.03.2019 in the area. After duty, he reached home at about 05:15AM and slept, however he got a call from one Chinna at around 06.50AM on 15.03.2019 informing that Shri Y.S. Vivekananda Reddy has died due to heart attack. Thereafter, he reached at the house of Shri Y.S. Vivekananda Reddy at around 07:20AM and entered through the main door, however he was not allowed initially to enter in the bedroom but was later allowed. When he entered in the bedroom, he saw CI J. Shankaraiah, Y.S. Bhaskar Reddy (A-7) Y.S. Manohar Reddy, T. Gangi Reddy (A-1), M.V. Krishana Reddy, Dondlavagu Shankar Reddy (A-5),





Dr. Venkatesh Naik, Gajjala Jai Prakash – compounder, Inayatullah and others were present in the bedroom. The room was cleaned and the dead body was kept in one side of the bedroom. On reporting to CI J. Shankaraiah, he told him that Shri Y.S. Vivekananda Reddy had died due to heart attack and vomited a lot of blood. However, he stated that there are grievous injuries on the both sides of head of the dead body, how such injuries can be caused in a case of heart attack. Further, he saw T. Gangi Reddy (A-1) changing the bedsheet. In the meantime, cotton and bandages were brought in the room by hospital staff and one Jai Prakash compounder accompanied by Vusireddy Sreenivas Reddy of Y.S. Raja Reddy hospital started bandaging of the deceased. The bandaging was done on the orders of T. Gangi Reddy (A-1). In the meantime, as per instruction of CI J. Shankaraiah, he started recording a video of the bedroom and bathroom on his mobile. On this, D. Siva Shankar Reddy (A-5) shouted on him to stop the recording immediately. However, CI J. Shankaraiah told D. Siva Shankar Reddy (A-5) to let him carry on photography. On seeing the dead body, he was not convinced it to be a case of heart attack and it appeared to be clear cut murder. He also told this opinion to CI J. Shankaraiah that it appears to be a murder. On this CI J. Shankaraiah directed him to take a video of the deceased and Scene of crime.

**16.106.** Investigation revealed that while the destruction of the Scene of Crime was going on Sh. R. Venkata Ramana of M/s Dharani Mineral Water, Pulivendula was also present. He stated that on



15.03.2019, at about 0730 AM, when he was at Krishnalayam Temple, Shri Raghava Reddy PA to Y.S. Avinash Reddy (A-8) called him to bring water cans at the residence of Shri Y.S. Vivekananda Reddy as he had died due to heart attack. Thereafter, he arranged water and also reached to the house of Shri Y.S. Vivekananda Reddy within 05 minutes and entered in the hall area, where about 20-25 persons were present. He noticed that the bedroom of Shri Y. S. Vivekananda Reddy was bolted from inside. The bedroom was opened after 5-7 minutes and Shri D. Siva Shankar Reddy (A-5), Shri Y.S. Bhaskar Reddy (A-7), Y.S. Manohar Reddy, CI J. Shankaraiah and other persons came out of room. Thereafter, the dead body was shifted from bed room to hall area on a stretcher. He noticed that bandages had also been applied on the head of deceased. Y.S. Avinash Reddy (A-8) was also available in the hall area. The persons who visited the house much earlier than him by knowing the death of Shri Y.S. Vivekananda Reddy due to heart attack were also clearly of the view that it was a case of murder.

- 16.107.** During investigation it is revealed that Shri Gajjala Jai Prakash Reddy, compounder had also arranged an Ambulance from E.C Gangi Reddy Hospital. Sh. Pappireddi Raghunatha Reddy, the Ambulance Driver has stated that he was called by Sh. Gajjala Jai Prakash Reddy to bring Ambulance at the residence of Shri Y.S. Vivekananda Reddy as his dead body was to be taken for Post Mortem at Govt. Hospital Pulivendula. Accordingly, he took the Ambulance to the residence of Shri Y.S. Vivekananda Reddy and parked the Ambulance inside the house of Shri Y.S.

Vivekananda Reddy. The dead body was brought on stretcher and they took the dead body to Govt. Hospital Pulivendula.

**16.108.** On this aspect, Sh. Guduru Sivarama Krishnareddy @ Babu Lecturer revealed that on 15.03.2019 at around 06:30AM Shri Gajjala Jai Prakash Reddy had come to his house for treatment of his father. In the meantime, Shri Gajjala Jai Prakash Reddy received a call from his son Gajjala Uday Kumar Reddy **(A-6)** to reach immediately to the house of Shri Y.S. Vivekananda Reddy. Accordingly, Shri Gajjala Jai Prakash Reddy left for the house of Shri Y.S. Vivekananda Reddy. Thereafter, Sh. Guduru Sivarama Krishnareddy @ Babu lecturer called M.V. Krishana Reddy, who informed that Shri Y.S. Vivekananda Reddy is no more and he asked him to come immediately, thus he also went to the house of Shri Y.S. Vivekananda Reddy on his bike and reached within 10 minutes. After reaching the house, he entered in the bedroom, where he saw there was huge blood in the bedroom and thereafter, he also went to the bathroom, where he saw that dead body of Shri Y.S. Vivekananda Reddy was lying there in pool of blood. He also noticed several grievous injuries on the head of Shri Y.S. Vivekananda Reddy. On seeing the grievous injuries and pool of blood in the bedroom and bathroom, he clearly understood that it was a case of murder. He also saw T. Gangi Reddy **(A-1)**, D. Siva Shankar Reddy **(A-5)**, Y.S. Manohar Reddy, CI J. Shankaraiah, Inayatullah and M.V. Krishna Reddy were present in the bedroom. T. Gangi Reddy **(A-1)** and D. Siva Shankar Reddy **(A-5)**, were telling to everyone that Shri Y.S. Vivekananda



Reddy died due to heart attack. However, he was feeling that it was a case of murder but could not express his emotions before them. He further saw one lady cleaning the blood on the floor of the bedroom on the instructions of T. Gangi Reddy (A-1) and D. Siva Shankar Reddy (A-5). They were discussing for the arrangement of body freezer box quickly and Y.S. Manohar Reddy asked him to arrange the same. However, in the meantime, he received a call and came out of the bedroom. Thereafter, he again tried to enter inside the bedroom but he found that the bedroom was got closed from inside. He remained there for about 10-15 minutes and there was crowd outside the house. He also heard discussion among the people that everybody who went inside the bedroom and seen the dead body of Shri Y.S. Vivekananda Reddy clearly stated that it was a case of murder against the version of family members present inside the house, who were saying it to be a case of heart attack.

**16.109.** Investigation revealed that on being informed by Y.S. Avinash Reddy (A-8), Shri J. Shankaraiah, CI Pulivendula along with 03 constables arrived at the house of Shri Y. S. Vivekananda Reddy at around 7.15 AM, however, none of the constables were allowed to enter inside the house by D. Siva Shankar Reddy (A-5). Thus, he alone went inside the house, where he saw Y. S. Bhaskar Reddy (A-7), Y.S. Manohar Reddy, Y.S. Pratap Reddy, T. Gangi Reddy (A-1), D. Siva Shankar Reddy (A-5), Shaikh Inayatullah, Shri Gajjala Jai Prakash Reddy, Compounder, Shri Vusireddy Sreenivas Reddy, Compounder,





Dr. Venkatesh Naik and some other persons inside the bedroom. Further, he saw that a huge quantity of blood was present in the bathroom and bedroom was got cleaned by Smt. Ragiri Lakshmi, a maid working in the house of Late Shri Y.S. Vivekananda Reddy, on being forcibly instructed by the T. Gangi Reddy (A-1) and D. Siva Shankar Reddy (A-5). Further, in order to conceal the grievous injuries inflicted on the body of Shri Y.S. Vivekananda Reddy, the same were got cleaned and bandaged with the help of compounder Shri Gajjala Jai Prakash Reddy (father of Gajjala Uday Kumar Reddy- A-6). On objecting these activities, CI J. Shankaraiah was intimidated by D. Siva Shankar Reddy (A-5) to keep mum about the grievous injuries on the body of Shri Y.S. Vivekananda Reddy and to manage it as an occurrence of heart attack and blood vomiting. Moreover, on the instructions of the accused persons, a body freezer box was also brought immediately to put the body of the Shri Y.S. Vivekananda Reddy for display so that the brutal murder could be hidden from the public view by decorating the dead body with flowers. In the meantime, the D. Siva Shankar Reddy (A-5), T. Gangi Reddy (A-1), Y.S. Avinash Reddy (A-8) and their close associates were convincing the visiting persons that Shri Y.S. Vivekananda Reddy had died due to blood vomiting and heart attack. He also stated that YS Avinash Reddy (A-8), D. Sankar Reddy (A-5), and T. Gangi Reddy (A-1) told him that registration of case is not necessary and to not to go for post mortem.

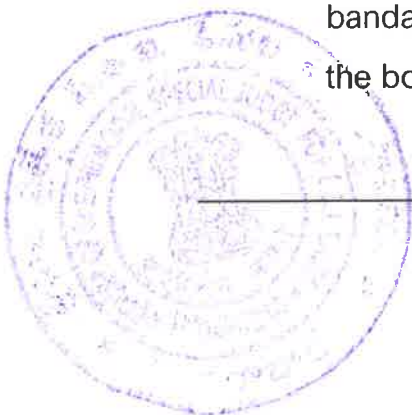
16.110. During investigation Shri M.V Krishna Reddy (**PA of Shri Y. S. Vivekananda Reddy and complainant in the case**) who was the first person to arrive at the house of Shri Y.S. Vivekananda Reddy and remained present till the dead body was taken to the hospital for Post-mortem, stated that when he saw the vehicle of Y. S. Avinash Reddy (**A-8**) he came outside the house and received Y.S. Avinash Reddy (**A-8**) and further accompanied them while entering in the house. D. Siva Shankar Reddy (**A-5**) and E.C. Surendra Nath Reddy also followed Y.S. Avinash Reddy (**A-8**). All three went to the bedroom and bathroom to see the dead body of Shri Y.S. Vivekananda Reddy. Thereafter, all three (D. Siva Shankar Reddy (**A-5**), E.C. Surendra Nath Reddy and Y.S. Avinash Reddy (**A-8**)) had discussion among themselves however he could not hear the same being at a distance. After sometime, Y.S. Avinash Reddy (**A-8**) and E.C. Surendra Nath Reddy went towards the garden area and D. Siva Shankar Reddy (**A-5**), remained in the hall area. In the meantime, Y.S. Bhaskar Reddy (**A-7**), Y.S. Prakash Reddy, Y.S. Manohar Reddy, Y.S. Pratap Reddy, and T Gangi Reddy (**A-1**) also reached at the house. They also went inside the bedroom and bathroom. After sometime, CI J. Shankaraiah also reached there. At that time D. Siva Shankar Reddy (**A-5**), Y.S. Manohar Reddy, T. Gangi Reddy (**A-1**), Dr. Naik, Councilor Vara Prasad, compounder Jai Prakash Reddy, CI J. Shankaraiah, Inayatullah, Tanker Basha, P. Rajashekhar and himself were present in the bedroom. He heard from T. Gangi Reddy (**A-1**) saying that it is a blood vomiting, D. Siva Shankar Reddy (**A-5**), Y.S. Manohar

Reddy and CI J. Shankaraiah did not react on the version of T. Gangi Reddy (A-1) and agreed that it was a blood vomiting. But he countered them saying that how a pool of blood can be a vomiting and also added that there were serious injuries on the forehead but they did not pay heed to him. The cleaning of the bedroom and bathroom was done on the instance of family member Y.S. Bhaskar Reddy (A-7), T. Gangi Reddy (A-1) and D. Siva Shankar Reddy (A-5). CI J. Shankaraiah was also present in the bedroom. Thereafter, the dead body was shifted from bathroom to bedroom under the instructions of D. Siva Shankar Reddy (A-5) and T. Gangi Reddy (A-1). The bedsheet was changed by T. Gangi Reddy (A-1) who also brought a shirt to change the blood-soaked clothes but, in the meantime, Inayatullah noticed grievous injuries behind the head. The cotton and bandages were arranged and applied by Jai Prakash compounder and one other compounder. Y.S. Manohar Reddy, D. Siva Shankar Reddy (A-5), T. Gangi Reddy (A-1) and Y.S. Bhaskar Reddy (A-7) were present in the bedroom while the bandages were applied. In the meantime, N. Rajashekhar Reddy talked to CI J. Shankaraiah and told him to register an FIR. Accordingly, a complaint was lodged by him. However, the complaint was drafted under the dictation of D. Siva Shankar Reddy (A-5). CI J. Shankaraiah after going through the complaint advised him to mention the details of injuries on the forehead and back side of the head and right-hand palm. Accordingly, the changes were made in the complaint and case was registered.



**16.111.** Investigation revealed that after cleaning the Scene of Crime and applying bandages on the dead body of Shri Y.S. Vivekananda Reddy, one body freezer was arranged through one Shri Vemavaram David Sikhamani, Secretary, CSI Town Church Pulivendula for the purpose of public display of dead body. On examination, Shri Vemavaram David Sikhamani stated that he received a call from Y.S. Prakash Reddy at about 07:20 AM, and he told him to send a body freezer box at the residence of Shri Y.S. Vivekananda Reddy. Accordingly, he accompanied with Sexton P. Nillaiah carried a body freezer box to the house of Shri Y. S. Vivekananda Reddy in an auto, and kept the body freezer box in the hall and a bed sheet was also spread in the box. However, after 10 minutes it was informed that the body will be taken to Hospital for Post Mortem and there is no need of the body freezer box.

**16.112.** It is revealed that Inayatullah, Smt. Ragiri Lakshmi and Yeddula Prakash were present in the Hall area and heard the discussion among Y. S. Bhaskar Reddy (A-7), D. Siva Shankar Reddy (A-5), Y. S. Avinash Reddy (A-8), Y. S. Manohar Reddy that cotton bandages and body freezer box were required to be arranged. Therefore, arrangement for body freezer box was part of plan of destruction of Scene of Crime. Shri J. Shankaraiah, CI Pulivendula stated that the body freezer box was brought by the accused persons to put the body for public display after bandaging and floral decoration so that the injuries present on the body could not be noticed by the general public.

DEAD BODY SHIFTED FROM BATHROOM TO BEDROOM AND CLEANING

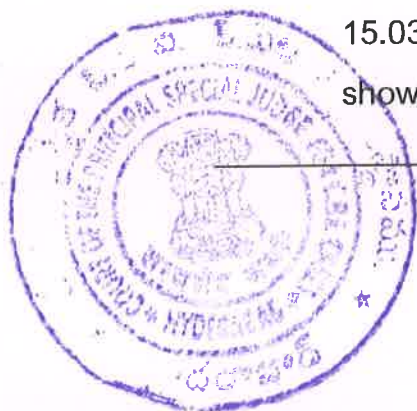


16.113. During investigation, all the early visitors after seeing the dead body stated that death of Shri Y.S. Vivekananda Reddy was suspicious and appeared to be a case of murder, and not a case of death due to heart attack and blood vomiting. However, Y. S. Avinash Reddy (A-8) and Y.S. Bhaskar Reddy (A-7) and their other close associates after reaching at the Scene of Crime and seeing the dead body of Shri Y.S. Vivekananda Reddy in pool of



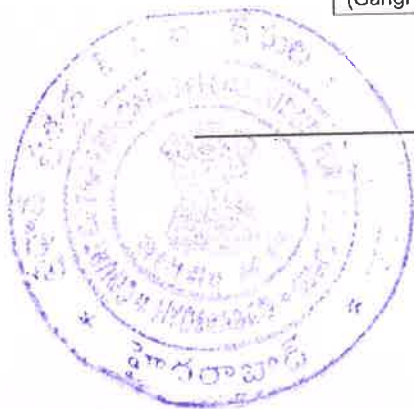
blood with grievous injuries, neither informed nor waited for the immediate relatives of the deceased i.e. (1) Mrs. Y.S. Sowbhagyamma – wife of the deceased (2) Mrs. N. Suneetha Reddy – daughter of the deceased. Rather giving the colour of natural death (due to heart attack) got cleaned and dressed up the Scene of Crime.

**16.114.** It is further revealed that T. Gangi Reddy (**A-1**), D. Siva Shankar Reddy (**A-5**) and Y.S Avinash Reddy (**A-8**) also tried to hush up the murder of Shri Y.S. Vivekananda Reddy by insisting CI J. Shankaraiah that registration of a criminal case and carrying out post mortem was not necessary. Moreover, while lodging the complaint at Police Station - Pulivendula on 15.03.2019 by M.V. Krishna Reddy, D. Siva Shankar Reddy (**A-5**) had dictated a vague complaint without even mentioning about the presence of grievous injuries, the dead body lying in the pool of blood and presence of huge blood in bedroom of the deceased. However, CI, J. Shankaraiah did not agree to register the FIR on the basis of vague complaint. Subsequently, as per the instructions of CI J. Shankaraiah, the complaint was modified by mentioning the injuries and presence of heavy amount of blood at the Scene of Crime and a FIR No. 84/2019 U/s 174 Cr.P.C was registered, despite being it a clear case of murder. The analysis of google takeout of email id [d.shankarreddy1967@gmail.com](mailto:d.shankarreddy1967@gmail.com) belonging to D. Siva Shankar Reddy (**A-5**) i.e., reveals that location of D Siva Shankar Reddy (**A-5**) from 08:25 AM to 12:45 PM on 15.03.2019 was near the Police Station - Pulivendula which shows that D. Siva Shankar Reddy (**A-5**) was present along with



M.V. Krishna Reddy while registration of the case at Police Station - Pulivendula. It is also revealed that between this period location of mobile phone of Yadati Sunil Yadav (A-2) was at the Police Station Pulivendula from 09.12 AM to 09.46 AM as per the analysis of his google takeout. Further the CDR analysis reveals that during this period D Siva Shankar Reddy (A-5) was in contact with Y.S. Avinash Reddy (A-8), Y.S. Bhaskar Reddy (A-7), and T. Gangi Reddy (A-1) as D Siva Shankar Reddy (A-5) had exchanged several calls with them, which are as follows.

**16.115.** Investigation revealed that the said FIR was registered only after the intervention of Shri N. Raj Shekhar Reddy, who after receiving information from M. V. Krishna Reddy regarding the letter containing name of Driver Prasad and seeing the photographs sent by Shaikh Inayatullah had suspected that it was not a case of natural death, therefore, he insisted M.V. Krishna Reddy to get registered a criminal case in the matter. Further, to pursue registration of case he also spoke to Sh. J. Shankaraiah, CI on the phone of M. V. Krishna Reddy. Therefore, the accused persons could not succeed in concealing the design of murder by showing it to be a case of natural death by heart attack and blood vomiting.

### **INQUEST PROCEEDINGS**

**16.116.** Investigation revealed that the dead body of Shri Y.S. Vivekananda Reddy was shifted from his residence to Govt. Hospital, Pulivendula at around 08.15-08.30 am in an Ambulance. The immediate relatives of Shri Y.S. Vivekananda Reddy i.e. wife, daughter, brother, son-in-law could reach Pulivendula only by 12:30 hrs from Hyderabad. As per Inquest Report, the proceedings had commenced at 09.00 AM on 15.03.2019 by CI J. Shankaraiah in presence of three inquest witnesses namely [1] Sarreddy Siva Prakash Reddy [2] N. Jagdeeshwara Reddy and [3] Ajjuguttu Venkata Narayana Reddy at the mortuary room of Govt. Hospital Pulivendula. As per Inquest proceedings, Shri Y.S. Vivekananda Reddy was wearing dark blue Color full sleeve cotton check shirt and following injuries were found on his dead body:





- [A] Two deep cut bleeding injuries side by side on mid forehead with same length of width about 01 inch and while about 3.5 inches of length and 06 inches of deep.
- [B] Cut injury on right side of head with length about 03 inches and width about 01 inches.
- [C] Cut injury on left side of head with length about 02 inches and width about 01 inches.
- [D] Cut injury about left side ear at its just rear side with length about 02 inches and width about 01 inch.
- [E] Deep cut injury on rear side of head with length about 04 inches and about 02 inches.
- [F] Injury below left eye.
- [G] Cut injury over right palm with length about 02 inches and width about 01 inches.

16.117. It is revealed that the Inquest proceedings had shown concluded at 12.30 PM, in the presence of immediate relatives namely Smt. Y.S. Sowbhagyamma (**wife of Y.S. Vivekananda Reddy**), Smt. N Suneetha Reddy (**daughter**), Shri N Raj Shekhar Reddy (**son-in-law**) and thus J. Shankaraiah, CI had obtained their signatures on the Inquest report. Further, M.V. Krishna Reddy had also signed as a complainant for initiating 174 Cr. PC proceedings. In the Inquest report, it was concluded that some unknown persons had committed the murder of deceased with some weapons. Thus, section of FIR was altered from 174 Cr. PC to 302 IPC. Thereafter, the dead body was handed over to one constable namely Ravi Naik of Police Station Pulivendula for the purpose of getting Post mortem examination carried out.

### **POST-MORTEM EXAMINATION & OPINION**

**16.118.** It is further revealed that after the inquest proceedings, Post-mortem examination of the dead body of Shri Y. S. Vivekananda Reddy was conducted at Govt. Hospital Pulivendula by doctors namely Dr. A. Jyothsna and Dr. L.



Ananda Kumar, which commenced at 12.35 PM. In the PM examination, following injuries were found on the dead body:

1. A lacerated injury vertical in position measuring 7 x 2 c.m over left side of forehead of bone deep with evidence of comminuted displaced fracture of frontal bone.
2. A lacerated injury of 7.5 x 5 c.m which is oblique in position of bone deep by the side of fist injury extending to middle of parietal bone with brain matter.
3. Seeping out with evidence of comminuted fracture of frontal bone with segmental loss of bone.
4. A lacerated injury of 7.5 x 1.5 c.m horizontally placed of skin deep bilaterally over temporo parietal region.
5. A lacerated injury of 8.5 x 5 c.m of bone deep present over left occipital region extending to parieto occipital junction with evidence of linear fracture of occipital bone.
6. A lacerated injury of 1 x 1 c.m present over lateral 1/3 of left eye brow which is skin deep.
7. A contused abrasion 2 x 0.5 c.m present over left cheek.
8. A lacerated injury of 3 x 1.5 c.m present over palmar surface of root of right index finger extending to root of right thumb.
9. Contused swelling over dorsum right palm.

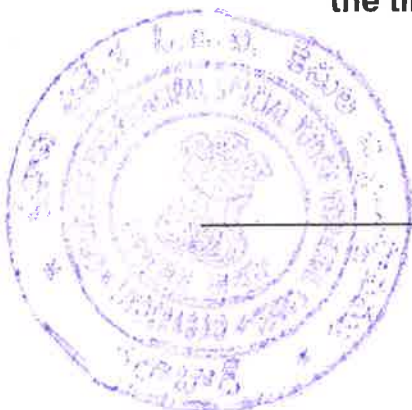
**VISIBLE DEEP INJURIES BEFORE POST-MORTEM EXAMINATION**





**16.119.** During Post-mortem in the internal examination, stomach was found empty and some internal organs were preserved for further examination at Regional Forensic Science Laboratory, Kurnool. As per Preliminary Report, the cause of death was opined as Haemorrhagic shock, injury to vital organ i.e. Brain. Thereafter, the Final opinion on Post-mortem Examination was received on 30.07.2019 in which the cause of death was shown as **“Haemorrhagic shock, injury to vital organ i.e. Brain. Further, the Time since death was concluded to have occurred about 8-12 hrs prior to Post-mortem”** (PM examination commenced at 12.35 PM). After Post-mortem examination, the dead body was handed over to Dr. Narreddy Suneetha Reddy (**daughter of the deceased**).

**16.120.** During investigation in order to ascertain the time of injuries inflicted on the body of Shri Y.S. Vivekananda Reddy, opinion was also sought from AIIMS, New Delhi. The board constituted consisting Dr. Abhilash S., Senior Medical Officer, Dr. Abhishek Yadav, Additional Professor and Dr. Kulbhushan Prasad, Additional Professor vide report dated 10.10.2022 opined that **“the Medical Board after perusal of documents, photos and videos unanimously concludes that the injuries observed in this case are fresh in duration and the time of infliction of the injuries is less than 12 hrs. which is corroborating with the time since death of post mortem examination.”**



**16.121.** During investigation, Department of Forensic Medicine, Government Medical College, Kadapa vide report dated 28.08.2021 regarding weapon of offence has opined as under: -

**(1) Whether the injuries marked at Sr. No. 1 to 9 in the post mortem report dt: 15.03.2019 are caused by sharp edged or blunt weapon?**

**Answer: -** Sharp Edged weapon.

**(2) Whether the injuries are caused by an axe?**

**Answer: -** Yes may be possible.

**(3) Whether the injuries mentioned in the PMR were Sufficient to cause death of the deceased?**

**Answer: -** YES

**(4) Whether death of Y.S. Vivekananda Reddy is homicidal in nature?**

**Answer: -** Nature of death can be determined by Investigating Officer. As per the pattern of the injuries recorded on the person of the deceased during the post mortem, it seems homicide.

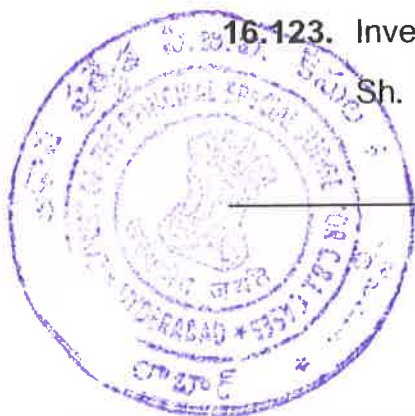


## OUTCOME ON NOTE WRITTEN BY DECEASED

16.122. On this aspect during investigation Shaik Dasthagiri (**A-4, turned approver**), had disclosed that all 04 accused assailants had tortured Shri Y. S. Vivekananda Reddy before murder and forced him to write a false note mentioning that his driver Prasad had beaten him badly and he should not be spared. The relevant extract of 306 Cr. PC statement of Shaik Dasthagiri on this aspect is reproduced in translated form:

*".....Then Yerra Gangi Reddy said that," make this fellow to (Abusive language) write one letter. Then myself and Sunil Yadav caught hold of the shirt of Vivekananda Reddy and dragged him near to the cupboards and made him to sit on his knees and asked to write one letter with his pen, but he refused to it. Then we four beat him up too much. Then Yerra Gangi Reddy said that, "hey fool (literal translation of the used abusive term is "son of the prostitute") if you write a letter then we will leave you and if you don't write then we will kill you (and leave). Later, Vivekananda Reddy agreed to write. Then Sunil Yadav made him write, ". Then Sunil Yadav made him to write, "I asked my driver to come to the duty (a bit) early, (because of it) so he tried to kill me. So (you) don't leave driver Prasad, don't leave driver Prasad," and wrote "yours Vivekananda Reddy". Then we threw the pen and the letter on his bed...."*

16.123. Investigation has revealed that M. V. Krishna Reddy informed Sh. N. Raj Shekhar Reddy at 06.15.32 AM (47 Sec.) and Sh. N.

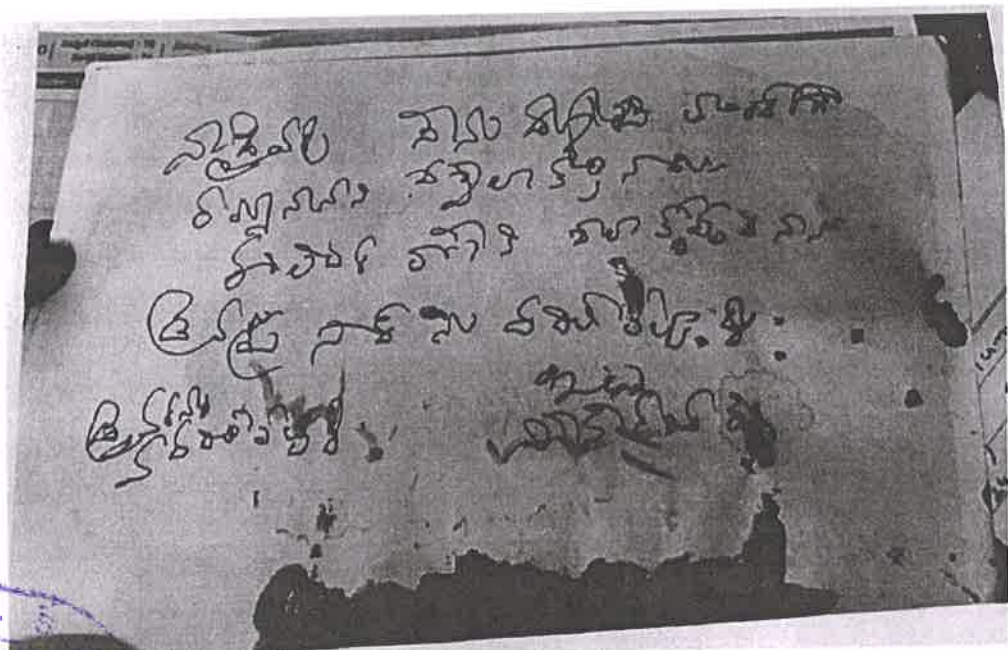


Siva Prakash Reddy at 06.18.26 AM (78 Sec.) regarding death of Shri Y. S. Vivekananda Reddy and being fallen in the bathroom in a pool of blood. Immediately after, M. V. Krishna Reddy and Y. Prakash noticed a blood-stained note in Telugu which was purportedly written by deceased in his own handwriting before his murder, which was lying on the floor of bedroom in between sofa and the bed. The translated contents of this note are as follows: -

*"My driver, I called him for duty early, so he beat me like death. I found it difficult to write this letter. Do not leave driver Prasad. Do not leave driver.*

*Yours*

*Vivekananda Reddy'*



PHOTOGRAPH OF THE PURPORTED DYING DECLARATION

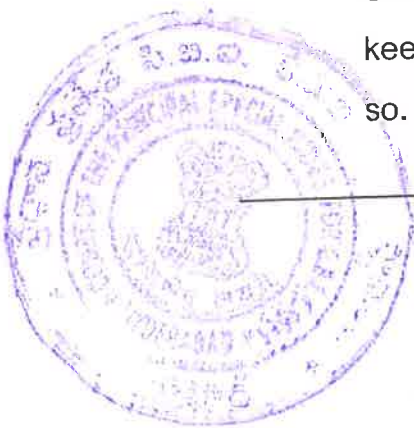




**16.124.** Investigation revealed that after going through the contents of the note Sh. M. V. Krishna Reddy again made a call to Sh. N. Raj Shekhar Reddy at 06:29:04 AM (347 Sec.), informing him that he had found one note mentioning the name of driver Prasad and he read out the contents of the note to Shri N. Raj Shekhar Reddy. On this, Sh. N. Raj Shekhar Reddy suspected that there was some foul play and it was not a case of natural death, therefore, in order to prevent mishandling of the note and to save driver Prasad from public outrage, he told Shri M. V. Krishna Reddy to keep the note in safe custody till the arrival of family members at Pulivendula. Moreover, Shri N. Raj Shekhar Reddy and his wife did not have any suspicion on Driver Prasad and considered him to be a loyal person.

**16.125.** Investigation revealed that in the meantime Shaikh Inayatullah reached at the house of Y. S. Vivekananda Reddy when Smt. K. Sasikala along with her 04 associates were already present outside the main door of the house. After reaching Shaikh Inayatullah took some photographs and sent to N. Raj Shekhar Reddy at 06:35:49 through WhatsApp. However, in these photographs the said note is not seen. Therefore, M. V. Krishna Reddy had removed the note before arrival of Shaikh Inayatullah.

**16.126.** Investigation revealed that after removing the said note from SoC, M.V. Krishna Reddy had given this note to Y. Prakash for keeping it in the dickey of his scooter, however he refused to do so. Then, M.V. Krishna Reddy asked him to give it to his wife



Smt. M. Sujatha for keeping it in safe custody. Thereafter, he wrapped the note in a piece of Newspaper and handed over the same to Smt. M. Sujatha w/o M.V. Krishna Reddy. After receiving the said note, Smt. M. Sujatha, on seeing the blood on the note got scared and called his son namely M. Rajesh Kumar Reddy. Further, on assurance of his husband, she kept the note at her home. Since, she had to proceed to Proddatur for some domestic work therefore she was not available at her house after 10:00 AM. Her husband, M.V. Krishna Reddy collected the note from home when she was not available. During handing over the said note to Smt. M. Sujatha by Y. Prakash, there has been some telephonic exchange amongst them which is reflected in the CDR of M.V. Krishna Reddy and Y. Prakash which shows that the said note was handed over to Smt. M. Sujatha at around 8:15 AM on 15.03.2019 as follows:

- 16.127.** Investigation revealed that Shri N. Raja Sekhar Reddy, on suspecting unnatural death of Shri Y. S. Vivekananda Reddy insisted M.V. Krishna Reddy to get registered a criminal case in the suspicious death of Shri Y.S. Vivekananda Reddy. To pursue the registration of case, he also spoke to Sh. J. Shankaraiah, CI through the phone of M. V. Krishna Reddy. Sh. J. Shankaraiah, CI has corroborated this fact.
- 16.128.** It is further revealed that after arrival of N. Raja Shekhar Reddy and Dr. Suneetha Reddy at Pulivendula, M.V. Krishna Reddy handed over the said note lifted from the Scene of Crime to Shri N. Raja Shekhar Reddy who after completion of Post-mortem Proceedings handed over the same to IO of the case in presence of Shri Rahul Dev Sharma, then SP Kadapa on a handing over memo.
- 16.129.** During investigation, local police considering the act of M.V. Krishna Reddy and Y. Prakash in removing the note from SoC to be criminal in nature, had arrested both these persons on 28.03.19. However, both were granted default bail on 27.06.19.
- 16.130.** During investigation the expert opinion furnished by CFSL, Hyderabad vide report dated 21.07.2020 has confirmed the handwriting of Shri Y.S. Vivekananda Reddy on the said note.
- 16.131.** During the course of investigation, the said note was subjected to Forensic Psychological Analysis. Vide report No. CFSL-2021/A-662/58 dated 10.01.2022, CFSL, New Delhi has



opined that the questioned handwriting was written under duress and extreme thought process.

**16.132.** Investigation revealed that the said note was lying on the floor of the bedroom whereas the dead body was found lying in the bathroom around 15-20 feet away. However, seeing the condition of dead body it can be understood that before death, deceased would not have been in a position to keep the letter at such a distance. The note itself contains blood stains in the lower edge which shows that while writing the said note the deceased had already sustained deep injury on his palm. Since the deceased was also in possession of mobile phone in working condition therefore making a distress call while being in injured condition, would have been easier for him than writing note, after arranging paper and pen. It shows that the assailants had forcibly made him to write the said note to mislead the case and to shield the actual accused persons.

**16.133.** During investigation though it has emerged that the said note has got contaminated being passing through several hands, however no malafide intention could be attributed behind removing the said note from the Scene of Crime and keeping it in safe custody as per instructions of N. Rajashekhar Reddy. The same was handed over to the local police on their arrival on the same day in the evening through a handing over Memo. Further, in order to find out some chance print on this note, Ninhydrin Test is under process after obtaining permission of this Hon'ble Court.





## MOBILE PHONE OF THE DECEASED

16.134. Investigation revealed that apart from the aforesaid note, M. V. Krishna Reddy had also removed mobile phone of Y.S. Vivekananda Reddy from the scene of crime on his own volition. As per statement of M. V. Krishna Reddy, he had noticed the phone while he saw a call coming from one Ravi Vempalli. The phone was on silent mode. As per Forensic extraction report obtained during investigation, in the call log, certain missed calls are existing including one in the name of '**Vmp Ravi**' (**+919440281211**) at 06:34:04(UTC+5:30) on 15-03-2019. However, it is revealed that before the call of Ravi Vempalli, another call originating from mobile phone No. +918008650069 on 15-03-2019 at 06:20:21(UTC+5:30) was rejected. Therefore, it indicates that M.V. Krishna Reddy had picked up the mobile phone at 6:20 AM and kept the phone with him. During investigation, chance print lifted from the mobile phone of deceased has been found matching with M. V. Krishna Reddy.

16.135. The absence of mobile phone at the SoC was noticed by Shri D. Nagaraja, SDPO Pulivendula, while he was preparing Observation cum seizure memo of the Scene of Crime. He observed that though deceased was using mobile phone however same was not available at the place of offence. Therefore, he enquired from M.V. Krishna Reddy about the mobile phone of deceased. On which, Shri M.V. Krishna Reddy stated that at his arrival, he noticed that mobile phone of Shri Y.S. Vivekananda Reddy was lying on the sofa of bedroom



therefore anticipating misuse of the phone, he took the phone and kept in his pocket. Thereafter, Shri M.V. Krishna Reddy directly handed over the mobile phone to Shri D. Nagaraja, SDPO, Pulivendula, Investigating Officer of the case on 15.03.2019 at 05:00 PM in the presence of witnesses. As per the statement of Shri M.V. Krishna Reddy the mobile phone of deceased was in his possession until the same was handed over to police.

- 16.136.** The said mobile phone was got forensically analyzed by local police during its investigation. On scrutiny of the data extraction report dated 23.05.2019, it is revealed that deceased had received a SMS 15-03-2019 01:31:06 (UTC+5:30) from mobile phone number +918309852627 saved in the name of **"Sambasiva Reddy"** in his contact list. Since, this message has been shown as "read" therefore it is indicated that by this time, the deceased would have been alive. The contents of this message were as such:

*"Eppudunna ni kuturu oka paapisti Munda, manasu& maanavatvam layni pasuvu. Oka aada puttuka putti,.inko ammaye ayena naa samsara jevitam naasanam chaysina raaxasi munda ni kuturu. Naa usuru tagili ni kuturi kuturu jevitam ni kuturi kannula mundaray sarva naasanam ayepotundi.ee ghoram chusina ni kuturu gundaylu baadukoni kumili kumili adustundi. Edi ni kannula mundaray jarugutundi bcoz edi kaliyugam. Edi jaragani roju Dayvudu laydu, Dayvuni Mahima laydu ani naynay oppukunta. Inka small pig,big pig la chaavulu anta bhayamkaramga untaaye antay....holy Sm kanniti usuru inta powerful ga untundaa ?ani nuvu talachukuntaav."*



The English translation of the message is as such:

*"Your daughter is an animal and who does not have humanity and heart. Though she born as a lady, she spoiled another lady marriage life. By having my suffering your daughter's life will also collapse in front of your eyes. By seeing all this your daughter will cry by beating her heart. This will happen in front of your eyes because this is Kaliyug. If it is not happened on that day, I will agree that there is no god and his grace. Then your deaths will be terrible like small Pig and Big Pig. You will feel the power of curse of holy woman."*

16.137. From the said mobile phone number +918309852627 (Sambasiva Reddy) several other deleted messages were also retrieved. Details of recovered deleted messages are as under:

**16.138.** The Forensic Extraction Report of the mobile phone, shows that the deceased had received last call from the said phone number +918309852627 (Sambasiva Reddy) at 16:32:51 (UTC+5:30) on 14-03-2019. Further there is a missed call from this phone number at 09:22:26 (UTC+5:30) on 15-03-2019.

**16.139.** Investigation revealed that the said messages were sent by Ms. Shaik Shameem, whose name deceased had saved in his mobile phone as '**Sambasiva Reddy**'. Ms. Shaik Shameem revealed that she is second wife of deceased Y.S. Vivekananda Reddy. They had entered in marriage during year 2010 and a son was born in the year 2015.

**16.140.** As regards sending of aforementioned messages to the deceased from 08.03.2019 to 15.03.2019 on his mobile phone, Ms. Shaik Shameem stated that she was annoyed with him and therefore she cursed the daughter of deceased and her two children, as at that time her (Ms. Shaikh Shameem) son was suffering from fever and she was in trouble. Further in the residential area, there was shortage of drinking water. Thus, she was furious with YS Vivekananda Reddy, as he was not taking care of his son. Therefore, she wrote nasty messages and sent to deceased. She further stated that whenever she (Ms. Shaik Shameem) used to refer N. Suneetha Reddy in her discussions



with YS Vivekananda Reddy, he used to respond, urgently. As regards problem of shortage of drinking water as narrated by Ms. Shaikh Shamim, her landlord namely Shri Chennuru Ravi Shankar has corroborated the same. Further, Shri Shaik Subahan, brother of Shaikh Shamim, who also lives with Shaik Shamim has stated that Y.S. Vivekananda Reddy and Ms. Shaikh Shamim had cordial relations except some annoyance on odd occasions as Y.S. Vivekananda Reddy was not properly giving time to Shaikh Shamim.

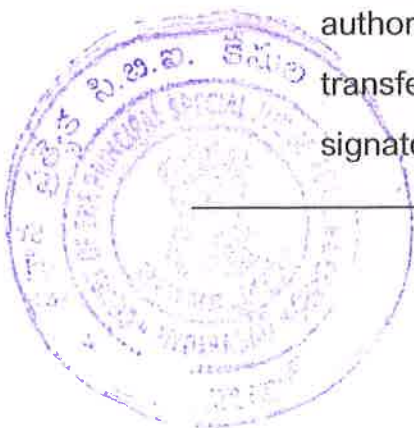
**16.141.** On the aspect of second marriage of Ms. Shaik Shameem, it is further revealed after her marriage with Shri Y.S. Vivekanand Reddy, the relatives of Y.S. Vivekananda Reddy, especially Shri N. Siva Prakash Reddy was not happy with Shri Y.S. Vivekananda Reddy and Ms. Shaikh Shameem. Further, N. Siva Prakash Reddy had objected their relationships several times. Though, daughter of deceased Smt. N. Suneetha Reddy was also not happy on account of the second marriage of her father, however she and her husband N. Raja Sekhar Reddy were fulfilling the financial needs of deceased as per his occasional requirements.

**16.142.** It is revealed that during marriage with Ms. Shaikh Shameem, Y.S. Vivekananda Reddy had given some money to her for purchasing jewellery and he got one extra floor constructed on her parental house at Balpanuru. Moreover, he also had given an Innova Car to her while she was pregnant and 8 cents of land in her father's name. In order to take care of his son, Y. S.



Vivekananda Reddy had also planned to buy a house near a school in Hyderabad for providing good education to the child besides making a fixed deposit and some agricultural property in the name of their son from the proceeds of Rs. 8 Crore, he was about to receive from a settlement of a property situated in Bangalore. Even on 14.03.2019 at about 3.15 p.m. during her conversations, Y. S. Vivekananda Reddy told her that he is waiting for the expected amount from Bangalore settlement. She also revealed that Y.S. Vivekananda Reddy was constantly being opposed by Y.S. Bhaskar Reddy (A-7) and his MP son Y.S. Avinash Reddy (A-8). There was fight within the family for political clout. Shri Y.S. Vivekananda Reddy was going through a financial crisis after he lost in MLC Election due to sabotage by Y.S. Avinash Reddy (A-8), Y.S. Bhaskar Reddy (A-7) and D. Siva Shankar Reddy (A-5).

- 16.143.** During investigation no evidence has emerged for attributing involvement on the part of relatives namely Smt. Y.S. Sowbhagyamma, Smt. Suneetha Reddy, Shri N. Raja Shekar Reddy, and Shri N. Siva Prakash Reddy in the conspiracy behind murder of Shri Y.S. Vivekananda Reddy in lieu of any dispute arising out of transfer of some property in the name of minor son born from the second wife Ms. Shaikh Shameem. Further, it is revealed that most of the properties were in the name of companies, wherein the deceased was a co-director / authorized signatory. Therefore, he was not in position to transfer property without the consent of other directors/ signatories who were also close family members.





## POST-CONDUCT OF THE ACCUSED PERSONS

- 16.144.** Investigation on the post-conduct of the accused persons revealed that D. Siva Shankar Reddy (**A-5**) had offered Rs. 10 Crores to one person namely Sh. K. Gangadhar Reddy (**a close associate of co-accused D. Siva Shankar Reddy (A-5)**) at the behest of Y. S. Avinash Reddy (**A-8**) and Y.S. Bhaskar Reddy (**A-7**) for taking the responsibility of murder of Sh. Y. S. Vivekananda Reddy as the accused assailants through whom the murder of Sh. Y.S. Vivekananda Reddy was got executed, were novice and D. Siva Shankar Reddy (**A-5**) had apprehension that they might reveal the truth before the Police about their role behind the murder and larger conspiracy. The said K. Gangadhar Reddy has died on 09.06.2022 in his house.
- 16.145.** During investigation on examination of data extracted from mobile phone of D. Siva Shankar Reddy (**A-5**) it is revealed that D. Siva Shankar Reddy (**A-5**) was keeping a close watch on activities of co-accused persons. During analysis of above mobile extraction, it is revealed that there are several video files of B. Ranganna, video files of CBI team at the house of deceased, video file of Shaik Dasthagiri (**A- 4 turned approver**) arriving at R & B Guest House at Pulivendula and other video files in parts containing interview of Sunil Yadav's family. Further, the carbon copy of arrest memo, personal search memo and remand report of accused Yadati Sunil Yadav (**A-2**) were also found in the mobile phone.



**16.146.** During investigation it was found that Y. S. Avinash Reddy (**A-8**), D. Siva Shankar Reddy (**A-5**), Y.S. Bhaskar Reddy (**A-7**) through their close associates were also attempting to influence the investigation, initially by destroying the evidence at the Scene of Crime, thereafter through registration of vague complaint at the Police Station. Moreover, when the case was registered by the local police, they have shared one message regarding posting of R. Vasudevan, Dy. SP (Investigating officer of the case). In the Mobile phone extraction of D. Siva Shankar Reddy (**A-5**) it is revealed that there are number of messages regarding transfer-postings of police officers with Y.S. Avinash Reddy (**A-8**), in which one of the messages is related to transfer of R Vasudevan, Dy SP. After formation of new Government in the State of Andhra Pradesh, the previous SIT was replaced with a new SIT and R. Vasudevan was made IO of the case vide order dated 13.06.2019 issued by the DGP, AP Office. In this regard, it is revealed that D Siva Shankar Reddy (**A-5**) had forwarded one message on 14.06.2019 to Y. S. Avinash Reddy (**A-8**) intimating him that R. Vasudevan transferred to Pulivendula as SDPO by the DGP office. On this message, Y. S. Avinash Reddy (**A-8**) replied that it may not be correct news as he had met DGP in the morning. Thereafter, investigation of the case was taken over by R. Vasudevan. Further, on the Orders of Hon'ble High Court when the case was transferred to CBI, said R. Vasudevan, made a request to D. Siva Shankar Reddy (**A-5**) for getting him transferred to Disha PS, Kadapa from Rayachoty Sub-Division of District Kadapa. This message was forwarded by D. Siva



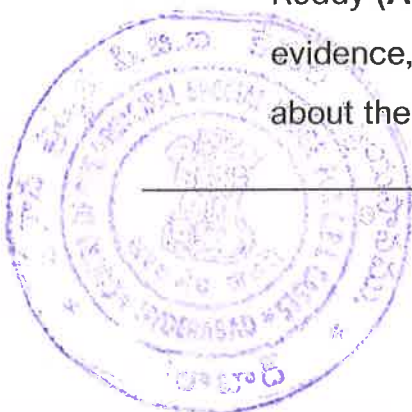
Shankar Reddy (A-5) to Y.S. Avinash Reddy (A-8). It shows that Sh. R. Vasudevan, previous IO of the case got compromised by these accused persons.

16.147. During investigation, it is revealed that when the case was transferred to CBI, as per statement of Shaikh Dasthagiri u/s 306 Cr. PC, he along with co-accused Sunil Yadav (A-2) and Gajjala Uma Shankar Reddy (A-3) had met with Y. S. Bhaskar Reddy (A-7) and D. Siva Shankar Reddy (A-5) at the Eswariah Garden and enquired saying that ***"what is our condition"? Case has been handed over to CBI?"***. They said that, ***"no problem we will take care of it." Please ask us, if you need some money then we will give you"***. On this aspect, it was found that Y. S. Bhaskar Reddy (A-7), Y.S. Avinash Reddy (A-8) and D. Siva Shankar Reddy (A-5) tried to influence Shaik Dasthagiri (A-4 – **turned approver**) through their close associate namely one Bharat Yadav and an advocate Obul Reddy who were following him to dissuade him to not to divulge any fact regarding the crime either before CBI or before the Ld. Court.

16.148. Investigation revealed that on 03.03.2021 when CBI called Shaik Dasthagiri (A-4 – **turned approver**) and others at Delhi by giving the notices. Prior to 10 days leaving for Delhi, D. Siva Shankar Reddy (A-5) called Shaik Dasthagiri (A-4 – **turned approver**) at the house of one Bayapu Reddy at Pulivendula and induced him to not to disclose their names before CBI and his life would be settled. Shri Bayapu Reddy has confirmed the visit of D. Siva Shankar Reddy (A-5) at his house in the morning

at around 06:30 am in the month of March-2021 and stated that they came to his house and had a discussion at the relevant period of time. It is further revealed that one Shri Bharat Yadav accompanied Shaik Dasthagiri (A-4) on his visit to Delhi as per the instructions of D Siva Shankar Reddy (A-5) to keep a watch on the facts being enquired by CBI.

**16.149.** Investigation as regards role of Gajjala Uday Kumar Reddy (A-6) revealed that he is a close associate of Y. S. Avinash Reddy (A-8), Y. S. Bhaskar Reddy (A-7) and D. Siva Sankar Reddy (A-5). He was found active in the intervening night of 14/15.03.2019 and had visited several times the house of Y. S. Avinash Reddy (A-8) / Y. S. Bhaskar Reddy (A-7) beside other relevant places. It is revealed that he was having the knowledge of death of YS Vivekananda Reddy early in the morning around 3:30-4:00 AM on 15.03.2019. He had prior knowledge of the conspiracy and in order to facilitate the coordinate amongst the co-accused persons he had taken leave for 15.03.2019, the leave application was submitted on 14.03.2019. He visited the house of Y. S. Avinash Reddy (A-8) / Y. S. Bhaskar Reddy (A-7) on 13.03.2019 and 14.03.2019 in the evening while Yadati Sunil Yadav (A-2) also visited the house of Y. S. Avinash Reddy (A-8) / Y. S. Bhaskar Reddy (A-7). Further, he had visited the house of Y. S. Avinash Reddy (A-8) / Y. S. Bhaskar Reddy (A-7) in the early morning of 15.03.2019 and accompanied Y. S. Avinash Reddy (A-8) and D. Siva Shankar Reddy (A-5) for destruction of evidence, which clearly establishes that he was fully aware about the murder of Y. S. Vivekananda Reddy and thereafter he





also accompanied with Y. S. Avinash Reddy (**A-8**) and others at the residence of Shri Y. S. Vivekananda Reddy. He was also involved in the destruction of evidence at the Scene of Crime as he called his father Gajjala Jai Prakash Reddy at 06:35 AM on 15.03.2019, soon after he arrived at the residence of Y. S. Vivekananda Reddy in conspiracy with other accused persons for applying cotton and bandages on the grievous injuries of the dead body of the deceased to conceal the same. Thus, he is liable for Criminal conspiracy for murder and destruction of evidence at the Scene of Crime.

**16.150.** Investigation has revealed that Y. S. Bhaskar Reddy (**A-7**) and Y. S. Avinash Reddy (**A-8**) were not having good terms with Shri Y. S. Vivekananda Reddy on account of political differences as well as family issues as discussed in the aforesaid paragraphs in details. It is revealed that Y. S. Bhaskar Reddy (**A-7**) and Y. S. Avinash Reddy (**A-8**) were behind the larger conspiracy of murder of YS Vivekananda Reddy as disclosed by Shaik Dasthagiri (**A-4, turned approver**) in his statement u/s 164 CrPC and 306 CrPC and other corroborative evidence. The payment of advanced money to the assailants was delivered through T. Gangi Reddy (**A-1**). The presence of Yadati Sunil Yadav (**A-2**) in the intervening night of 14-15.03.2019 particularly at 01:58:36 hrs on 15.03.2019, inside the house of Y.S. Bhaskar Reddy (**A-7**) / Y.S. Avinash Reddy (**A-8**). Further, in the intervening night of murder Y.S. Avinash Reddy (**A-8**) and T. Gangi Reddy (**A-1**) were active on their WhatsApp with certain similar timestamps. Moreover, Y. S. Avinash Reddy (**A-8**) was



also involved in floating the fake heart attack theory immediately after seeing the dead body in a pool of blood and he was remained present during the time of destruction of evidence at the place of occurrence, whereas Y. S. Bhaskar Reddy (A-7) had actively participated in the destruction of evidence at Scene of Crime by way of getting the injuries present on the dead body of deceased bandaged and also getting the blood present in the bed room and washroom cleaned. The cotton and bandages were got arranged in furtherance of the larger conspiracy, so that the grievous injuries of the dead body could be covered by applying cotton and bandages to make it like a heart attack and the visitors could not see the grievous injuries on the dead body. As per the statement of witnesses, who had visited the scene of crime in early hours, after seeing the grievous injuries on the dead body and presence of blood in the bedroom and bathroom, concluded it to be a case of murder. Whereas, the accused persons including YS Avinash Reddy (A-8) spread a fake story of heart attack to give it a color of natural death. Further, they also tried to hush up the registration of case through their conduit D. Siva Shankar Reddy (A-5). Their post conduct also establishes their role as they had contacted one K. Gangadhar Reddy through their conduit D. Siva Sankar Reddy (A-5) for taking the responsibility of the murder of Shri Y. S. Vivekananda Reddy as they had apprehension that since the assailants used by them in commission of murder of Shri Y.S. Vivekananda Reddy were novice in crime and they might reveal their identity. Further, during investigation, Y. S. Avinash Reddy (A-8) and D.

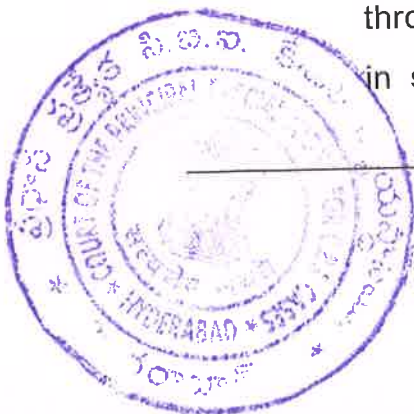
Siva Shankar Reddy (A-5) exchanged messages regarding posting of IO of the case. Thus, both these accused Y. S. Avinash Reddy (A-8) and Y.S. Bhaskar Reddy (A-7) had committed the offences of Criminal conspiracy for murder and destruction of evidence.

**16.151.** During investigation the role of M.V. Krishna Reddy has been found suspicious on the following aspects:

- A.** Apart from T. Gangi Reddy (A-1), he had also enquired about the plan of return of P. Rajashekhar, caretaker in evening of 14.03.2019.
- B.** M.V. Krishna Reddy had a long-time association with the deceased as Personal Assistant and had unhindered access inside the house of deceased, however in the morning of 15.03.2019 he sought permission from YS Sowbhagyamma to wake up the deceased.
- C.** He despite finding the side gate of the house opened, asked B. Ranganna (Watchman) to go and see YS Vivekananda Reddy inside the house, whereas B. Ranganna (Watchman) was not allowed to enter inside the house, generally. The mobile phone extraction of deceased reveals that M.V. Krishna Reddy has not made any phone call on the mobile phone of the deceased, before insisting B. Ranganna to go inside the house.



- D. He was fully aware about the death/ murder of YS Vivekananda Reddy after seeing the dead body and going through the contents of the note found at the scene of crime. However, he attempted to misguide Smt. K. Shashikala and persons accompanying her who visited the house deceased, by saying that Y. S. Vivekananda Reddy had gone to Tirupati and is not available.
- E. Despite being fully aware about the murder of YS Vivekananda Reddy, he immediately didn't inform the police, rather waited for the intervention of the family members to get a criminal case registered. Further, he didn't resist the destruction of scene of crime and remained silent.
- F. He had picked up the mobile phone of the deceased on his volition and handed over the same to police only after being enquired about the mobile phone of the deceased by Sh. D. Nagraja, SDPO.
- G. It is also revealed that when Y. S. Avinash Reddy (A-8) along with his associate reached and entered in the house of deceased at around 06:28-06:29 AM on 15.03.2019, simultaneously M.V. Krishna Reddy informed N. Raja Shekhar Reddy regarding the presence of note and its contents [06:29 AM - 347 Sec. call]. Further, on the instructions of N. Raja Shekhar Reddy, he sent this note through Y. Prakash to his wife Smt. M. Sujatha for keeping it in safe custody. It is very intriguing as by this time YS





Avinash Reddy (**A-8**) and persons accompanied with him had already reached at the house of deceased.

However, M V Krishna Reddy is not being recommended for prosecution due to insufficient evidence qua his participation in the conspiracy for murder as well as destruction of evidence.

**16.152.** Investigation as regards role of Y. Prakash revealed he was with M. V. Krishna Reddy, while discovering the dead body of Shri YS Vivekananda Reddy lying in a pool of blood. Further, he had helped M.V. Krishna Reddy in handing over of the note to the wife of M.V. Krishna Reddy. However, this act has not been found arising out of any malafide intention. Therefore, he is not being recommended for prosecution.

**16.153.** Investigation as regards role of Y. S. Manohar Reddy, it is revealed that Shaik Dasthagiri (**A-4, turned approver**) in his statement u/s 164 CrPC and 306 CrPC has also stated his name to be behind the larger conspiracy of murder, however sufficient prosecutable evidence regarding his role could not be collected. Though, during destruction of Scene of Crime, he was also present along with several other persons, however his substantive role in destruction could not be established. Therefore, he is not being recommended for prosecution.

**16.154.** The role of T. Gangi Reddy (**A-1**), Yadati Sunil Yadav (**A-2**), Gajjala Uma Shankar Reddy (**A-3**), Shaik Dasthagiri (**A-4 turned approver**) and D. Siva Shankar Reddy (**A-5**) have already been discussed in the Chargesheet dated 26.10.2021 u/s 173 (2) Cr.



PC and Supplementary Chargesheet dated 03.02.2022 u/s 173 (8) Cr.PC. Accordingly, they have already been prosecuted for their Acts.

**16.155.** In view of the facts and circumstances discussed above, prosecution of Gajjala Uday Kumar Reddy (**A-6**), YS Bhaskar Reddy (**A-7**) and YS Avinash Reddy (**A-8**) U/s 120-B r/w 302 & 201 IPC is recommended in continuation to the earlier charge sheets filed by CBI on 26.10.2021 and 03.02.2022 against the co-accused persons.

**16.156.** Investigation u/s 173(8) Cr. PC is still continued on following aspects and outcome thereof will be submitted before this Hon'ble Court:

**A.** In order to seek information regarding some suspected IMO users connected during the relevant period from the Wi-Fi router installed at the house of deceased in the intervening night of 14/15.03.2019, an MLAT (Mutual Legal Assistance Treaty) request has been sent to US Authorities on 20.06.2022 through Ministry of Home Affair, Government of India. Thereafter, on the request of US authorities, further clarifications have also been furnished on 29.08.2022, 04.11.2022 & 04.05.2023. However, the response of US authorities is awaited. Outcome of the same, if any will be submitted before this Hon'ble Court.



B. On an application filed by CBI for conducting Ninhydrin Test on the note written by deceased by CFSL New Delhi, this Hon'ble Court vide order dated 07.06.2023 has allowed the application of CBI. Necessary steps are being taken as per directions of this Hon'ble Court. Outcome thereof will be submitted before this Hon'ble Court on receipt of report from Experts.

C. During investigation certain mobile phones were seized and sent for forensic examination to CDAC, Trivandrum. Examination report of the same is still to be received. Same will be submitted before this Hon'ble Court.
